## 2025 ASSEMBLY JOINT RESOLUTION 29

April 23, 2025 - Introduced by Representatives MOSES, KITCHENS, ALLEN, TRANEL, WITTKE, PENTERMAN, GUNDRUM, O'CONNOR, ARMSTRONG, SPAUDE, DESMIDT, MIRESE, PETERSEN, SNODGRASS, DITTRICH, SHEEHAN, TITTL, KNODL, WICHGERS, PRADO, CALLAHAN, KREIBICH, SUBECK, SINICKI, MURPHY, BEHNKE, PALMERI, MELOTIK, CLANCY, MADISON, GOODWIN, ROE, JOHNSON, GOEBEN and KAUFERT, cosponsored by Senators FEYEN, CABRAL-GUEVARA, TOMCZYK, JACQUE, WALL, ROYS, RATCLIFF, HESSELBEIN, DRAKE, LARSON, NASS, DASSLER-ALFHEIM and SPREITZER. 1     **Relating to:** celebrating May 7, 2025, as Skilled Trades Day in Wisconsin.

2             Whereas, the construction industry is one of our nation's largest industries,  
3     and those in the skilled trades work in critical, rewarding, high-paying, high-  
4     demand jobs that cannot be outsourced overseas; and

5             Whereas, according to the Associated Builders and Contractors, more than  
6     one in four construction workers are over 55 years old, and the construction  
7     industry will need to attract an estimated half million additional workers on top of  
8     the normal pace of hiring in 2025; and

9             Whereas, Wisconsin's world-renowned registered apprentice program,  
10    established in 1912, is the oldest in the nation and allows anyone to participate in  
11    structured, on-the-job training with classroom instruction where they earn while  
12    they learn; and

13            Whereas, Youth Apprenticeship, which Wisconsin started in 1991 as a first

1 program of its kind in the nation, is a strong connector to registered apprenticeship  
2 programs; and

3 Whereas, the State of Wisconsin has invested significant tax dollars to  
4 encourage apprenticeship in the form of incentives and grants and passed reforms  
5 like allowing EdVest accounts to be used for apprenticeship costs, ratio reform, and  
6 allowing high school students to participate in registered adult apprenticeships;  
7 and

8 Whereas, those investments paid off when, last year, Wisconsin had an all-  
9 time record high number of apprentices in the history of the program, with over  
10 17,000 apprentices, many of which were in the construction trades, breaking the  
11 previous records set in 2022 and 2023; and

12 Whereas, last year, Wisconsin announced an all-time high of 9,932 youth  
13 apprentices enrolled during the 2023-24 school year, with a record 6,671 employers  
14 participating; and

15 Whereas, National Skilled Trades Day was created to help raise awareness of  
16 the important work of those men and women who build the places where we all live,  
17 work, play, worship, learn, and heal; now, therefore, be it

18 ***Resolved by the assembly, the senate concurring, That*** the Wisconsin  
19 State Legislature celebrates May 7, 2025, as Skilled Trades Day in Wisconsin.
