SUBJECT: Testimony for Senate Bill 505

Thank you Chairman Marklein and members of the Senate Committee on Agriculture, Revenue and Financial Institutions for holding a hearing and allowing me to testify in support of Senate Bill 505 (SB 505). This legislation is part of the package released from the Speaker's Task Force on Suicide Prevention.

Over the last year or so, I have been discussing with many of my constituents the concern of suicide among farmers. It has been a growing issue, and one that needs to be addressed. The price of milk has decreased over the years, which has caused many farmers to lose money and some have even gone bankrupt. This, along with other changes in farming over the years has caused an increase in suicide among farmers.

With these issues continuing to rise, as well as some challenges with cost for farmers to succeed, I have heard from many constituents that it is difficult for young people to want to enter into farming. Therefore, I was pleased to see legislation like this farmer tuition assistance bill come out of the Speaker's Task Force on Suicide Prevention. We have attached a substitute amendment on this legislation to make a minor change to make these farmer assistance scholarships.

SB 505 with the Senate Substitute Amendment allows the Technical College System Board to make grants to current or prospective farmers in the state to assist with farmer tuition. These farmer tuition assistance scholarships would be used for the purpose of paying no more than 50 percent of tuition costs for enrolling in courses on farm management or farm finance offered by technical colleges. A student may receive these grants that do not total more than \$1,000 per year for 3 years. I believe that these grants will create a support system to better assist young people to want to enter into farming, to understand farm management and farm finance, and hopefully keep the younger generations growing in Wisconsin's farming industry.

I want to thank the members of the Speaker's Task Force on Suicide Prevention for all of their work. Also, thank you for holding a hearing today. I ask for your support on SB 505 and I would be more than happy to answer any questions.

Having access to training like this can help farmers have a better understanding of farm practices as a whole. Not only is this education important, but students will create a support system of other farmers while taking these courses. This will continue to be a benefit to these farmers for years to come.

Thank you again for hearing Senate Bill 505, a bill that will help educate and prepare farmers to run a successful farm and allow them to be equipped to deal with all aspects of the farming business.
