Subject: Testimony in Support of Assembly Bill 661

Thank you Chairman Pronschinske and committee members for holding this hearing and allowing me to testify on Assembly Bill 661, relating to electronic issuance of dog training licenses.

Assembly Bill 661 will require the Department of Natural Resources (DNR) to offer dog licenses through the DNR's GoWild website. GoWild was created in 2016, by the DNR for outdoorsmen and women to easily obtain hunting and fishing licenses, register for safety courses and manage off-road vehicles licenses.

However, the Bird Dog Training license is not available in the electronic issuance system. The current paper system for dog training is no longer suitable during this technology dependent time. Outdoorsmen and women have shown that they like the convenience of going online to purchase their licenses. In 2020, the Go Wild system processed more than 1.8 million transactions online. This bill will require the DNR to include dog training licenses for purchase through the electronic system known as GoWild.

Thank you for your consideration on Assembly Bill 661.

Good morning! Thank you Chair Pronschinske and committee members for hearing four bills from the Sporting Freedom package to preserve and enhance Wisconsin's sporting heritage for hunters and sportsmen and sportswomen.

As a lifelong hunter, I am proud to be the lead author of two of the proposals on today's agenda. My bills simplify turkey hunting regulations and clear obstacles for dog trainers.

Turkey Hunting Simplification Bill (AB 671) – This bill would modify administrative rules relating to the hunting of wild turkeys to combine hunting zones and seasons to just two zones and two seasons (down from the complicated and restrictive six seasons that makes it difficult for many hunters to participate), and to modify youth hunting restrictions.

The spring turkey hunting season starts in mid-April, with the youth hunt on April 17th & 18th this year. On opening day of the regular season, April 21, 2021, there was a snow storm across portions of southern Wisconsin. The application for a turkey permit is due December 10 of the prior year. Unpredictable weather in April and May, can discourage youth hunters who have been looking forward to the hunt.

Dog Training Bill (AB 661) – This bill would require the DNR to make available on the Go Wild website dog training licenses. Currently, this license is not available there and that makes it harder for hunters to comply.

During the pandemic, many DNR Service Centers were closed, and counter service was restricted. This required hunters to mail a paper application for dog training licenses, allowing one to two weeks for processing. There is no justification for not making the application and permits available on the Go Wild system with all of the other hunting and fishing licenses.

Thank you again to the chairman and committee for holding this hearing. This package of legislation is about simplifying the DNR rules and regulations, so whether you're a seasoned hunter, angler or new to the sport, you can be sure that you purchased the right licenses, permits or tags to be part of the sporting culture in Wisconsin.

I am proud to be a part of this effort to protect and defend our sporting freedoms and heritage. I look forward to working with my colleagues to advance this legislation.

2021 Assembly Bill 661 Electronic Issuance of Dog Training Licenses December 15, 2021

Good morning Chair Pronschinske and members of the Committee. My name is Linda Olver, and I am the Bureau of Customer and Outreach Services Policy Advisor for the Wisconsin Department of Natural Resources. Thank you for the opportunity to testify, for informational purposes, on Assembly Bill 661 (AB 661), related to electronic issuance of dog training licenses.

The department issues relatively few dog training licenses compared to Ch. 29 hunting, trapping and fishing approvals. In response to the COVID-19 pandemic, the department consolidated the dog training license application process and required all dog training applications be mailed to the department's central office for processing. The following were issued in 2020 by central office Wildlife staff: 412 bird dog training licenses, 18 dog club licenses, and 2 hound dog licenses (432 total dog training licenses).

AB 661 does not include authority for license agents to collect an issuing fee for the sale of these dog training licenses. License agents would receive some compensation, as they would be authorized to collect the \$0.50 transaction fee authorized per s. 29.566(1m). However, license agent compensation would be significantly less than the compensation currently authorized by statute for the issuance of Ch. 29 approvals.

Special product fulfillment is required for two of the three dog training licenses (bird dog and dog club training) authorized in s. 169.20. State statute requires those training on captive pheasant, gray partridge, bobwhite quail, and other quail species of the subfamily *Odontophorinae* to use leg bands provided by the department, if the birds will be released and killed during the training activity. Bird dog and dog club license applicants may currently request leg bands at the time of application. Department staff mail the requested number of leg bands to approved dog training license applicants. Even with dog training licenses available for purchase in Go Wild, it is anticipated that department staff would continue to maintain an inventory of, and mail requested leg bands to, bird and dog club training license holders.

The authors may wish to consider adding a \$0.75 issuance fee for dog training licenses issued under s. 169.20 to allow license agents to earn a commission similar to what they are authorized to earn per 29.559(1)(a) for issuing Ch. 29 licenses.
