Testimony on Assembly Bill 238

Assembly Committee on Forestry, Parks and Outdoor Recreation

Good afternoon, and thank you Chairman Mursau and committee members for hearing Assembly Bill 238.

This bill simply shifts the responsibility of supplying communication equipment for off-road vehicle trails and routes from the Off-Road Vehicle Council to the DNR-Law Enforcement section of statutes. As a result, the DNR would have the ability to directly award grants to nonprofit or non-governmental organizations that meet the requirements for acquiring and maintaining communication equipment, technology, and software.

The Off-Road Vehicle Council is a body that offers guidance and suggestions to several Wisconsin governmental bodies, such as the DNR, the DOT, the governor, and the legislature. Its main focus is on matters concerning all-terrain vehicle trails and routes, including the activities performed by users of all-terrain and utility terrain vehicles. In addition, the council evaluates funding requests and provides recommendations to the DNR.

The Off-Road Vehicle Council has shown dedication to the maintenance and preservation of off-road trails and the promotion of safe and responsible off-road vehicle use. However, it is important to note that their expertise lies in these areas, and not in the appropriate allocation of funding for communications equipment and software. While this is understandable, it is crucial that the appropriation of these funds have the guidance and expertise to ensure that funding is allocated in a fair and effective manner.

The final step would be moving \$80,000 that is already allocated from the current local projects appropriation to the new appropriation pending JFC action.

Assembly Committee on Forestry, Parks and Outdoor Recreation Testimony on Assembly Bill 238

Good Afternoon!

Thank you Chairman Mursau and committee members for hearing Assembly Bill 238, relating to communications equipment for nonprofit organizations that promote the operation of ATVs and UTVs. Thank you Chairman Mursau, Rep. Bodden, Rep. Edming, and Rep. Green for co-sponsoring this legislation with Rep. Swearingen and me.

AB 238 removes communications equipment as an eligible local project under the direction of the Off-Road Vehicle Council. Instead, the bill creates a new appropriation under the DNR – Law Enforcement section of the statutes. This would allow the DNR to directly solicit and award grant money to nonprofit or non-governmental organizations that meet the qualifications for the purpose of acquiring and maintaining communications equipment and technology and software. The DNR is much more familiar with appropriate uses of this money than the Off-Road Vehicle Council.

The Off-Road Vehicle Council is made up of volunteer members who are knowledgeable and passionate about all-terrain vehicles (ATVs) and utility terrain vehicles (UTVs). The Council provides funding recommendations to the Department of Natural Resources (DNR) for various ATV and UTV projects. Funding can be awarded to a local unit of government or a nonprofit organization depending on its purpose. These projects are funded by user fees.

Projects eligible for funding include trail development, rehabilitation and maintenance, the production of maps, the placement of signs, and the purchase of communications equipment.

The members of the Off-Road Vehicle Council are very knowledgeable about ATV/UTV trails and maintenance. However, the members of the Council are not very familiar with appropriately awarding funding for communications equipment and software – nor are they supposed to be.

This bill does not appropriate any money. It is the intent of the authors to work with DNR to submit a request to the Joint Finance Committee (JFC) to transfer \$80,000 from the current local projects appropriation to the new appropriation for this purpose upon passage of the bill. The net impact of the proposal is \$0.

This proposal is supported by the Wisconsin ATV/UTV Association.

SB 239, the Senate companion to AB 238, passed the Senate Committee on Natural Resources and Energy 5-0 on May 11, 2023 and passed the State Senate 33-0 on June 7, 2023.

Thank you again to the committee for hearing AB 238, and your timely action on the bill.

2023 Assembly Bill 238

Software, Communications Equipment, and Maps for Nonprofit Organizations that Promote the Operations of All-Terrain and Utility Terrain Vehicles

September 19, 2023

Good morning, Chair Mursau, and members of the Committee. I am Lt. Jacob Holsclaw, and I serve as the Off-highway Vehicle Administrator for the Wisconsin Department of Natural Resources. With me today to help answer questions is Cathy Burrow, Manager of the Environmental and Natural Resources Grant Section within the Bureau of Community Financial Assistance. Thank you for the opportunity to testify, for informational purposes, on Assembly Bill 238, related to software, communications equipment, and maps for nonprofit organizations that promote the operations of all-terrain (ATV) and utility terrain vehicles (UTV).

Under current law, the department provides financial aid to nonprofit organizations to assist with ATV and UTV projects. These projects include trail maintenance, production of maps, placement of signs, and communications equipment through the statutory requirements of the safety enhancement program. Recommendations for the distribution of these funds are provided to the department by the Off-Road Vehicle Council. The Off-Road Vehicle Council is composed of dedicated volunteers who are very knowledgeable about trail infrastructure but generally do not work with communications equipment or software development.

This bill removes the production of digital information and acquisition of communication equipment from eligible projects normally covered under the guidance of the Off-Road Vehicle Council. This change in the administrative process would allow the Off-Road Vehicle Council to focus on trail development and maintenance while moving the administration of grants for the procurement of communication equipment to the department's Division of Public Safety and Resource Protection, specifically the Off-Highway Vehicle Program. The program currently administers funding to sheriff departments for recreational patrols to enhance public safety and is therefore familiar with administering these grants.

Under the current grant administration, every round of grant funding includes open competition by any applicant meeting the eligibility criteria. Over the past several years, the National Off Highway Vehicle Insurance and Services group has been awarded safety enhancement grant funding. This group is dedicated to off-highway vehicle recreation and has a large volunteer network of trail ambassadors. The trail ambassadors provide an increased presence on the trails, assist local law enforcement with safety patrols, and search and rescue missions. Efforts such as these may be greatly enhanced with up-to-date software and radio equipment. The department does not foresee a significant impact on workload or cost from the proposed change in grant administration.

Should this legislation not pass, communication equipment usage would continue to be funded through the current program. The Off-Road Vehicle Council has an established depreciation rate, as is their

practice for funding equipment. They would be able to fund radio grants based on the established rate and the per hour usage of the equipment. Outright purchases of radios would not be eligible.

This bill does not allocate funding to the appropriation created for the acquisition of software, communications equipment, and maps by ATV and UTV organizations. Without funding in this appropriation, the department would not be able to provide any grants for software or communications equipment.

To: Assembly Committee on Forestry, Parks and Outdoor Recreation

Re: AB238 & SB239

Our request is to change the administration and oversight of this part of the statute, from the Community of Financial Assistance to the Bureau of Public Safety & Resource Protection. This request was done in consultation and with support of both bureaus.

The Citizens Advisory Council (ORV Council) that advises the Community of Financial Assistance grants team, is well established and versed on topics that includes trail development, rehabilitation, maintenance type issues, as well as being knowledgeable about bridge repairs or replacement, culverts, signage and topics of that nature.

However, when dealing with issues and topics that relate to radio communication tools that are used in the field of our trail ambassador work, as well as other vital tools that include digital mapping services and other management tools needed to manage the extreme growth of this activity, it's not in this council's knowledge wheelhouse. We have experienced firsthand how unfamiliar and uncomfortable these requests have affected the ORV Council members.

We interact and work regularly with, also providing reports to the administrators and field team on the Bureau of Public Safety & Resource Protection, conducting and implementing the important work of the Safety Enhancement Program.

For this reason, and because their primary work also includes radio communications in their everyday workload, plus being familiar with various software programs that assist all parties to help responsibly manage this ever expanding outdoor recreation. This group is much more familiar and understanding with these categories of eligible projects and equipment, than the advisory council dealing with more familiar trail oriented projects.

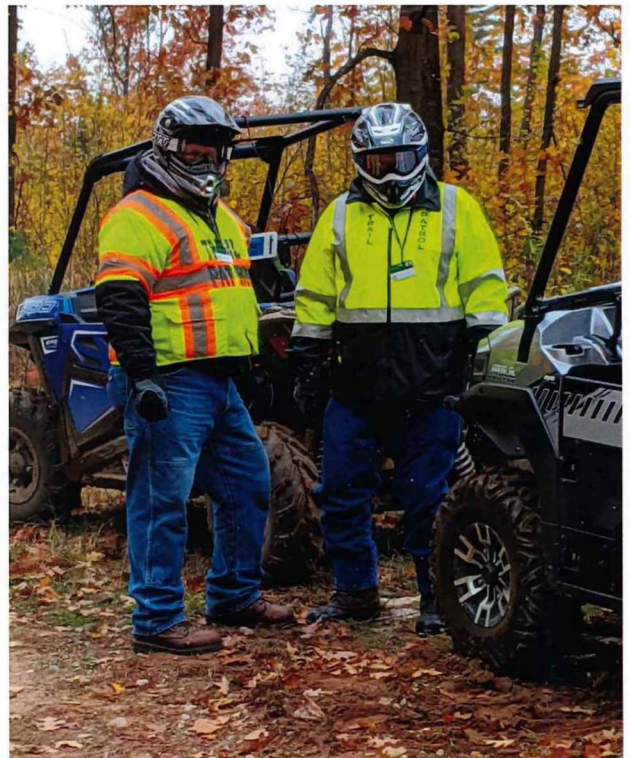

TRAIL PATROL OPERATIONS

The trail ambassadors are a visible presence on the trail systems. This presence sends a powerful message to all of the users, as well as the land managers and local citizens that are connected to the trail system.

The trail patrol focuses on the following items:

- Assistance to stranded or lost riders
- Law and ordinance compliance
- Safety concerns regarding trail & route conditions
- Trail sign issues
- Communications for patrols and emergency scenes
- A presence of volunteers that are dedicated to a positive image of their sport

Our trail ambassadors are trained to not only be a watchful eye for the items listed above, but to be an ambassador of the sport. We pride our trail patrol services on lending a helpful hand to anyone that needs assistance.

The volunteers from local clubs or regional volunteers are proven to be an asset to communities that are seeking to open new access routes or trails within their community. Having a dedicated group of volunteers that commit to patrolling the trails and routes offer an established form of responsibility to local land managers.

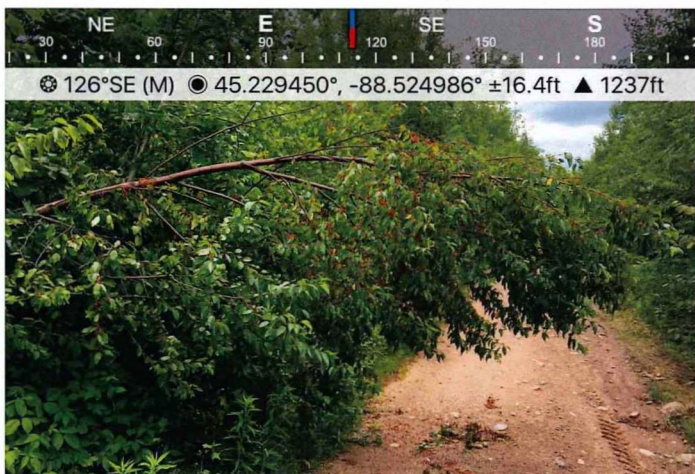
TRAIL & ROUTE CONDITIONS

A major opportunity for our trail ambassadors comes in the form of reporting trail & route conditions. Trail & route condition reports are designed to give the land managers, clubs or any entity that needs a report on the following conditions:

- Trail / route surface conditions
- Washout / erosion concerns
- Bridge issues
- Sign issues
- Gate issues
- GPS mapping services
- Invasive species information

During our trail & route condition report, trail ambassadors will examine all of the above conditions. A report will be generated and sent to the local club, land manager or requesting body (with permission from the appropriate land managers).

This information can be vital to any funding related activities. A trail report could be used prior to, or after a rehabilitation project has been completed. This will help ensure all the rehabilitation and maintenance efforts were successful.

WELCOME CENTER

A new feature being rolled out by the trail ambassador program is the welcome center. This service is designed to be setup alongside a highly traveled trail or route. The goal is to provide volunteer checks on equipment, safety gear & riding practices.

Some of the items on the check might include:

- For motorized sports, exhaust systems for sound and spark arrestors
- Registration compliance and general questions by riders
- Safety equipment requirements and safe riding practices
- General directions to service or points of interests

The trail checkpoint is a unique way to setup an area where users can approach the trail ambassadors to ensure they are properly covered. It's also a great way to promote the sport, trail ambassador program and the local club.

Trail checkpoints also serve as a great visual aid for local clubs to the local community. Having a visible area where the trail ambassadors are working and interacting with users of the trail system signify that these volunteers care for the riders and the trail system in that community.



TRAIL AMBASSADOR TRAINING & REPORTING



AMBASSADOR TRAINING

The foundation of the trail ambassador program is the training our volunteers receive. Training is conducted on a local, state and national scale, depending on the course. We offer both virtual and in-classroom platforms, as well as a hands on field day.

New trail ambassadors must attend a multi-hour training and orientation course. This course is conducted by regional and local coordinators, or completed online via virtual meeting or self-paced via our website. In this course, volunteers learn the basics of the program, how to communicate with coordinators, how to make contact with other trail users, how to make a positive impact in the community, how to deal with emergency situations and how to report back to the communication center. Students can obtain our trail ambassador text book in print or in digital format.



CONTINUING EDUCATION

To maintain your participation in the trail ambassador program, volunteers must attend ongoing training as updates dictate. Our training courses are offered from local, regional or national coordinators, or completed online via our virtual meetings or self-paced via our website. During our trainings, the volunteers will have a chance to learn new skills, improve existing skill-sets and learn to work together with other ambassadors.

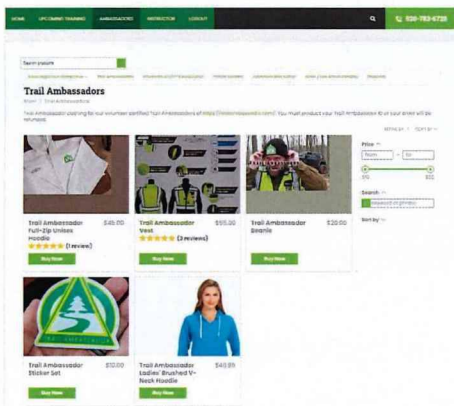
TOOLS FOR AMBASSADORS

The trail ambassador program offers a wide range of tools for our volunteers to be successful. These tools include a dedicated communications center, a private app for Android and Apple devices and a website where ambassadors can download resources and utilize our online education platform.

When our volunteers become certified trail ambassadors, they are asked to complete reports whenever they are out on patrol. These reports help validate their work while providing useful information that our communication center can pass along to our land managers or law enforcement. We offer multiple ways for our ambassadors to submit their paperwork.

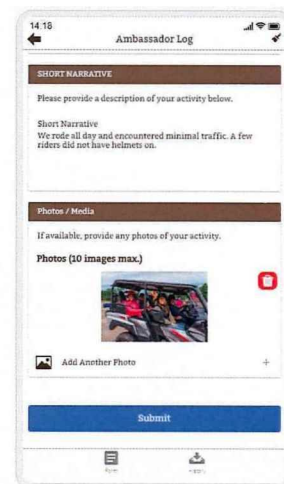
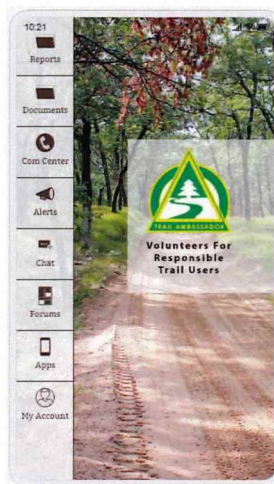
Trail ambassadors have access to our website tools, which include submitting trail reports and ordering trail ambassador clothing. They can also access our standard operating guidelines and other resources to support their operations.

We also have a private mobile app for Android and Apple devices. This app includes tools for submitting reports, referencing laws and sending



messages to the communications center. It's free to download and use, as long as you're an ambassador.

Finally, our communications center can submit paperwork on behalf of the ambassadors. If they are in the field or do not have access to a device connected to the web, the communications center can take their call or leave a voicemail to submit their information.



VOLUNTEER TODAY

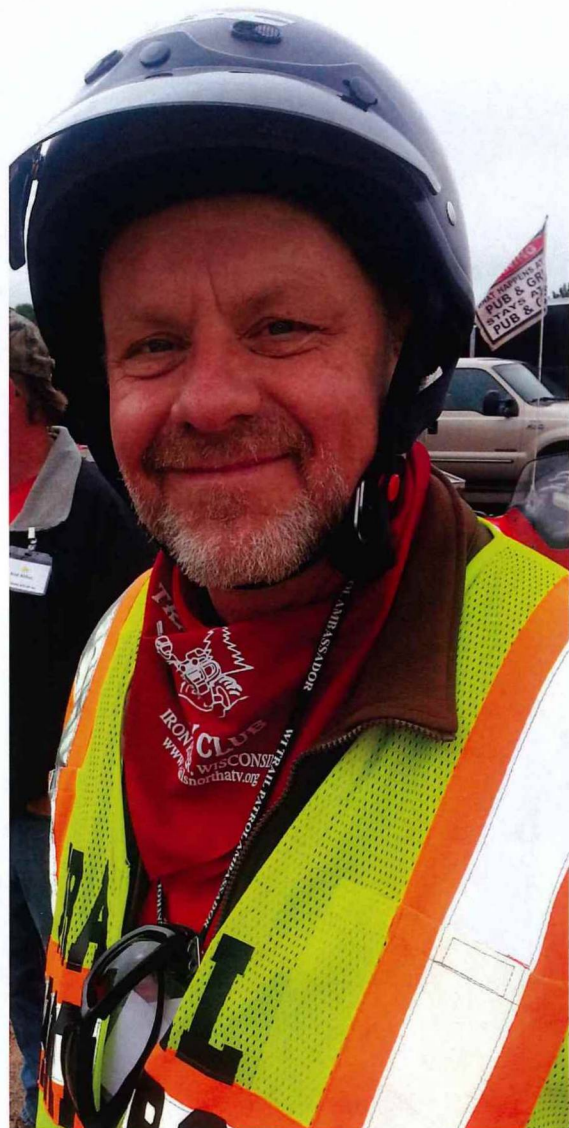
