Thank you Chairman Tomczyk and members of the Senate Committee on Transportation and Local Government for hearing testimony on SB 452.

On May 6th, 2023, Deputy Kaitie Leising of the St. Croix County Sheriff's Office was dispatched to a vehicle in the ditch of State Highway 128 near Glenwood City, WI. It was believed the driver of the vehicle was impaired. Eight minutes after Deputy Leising arrived and began to speak with the driver, he pulled a weapon and shot her. Deputy Leising returned fire after sustaining a gunshot wound and was rushed to a local hospital, where she was unfortunately pronounced deceased.

This bill will preserve the memory of Deputy Kaitie Leising by designating a portion of State Highway 128 in St. Croix County with her name. This portion of the highway includes the stretch of road where Deputy Leising's life was taken from her. As you will hear later, Kaitie was known for her confidence, loyalty, and love of others, especially her family.

While I was drafting the bill, I became aware that this portion of state highway had previously been designated as the 128<sup>th</sup> Infantry Memorial Highway, and signed into law by Governor Walker in 2013. However, I made efforts to discuss the situation with Wisconsin National Guard Adjutant General Paul Knapp. After some discussion, the Adjutant General stated would be honored to have the 128<sup>th</sup> add Kaitie's designation to the highway. The highway will officially have both designations after this bill is signed into law.

I appreciate Chairman Tomczyk and committee members for hearing our testimony today. I ask for your support for this bill, and would be happy to answer any questions you may have.

She was known for her confidence, quick wit, and infectious smile.

This bill designates a portion of State Highway 128 in St. Croix County as "Kaitie Leising Memorial Highway". This portion of the highway includes the stretch of road where Deputy Leising lost her life in the line of duty.

I am proud to sponsor this legislation to honor the life and service of Kaitie Leising. Thank you again for your time and support of Senate Bill 452.
