Re: Assembly Bill 168

Thank you, Chairman and Committee members, for hearing Assembly Bill 168---a bill designed to safeguard the Unemployment Insurance Trust Fund by protecting the integrity and security of the program to make sure only eligible individuals receive the full range of benefits.

This bill has several provisions to improve a system that was severely challenged during the pandemic.

An estimated 100 to 135 billion dollars of UI benefits nationally from the COVID-19 pandemic were lost during the greatest theft of tax dollars in us history.

Wisconsin itself had issues. In some cases, individuals who lost their jobs went months without receiving benefits while scammers took advantage of the program and fraudulently got benefits.

A 2020 audit also found only one half of one percent of the UI calls were answered in Wisconsin.

This bill will do the following:

**Identity proofing.** We are creating safeguards against fraud by improving ID checks for recipients, requiring the claimant to identify his or her identity prior to filing a claim and then use nationally recognized standards for verifying and authenticating who they are---similar to how we do it to access deferred comp, IRS tax returns, VA or social security benefits.

The next provision extends the statute of limitations from the current six years to eight years for prosecutors to pursue people who illegally obtained benefits under the 2020 CARES Act. It's worth noting that the state last year referred 48 people for felony prosecution---stealing more than \$2500 in UI benefits, and in 2023, there were 103 reported UI fraud cases in Wisconsin.

The third provision of the bill is aimed making a more concerted effort to prevent fraud on the front end rather than after it has happened. This aspect of the bill would require DWD to provide training materials for employers and claimants on the UI system. DWD would produce training videos on its website and also offer free quarterly live training seminars.

Fourth, the call center would adjust its hours if there were spikes in the volume of calls for UI claims in the wake of what happened during the pandemic when there were problems getting a live person on the phone.

Fifth, data base comparisons would codify weekly eligibility crosschecks of state and national data bases that track death records, employment records, prison records, and citizenship and immigration records for the sole purpose of detecting UI fraud and erroneous payments.

The last provision would be a reporting requirement to the executive and legislative branches of government, and to the UI Advisory Council if DWD suspended or curtailed methods used by the department to uncover fraud committed against the UI program.

Overall, these measures would improve the framework of the UI program and either codify or modernize procedures to make sure only those who actually qualify receive benefits.

Hello members of the committee, thank you for taking the time to hear testimony on AB 168.

In the weeks and months that followed the economic shut down in the Spring and Summer of 2020, many thousands of Wisconsinites were unexpectedly unemployed and forced to navigate our State's Unemployment Insurance system. Many of these people had never had to rely on government assistance before, yet were kept waiting for months on end to receive payments in order to stay afloat.

Making this process even more difficult, the State's UI program was completely unprepared for the mass influx of applications, cases, phone calls, and adjudications. People were forced to wait on hold for hours at a time to get through to someone who just to be put back on hold. Many people gave up attempting to get through and called their legislators asking for any assistance they could offer. My office worked with over 500 people who were navigating the UI system during that time.

AB 168 will build on previous efforts to bolster our UI system by extending call center hours during times of need. The bill stipulates that the call center must be open from 9am – 5pm when call volume has increased by 100% over the same week in the previous year and must be open with evening and weekend hours if there is a declared state of emergency or an increase of 300% compared to the same week in the previous year.

AB 168 will assist employers by requiring DWD to provide training materials on how to use the UI system, including videos on their website and free live training seminars on a quarterly basis.

Lastly the bill will protect taxpayers from bad actors who are looking to defraud the UI System by requiring applicants verify their identity prior to filling out their initial application and requiring DWD to compare state and national databases that track death, employment, citizenship, and prison records. This ensures the money meant to help those in their time of need gets into the right hands. This bill also ensures we continue to claw back any fraudulent payments received by extending the statute of limitations from 6 years to 8 years for a felony prosecution against an actor who committed fraud in



obtaining UI benefits or benefits under the federal Coronavirus Aid Relief, and Economic Security (CARES) Act of 2020.

AB 168 sets benchmarks for the agency to best handle unemployment applications in economic downturns while protecting the integrity of the program.

Good morning, Chair Melotik and members of the committee. Thank you for taking the time to hear my testimony on AB 168.

The Unemployment Insurance Fund (UI) is a critical piece of infrastructure the State administers for critical times of need. The availability, efficiency, and integrity of the system are paramount.

During the pandemic period, Wisconsin's UI system was challenged and found to be inadequate to meet the needs of those parties who were in need during that time. During the initial onset of the pandemic and the statewide business shutdown, DWD did not extend its call center hours, despite a nearly unprecedented surge in claims and UI problems.

I have heard countless stories from Fond du Lac and across Wisconsin from people saying that they could not get a hold of someone to get an answer to their UI claim.

From March 15, 2020, through June 30, 2020, 38.3 million of the 41.1 million total telephone calls (93.3 percent) to the call centers were blocked or received busy signals and, therefore, did not reach the call centers; individuals abandoned 6.2 percent of calls before speaking with the call centers; and 0.5 percent of calls were answered. This failure to provide support and constituent services for people in need is unacceptable.

Individuals who lost their jobs went months without receiving their benefits, while many ineligible individuals took advantage of the crisis and received benefits fraudulently. We need to ensure that DWD is using the most up-to-date fraud detection methods to protect innocent people from having claims opened up against them.

It is incumbent on the legislature to recognize the shortcomings of the current UI administrative design and take action to better equip the DWD to protect the integrity of our unemployment program for the maximum benefit of qualified participants, employers, and taxpayers.

AB 168 would enact a number of reforms to run the unemployment program more efficiently and ensure only eligible individuals receive their full range of benefits. These common-sense changes will help to safeguard all affected parties against a repeat of the unprecedented issues that surfaced during the pandemic. Changes would include:

- Extending Call Center hours during high times of need
- Giving the DOA flexibility in transferring employees to meet the increased workload
- Providing additional online resources to employers regarding the UI program as needed
- Building and requiring weekly eligibility crosschecks using various available databases
- Creating safeguards against fraud by improving identity checks for recipients as recommended by the U.S. Department of Labor.

AB 168 is a commonsense piece of legislation that will solve many of the problems plaguing Wisconsin's UI administrative system that DWD encountered during the pandemic. Through these reforms, Wisconsinites can feel assured that DWD will work in an effective and efficient manner, even when faced with a national emergency, in providing services and UI.

Thank you for your time and I hope you consider supporting Assembly Bill 168. I am happy to answer any questions you might have.

THANK YOU CHAIRMAN AND COMMITTEE MEMBERS FOR HEARING ASSEMBLY BILL 168---A BILL DESIGNED TO SAFEGUARD THE UNEMPLOYMENT INSURANCE TRUST FUND BY PROTECTING THE INTEGRITY AND SECURITY OF THE PROGRAM TO MAKE SURE ONLY ELIGIBLE INDIVIDUALS RECEIVE THE FULL RANGE OF BENEFITS.

THIS BILL HAS SEVERAL PROVISIONS TO IMPROVE A SYSTEM THAT WAS SEVERELY CHALLENGED DURING THE PANDEMIC.

AN ESTIMATED 100 TO 135 BILLION DOLLARS OF UI BENEFITS NATIONALLY FROM THE COVID 19 PANDEMIC WERE LOST DURING THE GREATEST THEFT OF TAXDOLLARS IN US HISTORY.

WISCONSIN ITSELF HAD ISSUES. IN SOME CASES, INDIVIDUALS WHO LOST THEIR JOBS WENT MONTHS WITHOUT RECEIVING BENEFITS WHILE SCAMMERS TOOK ADVANTAGE OF THE PROGRAM AND FRAUDULENTLY GOT BENEFITS.

A 2020 AUDIT ALSO FOUND ONLY ONE HALF OF ONE PERCENT OF THE UI CALLS WERE ANSWERED IN WISCONSIN.

THIS BILL WILL DO THE FOLLOWING:

IDENTITY PROOFING. WE ARE CREATING SAFEGUARDS AGAINST FRAUD BY IMPROVING ID CHECKS FOR RECIPIENTS. FIRST BY REQUIRING CLAIMANT TO IDENTIFY HIS OR HER IDENTITY PRIOR TO FILING A CLAIM AND SECONDLY BY USING NATIONALLY RECOGNIZED STANDARDS FOR VERIFYING AND THEN AUTHENTICATING WHO YOU ARE---SIMILAR TO HOW WE DO IT TO ACCESS DEFERRED COMP, IRS TAX RETURNS, VA OR SOCIAL SECURITY BENEFITS

THE NEXT PROVISION EXTENDS THE STATUTE OF LIMITATIONS FROM THE CURRENT SIX YEARS TO EIGHT YEARS FOR PROSECUTORS TO PURSUE PEOPLE WHO ILLEGALLY OBTAINED BENEFITS UNDER THE 2020 CARES ACT.

IT'S WORTH NOTING THAT THE STATE LAST YEAR REFERRED 48 PEOPLE FOR FELONY PROSECUTION---STEALING MORE THAN \$2500 IN UI BENEFITS. AND IN 2023 THERE WERE 103 REPORTED UI FRAUD CASES IN WISCONSIN.

THE THIRD PROVISION OF THE BILL IS AIMED MAKING A MORE CONCERTED EFFORT TO PREVENT FRAUD ON THE FRONT END RATHER THAN AFTER ITS

HAPPENED. THIS ASPECT OF THE BILL WOULD REQUIRE DWD TO PROVIDE TRAINING MATERIALS FOR EMPLOYERS AND CLAIMANTS ON THE UI SYSTEM. DWD WOULD PRODUCE TRAINING VIDEOS ON ITS WEBSITE AND ALSO OFFER FREE QUARTERLY LIVE TRAINING SEMINARS.

FOURTH, THE CALL CENTER WOULD ADJUST ITS HOURS IF THERE WERE SPIKES IN THE VOLUME OF CALLS FOR UI CLAIMS IN THE WAKE OF WHAT HAPPENED DURING THE PANDEMIC WHEN THERE WERE PROBLEMS GETTING A LIVE PERSON ON THE PHONE.

FIFTH, DATA BASE COMPARISONS WOULD CODIFY WEEKLY ELIGIBILITY CROSSCHECKS OF STATE AND NATIONAL DATA BASES THAT TRACK DEATH RECORDS, EMPLOYMENT RECORDS, PRISON RECORDS, AND CITIZENSHIP AND IMMIGRATION RECORDS FOR THE SOLE PURPOSE OF DETECTING UI FRAUD AND ERRONEOUS PAYMENTS.

THE LAST PROVISION WOULD BE A REPORTING REQUIREMENT TO THE EXECUTIVE AND LEGISLATIVE BRANCHES OF GOVT, AND TO THE UI ADVISORY COUNCIL IF DWD SUSPENDED OR CURTAILED METHODS USED BY THE DEPT TO UNCOVER FRAUD COMMITTED AGAINST THE UI PROGRAM.

OVERALL, THESE MEASURES WOULD IMPROVE THE FRAMEWORK OF THE UI PROGRAM AND EITHER CODIFY OR MODERNIZE PROCEDURES TO MAKE SURE ONLY THOSE WHO ACTUALLY QUALIFY RECEIVE BENEFITS.

**Written Testimony on AB 168**  
**Amy Pechacek, Secretary Department of Workforce Development**

Chair Michalski, Vice-Chair Snyder, Ranking Member Sinicki and Members of the Assembly Committee on Workforce Development, Labor, and Integrated Employment, thank you for the opportunity to provide written testimony for information only on AB 168. Thanks to Representative Kreibich and Senator Feyen for their interest in Unemployment Insurance (UI) Program Integrity.

AB 168 is either the Department of Workforce Development's (DWD) current practice or would not have the intended impact of bolstering Wisconsin's workforce, such as:

- **Education and Informational Materials:** UI already has external training and training videos available. There would be a cost involved with providing additional training requirements and complying with the proposed change, for which the bill does not allocate any funding.
- **Database Comparisons:** This is unnecessary given DWD's multifaceted, modernized approach to detecting and preventing fraud. Not only does the division cross match with death, employment, and other records, DWD is also a part of the National Association of State Workforce Agencies' Integrity Data Hub. The data hub provides access to cross-matching verification options, and nationwide databases, to name a few. DWD's Annual Fraud Report contains more detailed information about our detection tools.
- **Identity Proofing:** In the fall of 2024, DWD implemented a new identity verification service in partnership with US DOL, the United States Postal Service, and the General Services Administration. The National Identity Verification Process offers claimants the option to verify their identity in person at a participating Post Office or online through Login.gov. This process is federally funded for the first two years of use and DWD is exploring extended funding options available for the future. An initial estimate is that the proposed identity proofing standards would require a significant cost investment in annual vendor costs and technology development costs. Current UI processes already use targeted identification logic to verify the identity of every claimant, while also allowing for multiple methods for identity verification, utilizing existing federal services, and providing the program additional safeguards against fraud.
- The bill requires DWD to notify standing committees of the legislature, the Governor, and the Unemployment Insurance Council (UIAC) if DWD suspends or reduces any method used to detect fraud. Releasing this information to the public could actually increase the risk of fraudulent claims by allowing bad actors to take advantage of a change in use of a particular method used to detect fraud.

Regarding the changes outlined in AB 168 related to the UI call center, DWD notably upgraded the call center that has significantly improved accessibility and quality of customer service. The current contact center is enhanced with the following benefits:

- Modern web-based call delivery system that allows agents to work wherever they have an internet connection, providing greater flexibility for agents in taking and responding to calls;
- Scalability of solution in real time to address changing demands (both up and down);

- Ability to customize in-house call processing in real-time;
- Omnichannel approach that allows DWD to introduce other communication channels (e.g., chat, text messaging);
- Better ability to monitor interactions with customers; and
- Enhanced real-time reporting, including number of unique callers.

DWD already closely monitors call volume, patterns and wait times for the call center and adjusts hours accordingly to provide meaningful access while effectively managing resources. The monitoring mechanisms in place account for predictable increases due to seasonal and/or holiday trends versus unpredictable spikes. This proposed legislation does not account for these predictable trends; therefore, it would inefficiently assign staff.

This bill also does not factor in strides DWD has made in terms of modernization and ease of access to the unemployment insurance administration process, such as online filing process, secure online messaging with adjudicators, and translation of the UI application into plain language, which has significantly eased the claimant's experience. The Department is better equipped to manage a sudden influx in UI claims and calls due to modernization efforts.

Wisconsin Manufacturers & Commerce (WMC) appreciates the opportunity to testify in support of Assembly Bills 162, 167, 168 and 169. Thank you, Chairman Melotik, for holding this hearing and highlighting a key concern of employers throughout Wisconsin.

WMC is the largest general business association in Wisconsin, representing approximately 3,800 member companies of all sizes, and from every sector of the economy. Since 1911, our mission has been to make Wisconsin the most competitive state in the nation to do business. That mission includes making sure Wisconsin's employers have a capable and willing workforce.

While the worker shortage has improved for Wisconsin employers recently, too many are still unable to fill key positions. According to WMC's most recent *Wisconsin Employer Survey* released in January 2025, 63% of employers indicate that they are struggling to hire workers. Employers tell us that it is particularly difficult to find workers with the right skills and training.

Employers are also concerned that many people have simply dropped out of the workforce and are no longer looking for work. Wisconsin's labor force participation rate is currently 65.8%, which is better than the national average. However, it is significantly lower than our state's peak of 74.5% in 1997. Further, it is concerning that our current level is the same as the labor participation rate at the height of the pandemic in April 2020.

This labor participation rate is unsustainable for employers in Wisconsin, especially when coupled with low birth rates. If we want to continue to be a leader in manufacturing, agriculture and other industries, we must have a strong workforce. That is why it is important that government policies do not keep or place individuals on the sidelines.

**Assembly Bill 162:**

It is important to have a standard set of metrics for all of Wisconsin's workforce development programs. With multiple agencies overseeing a multitude of programs, it is important that the legislature, business community and public can evaluate the effectiveness of each program. This legislation's commonsense requirement to report this data in the same format utilizing the primary

indicators of performance under the Workforce Innovation and Opportunity Act (WIOA) will allow equal evaluation of the quality of each program and will tell us which programs are the best to utilize in the future.

**Assembly Bill 167:**

WMC members are very supportive of work search audits and additional oversight for enhanced federal benefits. The pandemic supplemental unemployment benefits provided a financial incentive for workers to remain on the sidelines, instead of filling desperately needed jobs. Employers were extremely disappointed that Governor Evers vetoed legislation to end the \$300 per week extra unemployment benefit. That would have provided meaningful relief to our economy. In August of 2021, we had an unemployment rate of 3.9%. When the \$300 per week benefit finally phased out in September, 36,435 fewer people collected unemployment benefits by December – a 30% drop in just four months. Those people didn't stay home once the extra benefits ended, they went back to work: Wisconsin added 34,854 workers during the same timeframe. Imagine how much more productive our economy could have been if we had stopped paying people not to work sooner.

**Assembly Bill 168:**

The pandemic showed that flexibility in staffing at the Department of Development (DWD) is vitally important. WMC believes that this bill makes sensible changes to allow employees from other agencies to help alleviate unemployment insurance backlogs at DWD. WMC is also supportive of the requirement to double check a claimant's identity, including weekly crosschecks with prison, employment, immigration and death databases.

**Assembly Bill 169:**

WMC members continually have individuals miss interviews or fail to respond to interview requests. It is common for employers to have half or even less of their scheduled interviews actually show up. Unemployment insurance claimants are saying they are fulfilling their work search requirements in order to keep benefits, but they are not actually looking for a job. This legislation creates a needed curb on this practice by saying if the claimant does this, they are not considered to have conducted a reasonable search for work in a week and therefore they lose their weekly benefit for that week.

WMC urges members of the Assembly Committee on Workforce Development, Labor and Integrated Employment to vote in support of Assembly Bills 162, 167, 168 and 169. The reforms in these four bills are important for the health of Wisconsin's workforce and will allow employers to stay and expand in Wisconsin. These reforms will encourage people into the workforce and allow them to experience the dignity of work.

Chair Melotik, members of the Committee, my name is Bill G. Smith, State Director for the National Federation of Independent Business (NFIB), and I appear today on behalf of over 10,000 Wisconsin member firms located throughout Wisconsin, and I report to you today that many of these firms are struggling with a full menu of economic challenges:

- Inflation
- Supply issues
- Economic Uncertainty
- Labor issues

Since 1974, NFIB's Research Foundation has collected Small Business Economic Trends data with a quarterly survey of our members, and since 1986, these quarterly snapshots of the small business economy that have been done on a monthly basis emphasizes the small employer labor market.

The bills before the committee today for your consideration would help provide unemployed individuals with incentives and encouragement to join or return to the workforce, while also responding to the worker shortage currently challenging our small business employers.

Assembly Bill 167 would provide important updates to the misconduct statute, creates legislative oversight of enhanced federal benefits and improves the monitoring of the requirements for work search.

Assembly Bill 169 would respond to a common concern from small business employers that too often applicants for jobs fail to show for interviews or report for work when hired.

Assembly Bill 168 would make several administrative changes including new procedures to detect fraud, creation of a call center to assist claimants and employers, and a requirement that DWD create an education and training program for employers, employees and claimants.

Assembly Bill 162, the workforce metrics proposal, would provide valuable data and performance related oversight of the workforce under the federal Workforce Innovation and Opportunity Act.

The unemployment insurance program is not a welfare program. It is a program designed with the intent to provide temporary financial assistance to those individuals who lose their job through no fault of their own.

Unemployment insurance is an important program, funded by employers, that helps protect communities and small businesses from hardship generated by economic downturns. It provides timely financial assistance to unemployed workers, but it was not intended nor should it provide a disincentive for individuals from seeking and obtaining employment.

According to the March Jobs Report by NFIB's Research Center, 40 percent of small business owners reported job openings they could not fill, up two points from February. Among the 53 percent of owners hiring or trying to hire, 87 percent said they had few or no qualified applicants for the positions they were trying to fill.

Importantly, a net 38 percent reported raising compensation, up 5 points from February. Clearly small business employers are feeling pressured to retain and attract employees.

Clearly, the labor market continues to be a big challenge for small business employers. NFIB supports passage of these bills because they will help put jobs back on Main Street by providing assistance to UI claimants, creating incentives for individuals to join or return to the workforce, and improve the labor participation rate of the state's workforce.

No one has a greater responsibility or ability to lead the economy of our state than our small business owners.

The Legislature has a special obligation, we believe, to ensure that public policies help promote and encourage the creation and growth of small business, and also to sustain the small business community throughout our state.

I hope you found the economic data – specific to small business – that I shared with you to be helpful as you consider public policies that impact our state's vital small business community, and I respectfully urge your support for passage of these important bills relating to unemployment insurance reform.

Chair Melotik and committee members, my name is Brian Dake, President of Wisconsin Independent Businesses. Thank you for the opportunity to testify in support of the Assembly Bill (AB) 167, Assembly Bill (AB) 168, and Assembly Bill (AB) 169.

By way of background, Wisconsin Independent Businesses (WIB) was formed in 1977 to provide small, independent business owners with an effective voice in the legislative and regulatory activities of state government.

We proudly represent nearly 2,000 small, independent business owners throughout Wisconsin. Most of our members, approximately 85%, own and operate businesses that have fewer than 25 employees and annual gross revenues of less than \$5 million. Our membership reflects the range of small businesses that exist in communities throughout Wisconsin.

In 2011, we surveyed our members about Wisconsin’s Unemployment Insurance (UI) law. From their responses, we developed the following set of objectives to guide our advocacy efforts:

- reduce the state UI tax burden on small businesses;
- increase UI claimant accountability;
- reduce the incidence of UI fraud;
- bring clarity to the enforcement of UI laws and regulations; and
- transition UI claimants back to work quickly.

If enacted into law, these three bills would fulfill these important objectives.

### **2025 Assembly Bill (AB) 167**

To remain eligible for state UI benefits, claimants must conduct at least four weekly work search actions and report them to the Wisconsin Department of Workforce Development (DWD) when filing their weekly UI claim.

State law also requires the DWD to conduct random work search audits and report annually to the Unemployment Insurance Advisory Council on the number and the results of work search audits conducted in the previous year. An analysis of this data for an eight-year period beginning in 2017 is very revealing.

Over this eight-year period, 28% of all DWD work search audits conducted found that claimants failed to fulfill their weekly work search requirements. Over the three-year period beginning in 2022, 41% of all DWD work search audits conducted found that claimants failed to fulfill their weekly work search requirements.

AB 167 would require the DWD to conduct random audits for at least 50% of all work search actions reported to have been performed by claimants. The DWD work search audit data justifies the need for enhanced work search authentication to ensure UI claimants fulfill their weekly work search requirements.

A guiding principle of the UI program is that benefits are only paid to eligible workers who are unemployed through no fault of their own. Consistent with this principle, employees terminated due to workplace misconduct are ineligible for UI benefits.

With the support of WIB, Wisconsin lawmakers modernized the state's Employee Misconduct law more than a decade ago. 2013 Wisconsin Act 20 defined misconduct and enumerated that misconduct includes seven general actions by an employee for which the terminated employee would be ineligible for UI benefits for a specified period. They are:

- violation of an employer's drug and alcohol policy;
- theft of an employer's property or services;
- conviction of a crime, if the conviction makes it impossible for the employee to perform employment-related duties;
- acts of workplace harassment, assault, or physical violence;
- chronic absenteeism or excessive tardiness;
- falsifying the employer's business records, and;
- willful and deliberate violation of a written and uniformly applied standard for an employer that is licensed or certified by a governmental agency.

Over the last decade, various provisions of this law have been subject to legal challenge, business practices and operations have changed, and unforeseen instances of employee misconduct have arisen. For these reasons, we are pleased that AB 167 would update the Employee Misconduct statute. Of note, this legislation would:

- replace the existing misconduct standard for chronic absenteeism or excessive tardiness with a new standard that is consistent with the unanimous ruling by the Wisconsin Supreme Court in *Wisconsin Department of Workforce Development v. Wisconsin Labor and Industry Review Commission (2018)*;

- enumerate unauthorized distribution of an employer's confidential or proprietary information, and use of an employer's credit card for an unauthorized or a nonbusiness purpose without prior approval from the employer as employee misconduct; and
- enumerate a violation of an employer's reasonable employment policy that covers the use of social media as employee misconduct.

## **2025 Assembly Bill (AB) 168**

Two recent reports from the United States Government Accountability Office (GAO) validate our advocacy efforts focused on reducing UI fraud.

In June 2022, the GAO issued a report to Congress entitled “Unemployment Insurance Transformation Needed to Address Program Design, Infrastructure, and Integrity Risks” in which it advised federal lawmakers that the UI program has been added to its “High Risk” designation list. This extraordinary designation is conferred upon federal programs in need of transformation and/or vulnerable to waste, fraud, abuse, and mismanagement.

In December 2022, the GAO issued a report to Congress entitled “Unemployment Insurance Data Indicate Substantial Level of Fraud during the Pandemic; DOL Should Implement an Antifraud Strategy.” While the GAO chastised the DOL for not implementing an overall UI antifraud strategy, their report provided federal lawmakers with a list of actions taken by the DOL to assist states combat UI fraud. The report noted:

- The DOL provided funding to procure and implement an identity verification solution, which became available to states in July 2020. This service provides new datasets to conduct enhanced UI claimant identity verification by states to prevent fraudulent claims from being paid based on false identities. It also contains a cross match with the Social Security Administration (SSA) Death Master File to identify the use of a deceased person’s Social Security number being used to file for benefits.
- The DOL provided funding to procure and implement a bank account verification service, which became available to states in February 2022. This service aids states in proactively identifying and authenticating bank account information provided by a UI claimant by validating the account status and ensuring the claimant is the owner or authorized user prior to initiating the UI benefit payment.
- The DOL is working with the SSA to establish a secure data exchange that allows states to cross match UI claims data with incarceration records. While some states have access to various local, state, or federal incarceration cross matches, the DOL encouraged all states to regularly cross match UI claims against prisoner records to ensure UI benefits are only paid to eligible individuals.

This GAO report also footnoted an August 11, 2021, Unemployment Insurance Program Letter (UIPL) from the DOL in which the agency “strongly encouraged all states to implement NIST-compliant identity proofing, specifically IAL 2 and AAL 2, before claimants start filling out the UI claims application and for re-accessing their account.”

The DWD is currently in the process of modernizing its UI information system. With funding and resources available from the DOL, the time is now for the State of Wisconsin to adopt the UI fraud prevention recommendations from the GAO and the DOL.

Passage of AB 168 would ensure that happens.

### **2025 Assembly Bill (AB) 169**

“Ghosting” is a dubious practice in which a prospective employee does not show up for a scheduled job interview or respond to an offer of employment from an employer. While employers cannot legally compel a prospective employee to sit for a job interview or respond to a job offer, “ghosting” by a UI claimant could be a fraudulent act.

AB 169 sets forth a process whereby a Wisconsin employer may voluntarily report a potential instance of “ghosting” to the Wisconsin Department of Workforce Development (DWD) for further investigation. If the Department determines a UI claimant was engaged in “ghosting,” he/she would be ineligible for UI benefits for the week in which the “ghosting” occurred.

### **Conclusion**

We respectfully ask for your support of AB 167, AB 168, and AB 169.

RE: Opposition to unemployment bills AB169, AB167, AB168, and AB164

Modest support for unemployment bill AB146

Dear Committee staff, representatives, and senators:

I am opposed to AB169, AB167, AB168, and AB164 as needless, legally problematic, and likely to create more harm than accomplishing any actual change. While I cannot testify at the public hearings scheduled for these bills given the sudden and rushed action being taken, I hope you will consider the information I am providing here.

First, some context is important. For 2025, initial claims for unemployment insurance are on a path to set a new record low (previously set in 2023). Data from DWD (<https://dwd.wisconsin.gov/uistats/>) shows claim-filing for the last several years (as current data for 2025 is only available through week 13, weekly data is only pictured for those weeks even though yearly data is available for previous years):

As evident here, 2023 (and 2024) surpassed the previous record low year for initial claims in Wisconsin, 2019, to set a new record low for initial claims in a year. So far, 2025 is on pace to have even fewer initial claims than 2023, as initial claims are running 94.55% of the pace set in 2024 and 94.17% of the pace set in 2023. This record low number of initial claims is occurring despite the spikes in initial claims for weeks 8 and 9 when mass layoffs of probationary employees in the federal sector took place (from this data, it appears that **over 2,000 additional, new initial claims** were filed in these two weeks).

To put these numbers in perspective: in 2007 (before the Great Recession struck Wisconsin in 2008) there were 638,548 initial claims, and 332,982 claimants were actually paid unemployment benefits that year. The current, incredibly low number of initial claims being filed in Wisconsin indicates that unemployment claims are becoming little more than an after-thought to most Wisconsin workers. As I have written previously:

So, unemployment has become less and less an issue for Wisconsin workers. The data right now indicates that the vast majority of claims are filed in the winter months, when scores of businesses like landscaping, road building, some construction, and others cannot operate because of winter conditions.

The current proposals in AB162, AB169, AB167, AB168, and AB164 will do nothing to make unemployment more useful and efficient for Wisconsin workers and employers.

- AB169: This bill recirculates the 2023 AB149 bill. The Department, however, already encourages employers to report this work search information. See, e.g., Refused Work (<https://www.dwd.wisconsin.gov/ui201/b7201.htm#refused-work>), Work Available with Current Employer (<https://www.dwd.wisconsin.gov/ui201/b7201.htm#work-available>), and Report Unemployment Fraud (<https://www.dwd.wisconsin.gov/ui/fraud/report.htm>). All of these employee actions would also lead to a loss of benefits, IF the person was claiming benefits at the time. In short, this proposal pretends that the labor supply is growing and that there are numerous unemployed people looking for jobs while claiming unemployment benefits, when the claim-filing data indicates the exact opposite. There is in reality a shortage of workers and employers are competing among themselves to hire workers from each other.
- AB167: This bill recirculates the 2023 AB147 bill. This expansion of Beres and accidental damage raises a serious risk of Wisconsin employers losing their FUTA tax exemption, because the misconduct penalty of lost wages in a benefit year can only be applied to intentional employee conduct.<sup>1</sup> The proposed changes regarding social media,

job registration in other states for those with combined wage claims (regardless of whether job registration is even available in other states), work search auditing for claims in which no benefits are paid (at present, the Department only audits claims in which benefits are paid, and audits nearly all employees who receive unemployment benefits), and Joint Finance Committee approval for emergency federally-funded benefits demonstrate a basic lack of understanding of how unemployment claim-filing is actually being administered.

- AB168: This bill recirculates the 2023 AB152 bill, with some modifications. In general, the bill does nothing but put into statute current Department practices and resources for administering unemployment claim-filing. While I certainly can find things with which to criticize the Department, putting current practices into statute accomplishes nothing but hamstringing the Department when new practices and resources emerge. There simply is no sound reason to limit administrative discretion without any recognition that times and issues will change.
- AB164: This bill features a more limited embrace of the transformation of unemployment into reemployment assistance of 2023 AB150 bill. As currently framed, this bill is little more than busy work regarding name changes and accomplishes almost nothing of substance.

Unfortunately, the one bill that is addressing a sorely needed problem, **AB146**, and the short timelines small employers have to respond to Department inquiries is getting no hearing and apparently no legislative support. In this proposal, the legislature wants to extend the time for employers to respond to Department inquiries for employee separations to twelve days. While this proposal is problematic, there are several reasons for why it is raising an important issue for many small employers.

Enclosed is a listing of the 658 unemployment warrants issued by the Department in March of 2025. I will bet anyone a good Wisconsin beer that close to 500 of these warrants are against employers. Because the unemployment portal is so difficult to manage, small employers are having a nearly impossible time paying their unemployment taxes properly. For example:

- 2025UC000603 / Dartmouth College in New Hampshire owes \$854.00 in taxes, \$171.92 in fees, and \$10.00 in fees
- 2025UC000300 / Funimation Productions LLC in Texas owes \$116.00 in taxes, \$1.94 in interest, \$100.00 in penalties (\$50 per missed quarter), and \$20.53 in fees.
- 2025UC000029 / Ars Child Care Inc. in Eau Claire owes \$395.77 in taxes, \$6.60 in interest, \$737.63 in penalties, and \$10.00 in fees.
- 2025UC000020 / Lighthouse Lakesresort LLC in Lake Geneva owes \$522.15 in taxes, \$22.19 in interest, \$100 in penalties (\$50 per missed quarter), and \$10 in fees.
- 2025UC000077 / Westfahl Plumbing Co. in Brookfield owes \$4.26 in taxes, \$0.04 in interest, \$200.00 in penalties (\$50 per missed quarter), and \$10 in fees.

evidenced by a signed acknowledgement of receipt) constitutes ‘misconduct’ for the purpose of disqualification from unemployment benefits.”

While large employers have paid representatives to monitor and respond to Department inquiries, small employers too often have no one managing their unemployment accounts. As a result, reporting discrepancies are not caught until fees, penalties, and interest are charged.<sup>2</sup> In my ten plus years of representing employers in unemployment matters, I have yet to come across a small employer that has any process or even access setup for online management of their unemployment account prior to my representation. But, with the push for online-only filing, more and more small employers are being hit with these fees and penalties for reasons that they do not understand and are not even aware of until these warrants are issued.


It is this background for why the response time is such an issue for small employers, especially with the delays in postal mail that become widespread in Wisconsin over the last several years (a large envelope takes 4-5 days from one Madison address to another Madison address, and such an envelope to an address in Beaver Dam can take 7 to 10 days).

So, getting some opportunity to respond to Department inquiries is essential. But, mandating a twelve day window for responding to Department inquiries will likely run afoul of the requirements in California Department of Human Resources Development v. Java, 402 U.S. 121, 91 S.Ct. 1347, 28 L.Ed.2d 666 (1971) that unemployment benefits be paid "when due." What seems more doable is for the Department to indicate a mechanism to employers to ask for an extension.

Typically, Department representatives will automatically agree to an extension when an extension is requested. But, the Department does not disclose that practice and instead mandates deadlines for responding to its queries. So, an obvious and effective solution especially in light of the delays with postal mail and the lack of portal access and use is for the Department to include notice about requesting an extension with its queries. Such a solution keeps the Department from running afoul of Java while also offering needed flexibility to small employers.
