Testimony on Assembly Bill 304 and Senate Bill 308

June 10th, 2025

Thank you Chairs James, Chair Tittl and committees members for hearing Assembly Bill 304 and Senate Bill 308, relating to allocation of \$1 million for purchase of Libertas Treatment Center in Chippewa Falls.

As many of you are aware, Western Wisconsin has been devastated by hospital closures in the last two years. First, residents of the Chippewa Valley area were affected by the closures of HSHS Sacred Heart Hospital in Eau Claire and St. Joseph's Hospital in Chippewa Falls. Simultaneously, without notice or public justification, the Libertas Treatment Center closed its doors after providing substance use treatment services in Chippewa Falls for nearly 48 years.

Lutheran Social Services (LSS) of Wisconsin and Upper Michigan recently acquired the former Libertas Treatment Center. Through the purchase and renovation of this facility, LSS plans to open a 50-bed treatment center to help men in need of recovery services. Women in similar circumstances will continue to receive services through a well-established LSS program located in Eau Claire.

The new treatment center will offer daily evidence-based treatment methods. Clients will participate in a variety of group activities and therapy sessions designed to inform, educate, and motivate them as they heal, recover, and prepare for their transition home and within the community. Clients also have the opportunity to engage in other programs within the facility such as GED classes, employment outside of the facility, and other education.

LSS anticipates that most clients served at this new facility will need both medical monitoring and transitional residential treatment services, with many residents being referred from DHS, self-admittance, or a correctional facility.

Due to the challenges of access to healthcare in Western Wisconsin, reopening this facility as a substance use treatment facility will fill a significant void in the area's growing mental healthcare needs. This bill improves access to much needed mental healthcare assistance. I kindly urge you to support this bill and thank you once again for your time to consider this important piece of legislation.

Testimony on 2025 Senate Bill 308/ Assembly Bill 304

Relating to: a grant to assist in the purchase and renovation of an existing facility in the city of Chippewa Falls to provide a 50-bed treatment center to men with substance use disorders.

Thank you, Chairman Tittl, and other members of the committees for the opportunity to testify on this legislation today. Last year, the Chippewa Valley experienced an unprecedented loss of health care services when two hospitals and Prevea Health pulled out of the region. In addition to these closures, L.E. Phillips Libertas Treatment Center, which provided substance use treatment and detox services, also had to close its doors, leaving the Chippewa Falls area with a service gap. Lutheran Social Services of Wisconsin and Upper Michigan (LSS) recently acquired the former Libertas Treatment Center.

Through the purchase and renovation of this facility, LSS plans to open a 50-bed medically monitored and transitional residential treatment center that will serve adult men (ages 18-65+) who self-refer or are referred by the Wisconsin Department of Health Services (DHS) County unit or a correctional facility. Women will continue to receive services through a well-established LSS program located in Eau Claire, WI.

The new treatment center will offer daily, evidence-based treatment methods. Clients will participate in a variety of group activities and therapy sessions designed to inform, educate and motivate them as they heal, recover, and prepare for their transition home and within the community. Clients may also engage in educational and employment opportunities (e.g., GED/HSED virtually, employment outside of the facility, etc.). The typical stay for medically monitored clients will be four to six weeks. For transitional, residential clients, the average stay will range from 30 to 120+ days. Upon discharge, clients will be referred to a continuing care option, such as an outpatient clinic and/or recovery coaching from LSS, as needed.

LSS plans to upgrade the former Libertas Center facility, ensuring that clients experience spaces that are welcoming and safe to assist the healing and recovery process for these patients. Thank you all again for your time and consideration, and I will be happy to answer any questions you have.

It is an honor to speak with you today about supporting legislation that will assist individuals who experience drug and alcohol addiction and co-occurring mental health challenges in the Chippewa Falls and the Eau Claire areas.

My name is Héctor Colón. I am the President and CEO of Lutheran Social Services of Wisconsin and Upper Michigan (Also known as LSS).

As you know Recently, the closures of HSHS Sacred Heart and St. Joseph's Hospital in Eau Claire has left this area without much needed mental health and addiction relating services. At the same time, and without public notice or explanation, the former LE Phillips Libertas Treatment Center in Chippewa Falls closed its doors after providing substance use treatment services since 1977.

Adding to this challenge is that According to the 2024 Chippewa County Community Health Assessment, the top five issues that are impacting residents are 1) Alcohol misuse; 2) lack of public transportation; 3) healthcare accessibility 4) poor mental health; and 5) Lack of access to childcare or unaffordable childcare.



Dear Senator James, Representative Tittle, and Committee Members,

Thank you, Senator James and Rep. Moses for co-authoring this important bill, and thank you, Committee Chairman – Sen. James and Rep. Tittl and Committee Members, for the opportunity to speak today in strong support of SB 308 and AB 304. This legislation would help fund the purchase and renovation of the former LE Phillips Libertas facility in Chippewa Falls to become a 50-bed treatment center for men with substance use disorders.

My name is Tara Treglowne, and I serve as the Chief Operating Officer of Lutheran Social Services of Wisconsin and Upper Michigan. I'm here today on behalf of our organization, and speaking from personal experience, as someone who lost my brother to complications related to substance use. Substance use disorder affects every community and touches nearly every family. Whether directly or indirectly, it impacts us all.

According to the 2023 National Survey on Drug Use and Health:

- Over **48 million** people aged 12 and older had a substance use disorder.
- The highest rates are among young adults aged 18–25, with over **27%** affected.

Despite the clear need, access to treatment remains a critical gap, especially in Northwest Wisconsin, where recent closures of treatment centers have left many without care.

LSS plans to re-open this facility as a medically monitored and transitional residential treatment center for adult men. This center will offer evidence-based therapy, including Cognitive Behavioral Therapy, Motivational Interviewing, and trauma-informed care. We'll also offer support for individuals to obtain their GED, employment support, and life-skills training to prepare clients for long-term recovery and reintegration into their communities.

Renovations- both internal and external - will ensure the facility is **safe, up to code, welcoming, and trauma-informed**, which are all critical to fostering dignity, healing, and hope. Planned updates include expanding bed capacity, upgrading HVAC and windows, improving accessibility to meet licensing requirements, and making modern enhancements such as new flooring, paint, and kitchen improvements.

LSS believes in the **infinite worth of every individual**. Our mission is rooted in whole-person care, and we are proud to be a part of the solution to rebuild Wisconsin's treatment infrastructure in this region.

We respectfully request your support for this \$1 million investment, not only in a building, but in the lives of individuals and families affected by addiction.



Legislative Brief: Help LSS Take On the Chippewa Falls Substance Use Crisis with a 50-Bed Residential Treatment Center

Executive Summary

Nearly 50 million American adults battled a substance use disorder in the past year (National Survey on Drug Use and Health, 2023). Yet, finding treatment services is difficult in many areas of Wisconsin, including in Chippewa Falls.

Recently, Northwest Wisconsin was hit with major healthcare closures including HSHS Sacred Heart Hospital in Eau Claire and St. Joseph's Hospital. Simultaneously, without notice or public explanation, the Libertas Treatment Center closed its doors after providing substance use treatment services in Chippewa Falls since 1977.

Lutheran Social Services of Wisconsin and Upper Michigan (LSS) recently acquired the former Libertas Treatment Center at 2661 County Hwy I in Chippewa Falls. Through the purchase and renovation of this facility, LSS will open a 50-bed treatment center to men in need of recovery services.

The Community Need

At the lowest point of his substance use journey, Chuck spent time incarcerated, lost several peers to their addictions, and was estranged from his children. At a recent check-in with Shelley, our program supervisor, Chuck said that the lessons he learned at LSS helped him decide for something different in his life. Chuck reports that he has been sober for over five years. He continues to attend recovery meetings and has found a support system that he uses every day." He says, "It's not always fun to do the right thing, but it does pay off. I get to be out here every day. I get to be with my kids every day. At thirty, I have my driver's license. I can drive my truck to Walmart to get work materials. I can buy fishing equipment because I have money that I worked hard for!" Chuck hopes to own his own construction company in 10 years. "I'm well on my way there," he said.

Without hospitals and substance use treatment centers in the Chippewa Valley, there is a critical healthcare gap for people like Chuck and the general community. In fact, among the top five issues impacting Eau Claire County residents, poor mental health, substance misuse and alcohol misuse are at the top (2024 Eau Claire County Community Health Assessment).



We know through the National Institute on Drug Abuse (NIDA) that individuals with addiction often have co-occurring health issues, including lung or heart disease, stroke, cancer, or mental health conditions. Additionally, per the NIDA, from 2011 to 2021, over 321,000 U.S. children lost a parent due to overdose.

The community is turning to LSS. As a trusted nonprofit with 143 years of service, LSS is uniquely positioned to expand substance use treatment in Northwest Wisconsin improving access to treatment and empowering community members to regain control of their lives.

The Plan

LSS will open a 50-bed, medically monitored and transitional residential treatment center that will serve adult men (ages 18-65+) who will self-refer or be referred by the Wisconsin Department of Health Services (DHS) County unit or a correctional facility. While referrals could come from other parts of the state, priority will be given to the Chippewa Valley area. Women will continue to receive services through a well-established LSS program located in Eau Claire, WI.

The new 50-bed LSS treatment center will offer daily evidence-based treatment methods for clients throughout each week of stay including Cognitive Behavioral Therapy and Feedback Informed Treatment with Motivational Interviewing and Trauma Informed approaches. Clients will participate in a variety of group activities and therapy sessions designed to inform, educate and motivate them as they heal, recover, and prepare for their transition home and within the community. Visiting and supervised recreation will be offered on weekends. Clients who are eligible may also engage in educational and other opportunities (e.g., GED/HSED virtually, employment outside of the facility, etc.).

The typical stay for medically monitored clients will be four to six weeks, based on the American Society of Addiction Medicine (ASAM) criteria, as well as each individual's unique needs and overall progress. For transitional residential clients the average stay will range from 30 to 120+ days. LSS anticipates that most clients served at this new facility will need both medically monitored and transitional residential treatment services. Upon discharge, clients will be referred to a continuing care option such as an outpatient clinic and/or recovery coaching from LSS, as needed.

To aid in our clients' healing and recovery, LSS will upgrade the former Libertas Center facility, incorporating minor trauma informed modifications to the environmentally friendly building. "Slight adaptive reuse" design elements are crucial for recovery as they create surroundings that acknowledge and address the complex relationship between mental health challenges (including trauma) and addiction. Renovations will ensure that clients experience spaces that are welcoming and safe.



In addition, the facility's outdoor space creates healing connections to nature that will help reduce anxiety and stress for our clients and provide wellness breaks for our colleagues. The lush and beautiful 12-acre park-like grounds offer walking paths that allow access to a gazebo, rock garden, and outdoor seating throughout – elements that are known to boost mental clarity and improve overall physical health.

Legislative Considerations

Legislative approval and support of \$1 million in state funding will assist in the purchase and renovation of the LSS substance use center (total estimated cost of \$3 million), while also providing operating support for the life-enhancing programming that happens within. Following the abrupt closure of the Libertas Center, legislative support will buoy the community by ensuring substance use treatment is accessible to more individuals in the Chippewa Valley who struggle with addiction. Through our partnership, we also will ensure the community is continuously building a robust network of service providers with the intention to destigmatize substance use treatment, so people seek help.

Conclusion

At a time when the Chippewa Valley most needed help for drug and alcohol addiction, local hospitals and substance use treatment centers closed posing significant challenges to the community's healthcare infrastructure. Community leaders and organizations are actively working to address the resulting gaps in services, and LSS will play a significant role in bringing things back into balance in Northwest Wisconsin.

Discussions about LSS opening a 50-bed substance use treatment center in Chippewa Falls is already gaining an enormous amount of excitement and gratitude by the community. Our in-depth knowledge and expertise in this space also indicates there will be a ripple effect that positively impacts family members, schools, neighborhoods, workplaces, and the greater Chippewa Valley area.



Your love shelters Henry in his new home

Chronic health issues led to Henry losing his job and home, forcing him to live in an abandoned RV deep in the woods with no electricity or running water. He felt lonely and hopeless. He became hospitalized and was diagnosed with severe dehydration and depression. He was referred to LSS Gaining Ground, a well-coordinated system of support to meet the comprehensive needs of the people it serves.

Our case worker walked beside Henry to develop goals. She helped Henry complete housing applications, update his Social Security and Disability status, and advocate for access to other community-based resources. In time, Henry found an affordable apartment. He sees doctors to manage his health concerns and receives Meals on Wheels. Henry is flourishing.



Everyone deserves a safe, stable home. Through your generosity each person's specific situation is addressed by assessing the underlying issues that led to homelessness and providing wrap-around services and care coordination to ensure housing is sustainable.

Your dedication lights the way to Laura's bright future

Laura experienced significant trauma in her young life. As a junior in high school, she was acting out in anger and aggression. She was referred to LSS School Centered Mental Health (SCMH) for robust, holistic services that provide help at school and in her home. Our licensed therapists worked with Laura and her counselors, teachers, staff, and mom to help develop a treatment plan for her. Our family coach met with Laura's mom at her home and in the community to provide counseling and resources in support of the health and well-being of her entire family.

Laura worked with our therapist to strengthen her coping skills, address her anger responses, and find healthier ways to express her needs. She has rebuilt her relationship with her mom and siblings. She graduated in May 2024 and is now attending college.

Students like Laura need help to heal and cope before they exhibit harmful behaviors towards themselves or others. Your compassion provides a pathway to well-being.

Your generosity helps Kenny find his way


When Kenny first arrived at LSS Clubhouse he was unemployed, nearly homeless, and grappling with thoughts of suicide. LSS staff and other Clubhouse members accepted him with kindness, warmth, and understanding. **"They guided me through my dark depression. They pointed me in the right direction to healing and happiness again,"** Kenny said.

LSS Clubhouse offerings are based on a recognized international model that provides social contact in a structured, meaningful daily routine for those diagnosed with mental illness. The program has proven vital in relieving feelings of hopelessness which lessens the risk of psychiatric hospitalization.

Kenny received our transitional employment services and was assigned a position as property caretaker at a senior living apartment complex. Eventually, the company hired him as an employee.

Recovery is a process that is seldom linear. Because you care, people in recovery will always have a supportive community in which to use their God-given gifts to serve.

Your welcoming heart opens doors to new beginnings

In 2024, LSS Refugee Resettlement celebrated 50 years of service. Over that time we helped 11,000 individuals and families lawfully and permanently enter the U.S. after having fled unspeakable violence and war. In the first 90-days alone, LSS helps to secure initial housing; food and clothing; school enrollment for children; English as a second language classes; job services and placement. We then continue working with individuals and families to help them become independent and self-sufficient. This generally occurs within 6-12 months. After that initial period, LSS is on-call to answer questions and serve as a resource. The goal for each refugee is self-sufficiency as quickly as possible, and 88% of the refugees served by LSS are employed within 6 months of arrival.



- Fatima, recently resettled from Afghanistan, works at a major healthcare provider coordinating appointments for newly arrived refugees.
- Sonda, a Rohingya woman, is now a case manager at a local agency assisting in resettling new refugees.
- Ahmad, who served as a judge in Afghanistan, is working at a local immigration service supporting Afghan clients on their path to citizenship.

Building a new life, becoming self-sufficient and remaining independent requires a firm foundation and an occasional helping hand.



- **Celebrated 50 years of the LSS Foundation** and the transformative funding that has sustained innovation and helped open new programs to meet evolving community needs.




