***Analysis by the Legislative Reference Bureau***

***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

PREFATORY NOTE: This draft was prepared for the Joint Legislative Council's Special Committee on Recodification of Chapter 45, Veterans, based on recommendations of the committee's drafting subcommittee. The special committee was directed to conduct a recodification of ch. 45, relating to veterans, to include reorganizing the chapter in a logical manner, renumbering and retitling sections, consolidating related provisions, modernizing language, resolving ambiguities in language, making other necessary organizational changes, and making minor substantive changes.

The draft does the following:

1. Reorganizes the entire chapter by subdividing it into 8 subchapters. Currently, the chapter consists of 2 subchapters, one of which relates to housing programs, and the other of which includes all other veterans programs and services.

2. Makes nonsubstantive editorial changes to modernize language to make the language consistent with current drafting style.

3. Repeals several provisions considered no longer necessary. For example, language regarding construction of veterans memorials that have already been constructed is eliminated. As another example, language regarding employment of disabled veterans is eliminated in light of the state Fair Employment Act and the federal Americans with Disabilities Act.

4. Moves to other chapters of the statutes provisions from current ch. 45 that are not directly related to veterans. For example, provisions dealing with military service (ss. 45.50, 45.51, and 45.53) are moved to ch. 21, which relates to military affairs. As another example, the provision dealing with the educational approval board (s. 45.54) is moved to ch. 39, which relates to educational agencies.

5. Simplifies confusing statutory language by drafting it in a format that is easier to understand. For example, the formula for awarding grants to veterans organizations in current s. 45.353 (2) is simplified in the new s. 45.41 (2) by showing how much is received by the organization depending on the level of expenditure.

6. Makes minor substantive changes that the special committee concluded are relatively noncontroversial. These include the following:

a. Expanding the definition of "veteran" that is used in current ch. 45 to include persons who are missing in action, persons who died as the result of a service-connected disability, and persons who died in the line of duty while on inactive or active duty for training purposes.

b. Changing the names of the state veterans facilities in current statutes to the Wisconsin Veterans Home at Union Grove, the Wisconsin Veterans Home at King, and the Wisconsin Veterans Home at Chippewa Falls, and generally applying the laws that currently apply to just one or 2 of the homes to all 3 homes.

c. Expanding the definition of "war period" to include any period after the Iraq War that results in a person receiving an Expeditionary Medal and that the state department

of veterans affairs determines and designates by rule. In designating a war period, the department would be required to review the criteria used to establish the war periods currently listed in the statutes and consult with the U.S. department of defence.

d. Requiring that ch. 45 be construed as liberally as the language permits in favor of applicants. Currently, the liberal construction provision applies to many, but not all, parts of the chapter.

e. Allowing deceased persons who served under honorable conditions in the national guard or reserves to receive military funeral honors. Currently, military funeral honors are limited to deceased persons who served in the U.S. armed forces.

13 the veteran acknowledges paternity or paternity has been otherwise established.

14          **(5)** “Department” means the department of veterans affairs.

15          **(6)** “Dependent” includes any of the following:

16           (a) A spouse, a surviving spouse, or a divorced spouse, but only if the divorced  
17 spouse is not remarried and is receiving child support or maintenance from the  
18 veteran under a court order.

19           (b) Any child under 18 years of age, or under the age of 26 if in full attendance  
20 at a recognized school of instruction, or of any age if incapable of self-support by  
21 reason of mental or physical disability.

22           (c) The biological or adoptive parent or a person who acts in the place of a parent  
23 and who has so acted for not less than 12 months prior to the veteran’s entrance into  
24 active service.

15 (10) “Secretary” means the secretary of the department.

16 (11) “Service in a crisis zone” means any of the following:

17 (a) *Service in Lebanon and Grenada.* A person shall be considered to have  
18 served in Lebanon or Grenada if the person was on active duty in Lebanon or its  
19 territorial waters under honorable conditions between August 1, 1982, and August  
20 1, 1984, or in Grenada between October 23, 1983, and November 21, 1983, and meets  
21 one of the following conditions:

22 1. Was entitled to receive the armed forces expeditionary medal established by  
23 executive order 10977 on December 4, 1961.

24 2. Was entitled to receive the marine corps or navy expeditionary medal.

19 Operation Desert Storm, as established by the department by rule.

20          6. The person served for 90 days or more in support of Operation Enduring  
21 Freedom or an operation that is a successor to Operation Enduring Freedom or

10 if the person was on active duty in the U.S. armed services in Somalia or in territorial  
11 waters adjacent to Somalia under honorable conditions between December 9, 1992,  
12 and the ending date of Operation Restore Hope, as established by the department by  
13 rule.

14           (e) *Service in Bosnia.* A person shall be considered to have served in Bosnia if  
15 the person served for 90 days or more in support of Operation Balkan Endeavor or  
16 served for 90 days or more in Austria, Bosnia and Herzegovina, Czech Republic,  
17 Croatia, Hungary, Macedonia, Montenegro, Serbia including the autonomous  
18 provinces of Kosovo and Vojvodina, Slovakia, or Slovenia, or in territorial waters  
19 adjacent to any of those countries, under all of the following conditions:

20           1. Under an active duty order, an involuntary extension of an active duty order,  
21 or a unit assignment order.

22           2. Under honorable conditions.

23           3. Between December 1, 1995, and the ending date of Operation Balkan  
24 Endeavor or a successor operation, as established by the department by rule.

25           **(12)** “Veteran”, except in s. 45.001, means any of the following:

1           (a) A person who has served on active duty for at least one qualifying term of  
2 service under pars. (b) to (d) under honorable conditions in the U.S. armed forces or  
3 in forces incorporated as part of the U.S. armed forces during a war period or in a

18 Corps Expeditionary Medal, or an equivalent expeditionary or service medal.

19           (e) A person who was honorably discharged from the U.S. armed forces or from

22 or for reasons of hardship.

23           (f) A person who was released under honorable conditions from the U.S. armed

13 (a) Indian War: between 1860 and 1898.

14 (b) Spanish–American War: between April 21, 1898, and April 11, 1899.

15 (c) Philippine Insurrection: between April 12, 1899, and July 4, 1902 (extended  
16 to July 15, 1903, if actually engaged in Moro Province hostilities).

17 (d) Boxer Rebellion: between June 16, 1900, and May 12, 1901.

18 (e) Mexican border service: between June 19, 1916, and April 5, 1917.

19 (f) World War I: between April 6, 1917, and November 11, 1918 (extended to  
20 April 1, 1920, if service was in Russia).

21 (g) World War II: between August 27, 1940, and July 25, 1947.

22 (h) Korean conflict: between June 27, 1950, and January 31, 1955.

23 (i) Vietnam War: between August 5, 1964, and January 1, 1977, excepting  
24 service on active duty for training purposes only.

1 (j) Persian Gulf War: between August 1, 1990, and the ending date of Operation  
2 Desert Shield or the ending date of Operation Desert Storm as established by the  
3 department by rule.

4 (k) Afghanistan War: between September 11, 2001, and the ending date of  
5 Operation Enduring Freedom or an operation that is a successor to Operation  
6 Enduring Freedom, as established by the department by rule.

7 (m) Iraq War: between March 19, 2003, and the ending date of Operation Iraqi

10 (n) Any period after the period specified in par. (m) that the department  
11 determines and designates by rule, after reviewing the criteria used to establish the

20 veterans service officers with information on all necessary military points of contact  
21 and general deployment information for reserve units of the U.S. armed forces.

22 **(14) LIBERAL CONSTRUCTION INTENDED.** This chapter shall be construed as  
23 liberally as the language permits in favor of applicants.

24 **(15) DEFERRAL OF PAYMENTS AND INTEREST ON LOANS.** When a veteran or a  
25 member of the veteran's family makes application for deferment of payment of

17 making of a false or fraudulent affidavit, declaration, certificate, statement, or other  
18 writing, it may suspend all benefits available to the applicant from the department

20 (b) Any person who, with the intent to secure any benefits under this chapter  
21 for personal benefit or for others, willfully makes or causes to be made, or conspires,  
22 assists in, agrees to, arranges for, or in any way procures the making or presentation

15 **(18) COLLECTIONS.** The department may enter into contracts to collect  
16 delinquent loan payments owed to the department. The department may allocate a  
17 portion of the amounts collected under the contracts to pay contract costs.

19 contained in its files pertaining to applications for benefits to contractors providing  
20 collection services to the department.

21 **(19) LOAN GUARANTEE.** The department may provide a loan guarantee for

24 (a) "Duly authorized representative" means any person authorized in writing  
25 by the veteran to act for the veteran, the veteran's guardian if the veteran is

2 for proper reason no representative has been or will be appointed, the veteran's  
3 spouse, an adult child, or, if the veteran is unmarried, either parent of the veteran

5 (b) "Service office" means a county veterans service office.

6 **(2) SEPARATION DOCUMENTS.** Separation documents and copies of separation  
7 documents evidencing service in the armed forces of the U.S. are confidential and  
8 privileged. Examination of these records in the possession of the department or  
9 service office is limited to authorized employees of the department or service office  
10 and information entered in these records may be disclosed only to veterans and their  
11 duly authorized representatives or to interested governmental agencies for the  
12 purpose of assisting veterans and their dependents to obtain the rights and benefits  
13 to which they may be entitled.

14 **(3) U.S. DEPARTMENT OF VETERANS AFFAIRS RECORDS.** Records and papers in the  
15 possession of the department or service office that are released to the department or  
16 service office by the U.S. department of veterans affairs or that contain information  
17 provided by the U.S. department of veterans affairs are confidential. Release of  
18 information from these records or papers may be made only under regulations of the  
19 U.S. department of veterans affairs.

20 **(4) INVESTIGATION.** All reports of investigation made by employees of the  
21 department or at the direction of the department for official departmental purposes  
22 are only for the use of the secretary and staff. Materials and information that  
23 disclose the investigative techniques of the department or the identity of confidential  
24 informants and material received in confidence by representatives of the department  
25 may not be released.

1           **(5) VITAL RECORDS.** The service office may obtain a copy of a vital record under  
2           s. 69.30 (2) and may transmit the copy to the department or to the U.S. department  
3           of veterans affairs to assist a veteran or his or her dependent in obtaining a benefit.

4           **(6) DISCLOSURE OF MONETARY BENEFITS.** The department shall disclose, to any  
5           person who requests, the amount of any payment, grant, or loan made by the  
6           department to any applicant. A person seeking this information shall be required  
7           to sign a statement setting forth the person's name and address and the reason for  
8           making the request and certifying that the person will not use the information  
9           obtained for commercial or political purposes.

10          **(7) DISCLOSURE OF LOAN STATUS INFORMATION.** The department may disclose to  
11          a consumer reporting agency, as defined in 15 USC 1681a (f), the current repayment  
12          status of, the balances due on, and other relevant information pertaining to  
13          department loans that is readily accessible on any loans on which balances are due  
14          and owing the department. The department may charge consumer reporting  
15          agencies an amount sufficient to cover all the costs of preparation and delivery of the  
16          information.

17          **(8) DISCLOSURE OF OTHER INFORMATION.** Except as provided in subs. (2) to (6),  
18          all files, records, reports, papers, and documents pertaining to applications for  
19          benefits from the department, and information contained in them, may be released  
20          by the department or service office only under rules of the department. The rules  
21          shall provide for the furnishing of information required under sub. (7) and for official  
22          purposes by any agency of the U.S. government, by any agency of this state, by any  
23          law enforcement, social services, or human services agency of any Wisconsin county,  
24          or by members of the state senate and assembly. The rules shall otherwise provide  
25          for release of personal information pertaining to or contained in any application for

1       benefits, whether pending or adjudicated, only when authorized in writing by the  
2       applicants or when necessary to assist applicants in securing veterans benefits that

6       served in the U.S. armed forces at any time, and who has been honorably discharged  
7       or given a certificate of service or relieved from active service may record with the  
8       register of deeds of any county, in a suitable book provided by the county for that  
9       purpose, a certificate of discharge or release. The certificate shall be accessible only  
10      to the discharged person or that person's dependents or duly authorized  
11      representative, as defined in s. 45.04 (1) (a), the county veterans service officer, the  
12      department, or any person with written authorization from the discharged person  
13      or that discharged person's dependents. The register of deeds may not charge for  
14      recording, except that in counties where the register of deeds is under the fee system  
15      and not paid a fixed salary, the county shall pay the fee specified in s. 59.43 (2) (ag).  
16      The record of any certificate of discharge or release made prior to July 6, 1919, is  
17      legalized.

18              **45.06 Security. (1)** It shall be unlawful for any person to receive or accept as  
19      a security or to withhold from a veteran or a person who was honorably discharged  
20      from the U.S. armed forces any discharge paper, citation, warrant, medal, badge, or  
21      evidence upon which the veteran is entitled to certain rights, as a veteran under the  
22      laws of the United States or of this state, and any transfer of the item during the life  
23      of the veteran upon a consideration or otherwise shall be null and void, and the  
24      refusal or willful neglect of any person to return or deliver upon demand the

1 discharge paper, citation, warrant, medal, badge, or evidence is punishable as  
2 provided in sub. (2).

3 (2) Any person who violates this section shall be fined not more than \$100 or  
4 imprisoned for not more than 6 months, or both.

5 **45.07 Wisconsin Veterans Museum.** (1) The department of administration  
6 shall provide suitable space for the purpose of a memorial hall, designated as the  
7 Wisconsin Veterans Museum, dedicated to the veterans of Wisconsin and to the men  
8 and women of Wisconsin who served in the armed forces of the United States during  
9 the civil war of 1861 to 1865 and during any subsequent period. The department of  
10 veterans affairs shall operate the Wisconsin Veterans Museum. The mission of the  
11 Wisconsin Veterans Museum is to acknowledge, commemorate, and affirm the role  
12 of Wisconsin veterans in the United States of America's military past by means of  
13 instructive exhibits and other educational programs.

14 (2) The battle flags of Wisconsin units serving in the nation's wars and all relics  
15 and mementos of the nation's wars donated to or otherwise acquired by the state for  
16 display in the Wisconsin Veterans Museum shall constitute the memorial collection.  
17 The department shall do all of the following:

18 (a) Catalog and identify all war relics and mementos of the memorial collection.

19 (b) Restore, preserve, and safeguard the relics and mementos of the memorial  
20 collection.

21 (c) Procure additions to the memorial collection.

22 (d) Provide proper display equipment and display the memorial collection to  
23 make it instructive and attractive to visitors.

24 **45.08 Memorial Day.** (1) Every department and agency of the state  
25 government, every court of the state, and every political subdivision of the state,

1 shall give a leave of absence with pay for the last Monday in May of each year, the  
2 day of celebration for May 30, Memorial Day, to every person in the employ of the  
3 state or political subdivision who has at any time served in and been honorably

5 armed forces. A refusal to give the leave of absence to a person entitled to the leave  
6 constitutes neglect of duty.

10 and assign the necessary work so as to permit the largest possible numbers of eligible  
11 persons to have a leave of absence either all or part of Memorial Day.

**SUBCHAPTER II****EDUCATION AND TRAINING****45.20 Veterans education programs. (1) GENERAL PROVISIONS. (a)**

15 *Definitions.* In this section:

16 1. “Institution of higher education” has the meaning given in 20 USC 1001 (a).

17 2. “Full-time classroom study” means any of the following:

18 a. Enrollment by a graduate student in courses for which more than 8 semester  
19 or the equivalent trimester or quarter credits will be given upon satisfactory  
20 completion.

6 semester or the equivalent trimester or quarter credits will be given upon  
7 satisfactory completion.

8           b. Enrollment by a graduate student in courses that upon satisfactory  
9 completion will fulfill no more than the minimum semester or equivalent trimester  
10 or quarter credit requirements of the program or school in which the student is  
11 enrolled.

12           c. Enrollment by any other eligible student in courses for which no more than  
13 11 semester or the equivalent trimester or quarter credits will be given upon  
14 satisfactory completion.

15           d. Study during a summer semester or session.

16           3. “Tuition” means any of the following:

17           a. For the University of Wisconsin System, academic fees, as described in s.  
18 36.27 (1), and segregated fees.

19           b. For technical colleges, program fees, as described in s. 38.24 (1m) (a) and (b)  
20 and additional fees reported and assessed by the college for the course of study.

21           c. For a high school, a school that is approved under s. 45.03 (11), or a  
22 proprietary school that is approved under s. 39.90, the charge for the courses for  
23 which a person is enrolled.

1           d. For an institution from which a person receives a waiver of nonresident  
2           tuition under s. 39.47, the amount of the reciprocal fee under s. 39.47 (2) and any fees  
3           that are similar to segregated fees for the University of Wisconsin System.

5           if the department determines that the income of the veteran and his or her spouse  
6           exceeds \$50,000 plus \$1,000 for each additional dependent in excess of 2 dependents.

7           2. In determining eligibility under this section, the department shall verify all  
8           reported income amounts.

9           (c) *Reimbursement limit.* The amount of the reimbursement under sub. (2) or  
10          (3) may not exceed the total cost of the veteran's tuition or the standard cost for a state  
11          resident for tuition for an equivalent undergraduate course at the University of  
12          Wisconsin–Madison per course, whichever is less, minus any grants or scholarships  
13          that the veteran receives specifically for the payment of tuition.

14          (d) *Child support or maintenance delinquency.* The department may provide  
15          reimbursement under sub. (2) or (3) to a veteran who is delinquent in child support  
16          or maintenance payments or who owes past support, medical expenses, or birth  
17          expenses, as established by appearance of the veteran's name on the statewide  
18          support lien docket under s. 49.854 (2) (b), only if the veteran provides the  
19          department with one of the following:

20               1. A repayment agreement that the veteran has entered into, that has been  
21               accepted by the county child support agency under s. 59.53 (5), and that has been  
22               kept current for the 6-month period immediately preceding the date of the  
23               application.

24               2. A statement that the veteran is not delinquent in child support or  
25               maintenance payments and does not owe past support, medical expenses, or birth

1 expenses, signed by the department of workforce development or its designee within  
2 7 working days before the date of the application.

3 **(2) TUITION REIMBURSEMENT PROGRAM.** (a) *Eligibility.* A veteran is eligible for  
4 the tuition reimbursement program under this subsection if he or she meets all of the  
5 following conditions:

6 1. The veteran applies for the tuition reimbursement program for courses  
7 begun within 10 years after separation from the service.

8 2. The veteran is a resident at the time of application for the tuition  
9 reimbursement program.

10 3. The veteran is enrolled for at least 12 credits during the semester for which  
11 reimbursement is sought.

12 (b) *Program benefits.* 1. A veteran who meets the requirements under par. (a),  
13 upon satisfactory completion of a full-time undergraduate semester in any  
14 institution of higher education in this state, any school that is approved under s.  
15 45.03 (11), any proprietary school that is approved under s. 39.90, or any institution  
16 from which the veteran receives a waiver of nonresident tuition under s. 39.47, may  
17 be reimbursed an amount not to exceed the total cost of the veteran's tuition minus  
18 any grants or scholarships that the veteran receives specifically for the payment of  
19 the tuition. Reimbursement is available only for tuition that is part of a curriculum  
20 that is relevant to a degree in a particular course of study at the institution.

21 2. The application for reimbursement of tuition under this subsection shall  
22 meet all of the following conditions:

23 a. Be completed and received by the department no later than 60 days after the  
24 completion of the semester. The department may accept an application received

1 more than 60 days after the completion of the semester if the applicant shows good  
2 cause for the delayed receipt.

3 b. Contain the information necessary to establish eligibility as determined by  
4 the department.

5 c. Be on the application form approved by the department.

9 3. Reimbursement provided under this subsection shall be paid from the  
10 appropriation under s. 20.485 (2) (tf). If the amount of funds applied for exceeds the

12 reimbursement that would otherwise qualify under this subsection. In those cases,  
13 the department shall determine eligibility on the basis of the dates on which  
14 applications for reimbursement were received.

15 4. Reimbursement of tuition and fees for a course may be provided at an  
16 institution or school under subd. 1. other than one from which the veteran is  
17 receiving his or her degree if all of the following apply:

18 a. The curriculum at the institution or school consists only of courses necessary  
19 to complete a degree in a particular course of study.

20 b. The course is accepted as transfer credits at the institution or school listed  
21 under subd. 1. from which the veteran is receiving his or her degree but is not  
22 available at that institution or school.

23 (c) *Limitations.* 1. A veteran is not eligible for reimbursement under this  
24 subsection for more than 120 credits or 8 full semesters of full-time study at any  
25 institution of higher education in this state, 60 credits or 4 full semesters of full-time

1 study at any institution of higher education in this state that offers a degree upon  
2 completion of 60 credits, or an equivalent amount of credits at a school that is  
3 approved under s. 45.03 (11), at a proprietary school that is approved under s. 39.90,

5 s. 39.47.

6 2. A veteran may not receive reimbursement under this subsection for any  
7 semester in which he or she received reimbursement under sub. (3) or s. 21.49.

8 **(3) CORRESPONDENCE COURSES AND PART-TIME CLASSROOM STUDY. (a) *Eligibility.***

9 The following persons are eligible for benefits under this section:

10 1. A veteran.

11 2. An unremarried surviving spouse or minor or dependent child of a deceased  
12 veteran.

13 (b) *Program benefits.* 1. A person, upon the completion of any correspondence  
14 course or part-time classroom study from an institution of higher education located  
15 in this state, from a school that is approved under s. 45.03 (11), from a proprietary  
16 school that is approved under s. 39.90, or from any public or private high school, may  
17 be reimbursed in part for the cost of the course by the department. The person shall  
18 present to the department a certificate from the school indicating that the person has  
19 completed the course and stating tuition and shall apply for reimbursement on an  
20 application that is received by the department no later than 60 days after the  
21 termination of the course for which the application for reimbursement is made. The  
22 department shall accept and process an application received more than 60 days after  
23 the termination of the course if the applicant shows good cause for the delayed  
24 receipt.

1           2. A person who is a resident of this state and otherwise qualified to receive  
2           benefits under this subsection may receive the benefits under this subsection upon  
3           the completion of any correspondence courses or part-time classroom study from an  
4           institution of higher education located outside this state if any of the following

6           a. The part-time classroom study is not offered within 50 miles of the person's  
7           residence by any school or institution under sub. (2) and the educational institution  
8           from which the study is offered is located not more than 50 miles from the boundary  
9           line of this state.

10          b. The correspondence course is not offered by an institution in this state.

11          3. Enrolled part-time classroom study or direct correspondence courses from  
12          a qualified educational institution may be authorized and the person reimbursed in  
13          part by the department when the courses are related to one's occupational,  
14          professional, or employment objectives, and to the extent that payment or  
15          reimbursement is not available from any other sources, or, in cases where  
16          reimbursement is not specifically for tuition, to the extent that the reimbursement  
17          is insufficient to cover all educational costs.

18          (b) *Limitations.* 1. a. No person who has obtained a master's degree or its  
19          equivalent is eligible for reimbursement under this subsection.

20          b. No person who has obtained at least a baccalaureate degree or its equivalent  
21          but not a master's degree or its equivalent is eligible for reimbursement under this  
22          subsection if the person has remaining U.S. department of veterans affairs education  
23          benefits.

1           c. For the purpose of this subsection, any person who has received a  
2           baccalaureate degree shall be deemed to be a graduate student whether he or she is  
3           taking graduate or undergraduate courses.

4           2. The department may not provide reimbursement under this subsection

6           related to the applicant's occupational, professional, or employment objectives.

7           3. A person may not be reimbursed under this subsection more than 4 times  
8           during any consecutive 12-month period.

9           **45.21 Retraining assistance program. (1) AMOUNT AND APPLICATION.** The  
10          department may pay a veteran not more than \$3,000 for retraining to enable the  
11          veteran to obtain gainful employment. The department shall determine the amount  
12          of the payment based on the veteran's financial need. A veteran may apply for aid  
13          to the county veterans service officer of the county in which the veteran is living. The  
14          department may, on behalf of a veteran who is engaged in a structured on-the-job  
15          training program and who meets the requirements under sub. (2), make a payment  
16          under this subsection to the veteran's employer.

17          **(2) ELIGIBILITY.** The department may provide aid under this section if all of the  
18          following apply:

19               (a) The veteran is enrolled in a training course in a technical college under ch.  
20               38 or in a proprietary school in the state approved by the educational approval board  
21               under s. 39.90, other than a proprietary school offering a 4-year degree or 4-year  
22               program, or is engaged in a structured on-the-job training program that meets  
23               program requirements promulgated by the department by rule.

24               (b) The veteran meets the financial assistance criteria established under sub.

25               (3) (c).

1 (c) The veteran is unemployed, underemployed, as defined by rule, or has  
2 received a notice of termination of employment.

3 (d) The veteran requesting aid has not received reimbursement under s. 45.20  
4 for courses completed during the same semester for which a grant would be received

6 (e) The department determines that the veteran's proposed program will  
7 provide retraining that could enable the veteran to find gainful employment. In  
8 making its determination, the department shall consider whether the proposed  
9 program provides adequate employment skills and is in an occupation for which  
10 favorable employment opportunities are anticipated.

11 **(3) RULES.** The department shall promulgate rules for the distribution of aid  
12 under this program, including all of the following:

13 (a) Standard budgets for single and married veterans.

14 (b) Selection procedures.

15 (c) Uniform need determination procedures.

16 (d) Application procedures.

17 (e) Coordination with other occupational training programs.

18 (f) Other provisions the department deems necessary to assure uniform  
19 administration of this program.

20 **(4) REPORT.** The department shall include in its biennial report under s. 15.04  
21 (1) (d) information relating to the veterans retraining assistance program, including  
22 the number of veterans obtaining gainful employment after receiving aid and a  
23 description of the veterans receiving aid, including their sex, age, race, educational  
24 level, service-connected disability status, and income before and after obtaining  
25 gainful employment. This information may be based on a valid statistical sample.

## SUBCHAPTER III

## VETERANS HOUSING LOAN PROGRAM

**45.30 Purpose. (1)** LEGISLATIVE FINDINGS. It is determined that veterans, who have sacrificed in the service of their country valuable years of their lives and considerable earning potential, constitute a readily identifiable and particularly deserving segment of this state's population. It is further determined that by making additional housing funds available to eligible veterans, limited private home loan funds will be more readily available to all. It is further determined that the loan programs established under this subchapter are special purpose credit programs for an economically disadvantaged class of persons for the purposes of 15 USC 1691–1691f.

**(2)** LEGISLATIVE INTENT. This subchapter is created principally to enable the state and the authority to exercise their borrowing power to increase those funds available for loans providing for the purchase or construction of private housing, without requiring down payments beyond the reach of families of modest means. It is the intent of the legislature that the department in its administration of this subchapter avoid the duplication of those administrative services available through private lending institutions, utilizing the administrative services of such institutions to the maximum extent consistent with the purposes of this subchapter.

**45.31 Definitions.** In this subchapter:

**(1)** “Anticipated annual shelter payment” means the total annual payments anticipated for the following, as determined by the department or authorized lender on the basis of the loan applied for under s. 45.37:

(a) Real estate taxes on the premises to be mortgaged.

(b) Insurance premiums for coverage required under s. 45.37 (3) (b).

1 (c) Required payments on principal and interest on all mortgages placed or to  
2 be placed against the home of an eligible person.

3 (2) “Authority” means the Wisconsin Housing and Economic Development  
4 Authority.

5 (3) “Authorized lender” means any lender or servicer authorized under s. 45.37  
6 (5) (a) 5. to make or service loans under s. 45.37.

7 (4) “Closing costs” include:

8 (a) Any origination fee authorized under s. 45.37 (5) (b).

9 (b) Attorney fees.

10 (c) Recording fees.

11 (d) Other costs authorized by the department.

12 (5) “Eligible person” means any person eligible under s. 45.33 (1) and not  
13 disqualified under s. 45.33 (2) to receive a loan under this subchapter.

14 (6) “Federal Home Loan Mortgage Corporation” means the corporation created  
15 under 12 USC 1451 to 1459.

16 (7) “Funds” include cash on hand and liquid investments owned by the veteran  
17 and his or her spouse, individually or jointly, unless the veteran and spouse are  
18 legally separated under s. 767.07.

19 (8) “Guaranteed loan” means a loan guaranteed by the U.S. department of  
20 veterans affairs under 38 USC 1801 to 1827.

21 (9) “Home” means a building or portion of a building used as the veteran’s  
22 principal place of residence, and includes condominiums and income-producing  
23 property, a portion of which is used as a principal place of residence by the veteran,  
24 and the land, including existing improvements, appertaining to the building.

1           **(10)** “Income” means the sum of the federal adjusted gross income plus any  
2 income received that may reasonably be expected to be regular and dependable.

3           **(11)** “Insurer” means any insurer authorized to do business in this state.

4           **(12)** “Manufactured home” means a structure, as defined by the Federal Home  
5 Loan Mortgage Corporation, which meets or exceeds the statutory size under s.  
6 348.07 (2).

7           **(13)** “Monthly payment” means all of the following:

8           (a) Required payments on principal and interest.

9           (b) Insurance premiums for coverage required under s. 45.37 (3) (b).

10          (c) One-twelfth of annual real estate taxes on the mortgaged property.

11          **(14)** “Qualified purpose” means any purpose authorized under s. 45.34 (1).

12          **45.32 Powers of the department.** With respect to loans made by and  
13 mortgages and mortgage notes executed or properties mortgaged to the department  
14 or to authorized lenders under this subchapter, the department may do any of the  
15 following:

16          **(1)** Execute necessary instruments.

17          **(2)** Collect interest and principal.

18          **(3)** Compromise indebtedness due on mortgage notes.

19          **(4)** Sue and be sued.

20          **(5)** Exercise the rights of a mortgagee, generally including the right to do any  
21 of the following:

22          (a) Acquire or take possession of the mortgaged property and in so doing the  
23 department may accept voluntary surrender and conveyance of title to the property  
24 in full satisfaction of a mortgage debt or may bid for and purchase the property at  
25 a sheriff’s sale or replevin the property.

1 (b) Commit itself to execute and execute subordination agreements, partial  
2 releases, and other necessary instruments.

3 (c) Set up and follow procedures to assure proper disbursement of the proceeds  
4 of insurance checks, share drafts, or other drafts covering damages sustained on  
5 mortgaged properties.

6 (d) Pay the principal and interest on any obligations incurred in connection  
7 with the mortgages on the property including real estate taxes, insurance premiums,  
8 attorney fees, and obligations created as a result of its exercise of powers vested in  
9 it under this subchapter.

10 (e) Exercise any other powers as may be necessary for the efficient  
11 administration of this subchapter.

12 **(6)** In contracts entered into under s. 45.37 (5) (a) 1., empower authorized  
13 lenders to exercise any of the powers vested in the department under this subchapter.

14 **(7)** Manage, operate, lease, exchange, sell, and otherwise convey real property.

15 **(8)** Grant easements in any real property the department acquires.

16 **(9)** Upon application by the mortgagor and agreement in writing executed by  
17 the parties:

18 (a) Extend the time in which the obligation under a mortgage note or any part  
19 of the obligation must be paid.

20 (b) Reduce the amounts of monthly installments and provide other terms and  
21 conditions relative to time and manner of repaying the obligation as it deems  
22 necessary or reasonable.

23 **45.33 Eligibility and disqualifying factors. (1) ELIGIBLE PERSONS.** Subject

25 (a) A veteran.

4 (c) The unremarried surviving spouse or dependent child, as defined in s. 45.01

6 **(2) DISQUALIFYING FACTORS.** (a) A person listed in sub. (1) may not receive a loan  
7 under this subchapter if the department or authorized lender determines that any  
8 of the following applies:

9 1. The person will be incurring an excessive indebtedness in view of the person's  
10 income.

11 2. The person has a previous loan outstanding under this subchapter, unless  
12 any of the following apply:

13 a. The previous loan has been assumed by an eligible person with the  
14 department's approval upon the sale of the residence securing the previous loan.

15 b. The person is applying for a loan under s. 45.37 for a purpose under s. 45.34  
16 (1) (c) and the previous loan was made under s. 45.37.

17 (b) A person listed in sub. (1) who is not a permanently and totally disabled  
18 veteran may not receive a loan under this subchapter if the department or authorized  
19 lender determines that any of the following applies:

20 1. The person is delinquent in child support or maintenance payments or owes  
21 past support, medical expenses, or birth expenses, as evidenced by the appearance  
22 of the person's name on the statewide support lien docket under s. 49.854 (2) (b),  
23 unless the person provides the department or authorized lender with one of the  
24 following:

12          **45.34 Uses for loan proceeds. (1)** MORTGAGE LOAN PROGRAM. An authorized  
13          lender may, with the approval of the department, make loans under s. 45.37 for any

7 that person was denied by the department. Refinancing loans may be made under

10 that the loan application should have been approved.

11 2. Refinancing the balance due on a construction period loan, bridge loan, or

22 (c) Loans made pursuant to this section shall not be subject to s. 138.05,  
23 138.051, or 138.052, except that a loan originated under this section after May 3,  
24 1996, is subject to s. 138.052 (5).

10 authorized lenders under sub. (5) (b).

11           11. Payment required of the department under sub. (5) (a) 6.

12           12. Payment of obligations arising from the acquisition of a headquarters and  
13 museum building for the department under s. 45.03 (5) (b).

14           (b) The board may amend the system of accounts established under par. (a) only  
15 by resolution of the board that is approved by the building commission.

16           (c) If revenues of the veterans mortgage loan repayment fund are insufficient  
17 to meet all current expenses, the secretary of administration shall establish a  
18 repayment schedule whereby the general fund will be reimbursed in an orderly  
19 manner for moneys advanced. Interest rates to be charged on loans subsequently  
20 issued shall be adjusted to provide sufficient revenues to meet all of this repayment  
21 schedule.

22           (d) After meeting all expenses and providing for reserves under par. (a) 3.,  
23 assets in the veterans mortgage loan repayment fund, upon prior approval of the

21 (c) After the assumption of a guaranteed loan funded under sub. (6) (c), if the  
22 loan is assumed, or the closing of the sale of a residence on which a balance is owing  
23 on a guaranteed loan funded under sub. (6) (c), the balance owing on the loan on the  
24 date of the assumption of the loan, if the loan is assumed, or the closing of the sale  
25 may be paid to the funds created under sub. (10) from available surpluses, if any, in

11 **(13) REPAYMENT OF LOAN.** Any money appropriated or transferred by law from  
12 the veterans mortgage loan repayment fund for purposes other than those listed in  
13 sub. (7), other than moneys made temporarily available to other funds under s.  
14 20.002 (11), shall be repaid from the general fund with interest at a rate of 5 percent  
15 per year from the date of the appropriation or transfer to the date of repayment.

**SUBCHAPTER IV****ASSISTANCE PROGRAMS**

18 **45.40 Economic assistance. (1) SUBSISTENCE AID.** (a) The department may  
19 provide subsistence aid to an incapacitated veteran or a dependent of a veteran in  
20 an amount that the department determines advisable to prevent undue hardship.  
21 The department may provide subsistence aid under this subsection to a person  
22 whose incapacitation is the result of alcohol or other drug abuse, if the person is  
23 participating in an alcohol or other drug abuse treatment program approved by the  
24 department. The department may provide subsistence aid on a month-to-month  
25 basis or for a 3-month period. The department may provide the aid for a 3-month

1 period if the veteran or dependent whose incapacity is the basis for the aid will be  
2 incapacitated for more than 3 months, as determined by a health care provider as  
3 defined in s. 146.81 (1), and if earned or unearned income or aid from other sources  
4 will not be available in the 3-month period. Subsistence aid shall be limited to a  
5 maximum of 3 months in a 12-month period unless the department determines that  
6 the need for subsistence aid in excess of this maximum time period is caused by the  
7 person's relapse.

8 (b) The department may submit a request to the joint committee on finance for  
9 supplemental funds from the veterans trust fund to be credited to the appropriation  
10 account under s. 20.485 (2) (vm) to provide payments under this subsection. The joint  
11 committee on finance may, from the appropriation under s. 20.865 (4) (u),  
12 supplement the appropriation under s. 20.485 (2) (vm) in an amount equal to the  
13 amount that the department expects to expend under this subsection.  
14 Notwithstanding s. 13.101 (3) (a), the committee is not required to find that an  
15 emergency exists. If the cochairpersons of the committee do not notify the secretary  
16 within 14 working days after the date of the department's submittal that the  
17 committee intends to schedule a meeting to review the request, the appropriation  
18 account shall be supplemented as provided in the request. If, within 14 working days  
19 after the date of the department's submittal, the cochairpersons of the committee  
20 notify the secretary that the committee intends to schedule a meeting to review the  
21 request, the appropriation account shall be supplemented only as approved by the  
22 committee.

23 **(2) HEALTH CARE AID.** The department may provide temporary health care aid  
24 for a veteran or the dependent of a veteran if the department considers it advisable  
25 to prevent undue hardship. Health care aid to pay medical or hospital bills under

1 this subsection is limited to a payment of up to \$5,000 per veteran or dependent for  
2 a 12-month period beginning on the first day of care for which the person seeks  
3 reimbursement under this subsection. The department may issue a certificate of  
4 entitlement stating that a veteran or dependent is eligible for health care aid under  
5 this subsection if the treatment is received within a time period that the department  
6 promulgates by rule. The department may not provide health care aid to pay for care  
7 provided to the veteran or dependent before the time period identified in the  
8 certificate of entitlement, except for emergency care, as determined by the  
9 department, if the application for the health care aid is submitted within 90 days  
10 after the emergency care ends. Health care aid may be used to provide payment for  
11 the treatment of alcoholism or other drug addiction or to provide payment for health  
12 care required because of alcoholism or other drug addiction or alcohol or other drug  
13 abuse. The department may not provide health care aid under this subsection unless  
14 the person's health care provider agrees to accept, as full payment for the medical  
15 treatment for which the aid is to be granted, the amount of the aid, the amount of the  
16 person's health insurance or other 3rd-party payments, if any, and the amount that  
17 the department determines the person is capable of paying. The department may not  
18 provide health care aid under this subsection if the combined liquid assets of the  
19 veteran and veteran's dependents who are living in the same household are in excess  
20 of \$1,000.

21 **(3) APPROPRIATIONS.** The department may provide aid under this section from  
22 the appropriation in s. 20.485 (2) (vm). Nothing in this section empowers the  
23 department to incur any state debt.

24 **45.41 Payments to veterans organizations. (1)** In this section:

1           (a) “Regional office” means the U.S. department of veterans affairs regional  
2 office in Wisconsin.

3           (b) “State veterans organization” means the state organization or department  
4 of a national veterans organization incorporated by an act of congress.

5           **(2)** Upon application the department shall make a payment to any state  
6 veterans organization that establishes that it, or its national organization, or both,  
7 has maintained a full-time service office at the regional office for 5 consecutive years  
8 out of the 10-year period immediately preceding the application. The payment shall  
9 be calculated based on the total amount of all salaries and travel expenses under sub.

10 (3) paid during the previous fiscal year by the state veterans organization to  
11 employees engaged in veterans claims service and stationed at the regional office.  
12 The payment shall be as follows:

13           (a) If the total amount paid under sub. (3) is from \$1 to \$2,499, the organization  
14 shall receive the amount paid.

15           (b) If the total amount paid under sub. (3) is from \$2,500 to \$9,999, the  
16 organization shall receive \$2,500.

17           (c) If the total amount paid under sub. (3) is from \$10,000 to \$119,999, the  
18 organization shall receive 25 percent of the amount paid.

19           (d) If the total amount paid under sub. (3) is \$120,000 or more, the organization  
20 shall receive \$30,000.

21           **(3)** A state veterans organization shall file an application annually with the  
22 department for the previous 12-month period ending on March 31 of the year in  
23 which it is filed. The application shall contain a statement of salaries and travel  
24 expenses paid to employees of the organization engaged in veterans claims service  
25 activities at the regional office by the state veterans organization covering the period

1 for which application for a payment is made. The statement shall be certified as  
2 correct by a certified public accountant licensed or certified under ch. 442 and sworn  
3 to as correct by the adjutant or principal officer of the state veterans organization.  
4 The application shall include the state organization's financial statement for its  
5 previous fiscal year and evidence of claims service activity that the department  
6 requires. The state veterans organization shall submit with its initial application  
7 sufficient evidence to establish that it or its national organization, or both, has  
8 maintained a full-time service office at the regional office for 5 consecutive years out  
9 of the 10-year period immediately preceding the application. Subsequent  
10 applications shall be accompanied by an affidavit by the adjutant or principal officer  
11 of the state veterans organization stating that the organization, on its own or with  
12 its national organization, maintained a full-time service office at the regional office  
13 for the entire 12-month period for which application for a payment is made.

14 (4) From the appropriation under s. 20.485 (2) (s), the department shall  
15 annually provide a payment of \$100,000 to the Wisconsin department of the Disabled  
16 American Veterans for the provision of transportation services to veterans.

17 **45.42 Veterans personal loans.** (1) It is determined that the loan program  
18 established under this section is a special purpose credit program for an economically  
19 disadvantaged class of persons for purposes of 15 USC 1691–1691f.

20 (2) The department may lend a veteran, a veteran's unremarried surviving  
21 spouse, or a deceased veteran's child not more than \$25,000, or a lesser amount  
22 established by the department under sub. (9). The department may prescribe loan  
23 conditions, but the term of the loan may not exceed 10 years. The department shall  
24 ensure that the proceeds of any loan made under this section shall first be applied  
25 to pay any delinquent child support or maintenance payments owed by the person

1 receiving the loan and then to pay any past support, medical expenses, or birth  
2 expenses owed by the person receiving the loan.

3       **(3)** The department may lend to the remarried surviving spouse of a deceased  
4 veteran or to the parent of a deceased veteran's child not more than \$25,000, or a  
5 lesser amount established by the department under sub. (9), for the education of the  
6 deceased veteran's child.

7       **(4)** The department may execute necessary instruments, collect interest and  
8 principal, compromise indebtedness, sue and be sued, post bonds, and write off  
9 indebtedness that it considers uncollectible. If a loan under this section is secured  
10 by a real estate mortgage, the department may exercise the rights of owners and  
11 mortgagees generally and the rights and powers set forth in s. 45.32. The  
12 department shall pay all interest and principal repaid on the loan into the veterans  
13 trust fund.

14       **(5)** The department may charge loan expenses incurred under this section to  
15 the loan applicant. The department shall pay all expenses received under this  
16 subsection into the veterans trust fund.

17       **(6)** The department may provide a loan under this section to an applicant  
18 whose name appears on the statewide support lien docket under s. 49.854 (2) (b) only  
19 if the applicant does one of the following:

20       (a) Provides to the department a repayment agreement that the applicant has  
21 entered into, that has been accepted by the county child support agency under s.  
22 59.53 (5), and that has been kept current for the 6-month period immediately  
23 preceding the date of the application.

24       (b) Provides to the department a statement that the applicant is not delinquent  
25 in child support or maintenance payments and does not owe past support, medical

1 expenses, or birth expenses, signed by the department of workforce development or  
2 its designee within 7 working days before the date of the application.

3 (c) Agrees to use the loan proceeds to pay any delinquent child support or  
4 maintenance payments and to pay any past support, medical expenses, or birth  
5 expenses if the applicant fails to meet the requirements under par. (a) or (b).

6 (7) No person may receive a loan under this section in an amount that, when  
7 added to the balance outstanding on the person's existing loans under s. 45.351 (2),  
8 1995 stats., and s. 45.356, 1995 stats., would result in a total indebtedness to the  
9 department of more than \$25,000.

10 (8) (a) The department may borrow from the veterans mortgage loan  
11 repayment fund under s. 45.37 (7) (a) to obtain money to make loans under this  
12 section.

13 (b) The department may enter into transactions with the state investment  
14 board to obtain money to make loans under this section. Transactions authorized  
15 under this paragraph may include the sale of loans.

16 (9) Subject to the limits established in subs. (2) and (3), the department may  
17 periodically adjust the maximum loan amount based upon financial market  
18 conditions, funds available, needs of the veterans trust funds, or other factors that  
19 the department considers relevant.

20 (10) The department may periodically adjust the interest rates for loans made  
21 under this section, which may vary based upon the term of the loan, the type of  
22 security offered, the method of payment, or other factors that the department  
23 considers relevant.

24 (11) If an applicant's total indebtedness for loans made under this section is  
25 more than \$5,000, the loan shall be evidenced by a promissory note and secured by

1 a mortgage on real estate located in this state. A loan of \$5,000 or less made to an  
2 applicant whose total indebtedness for loans made under this section is \$5,000 or less  
3 shall be evidenced by a promissory note and secured by a guarantor or by a mortgage  
4 on real estate located in this state. A mortgage securing a loan made under this  
5 section is acceptable if the applicant has equity in the property subject to the  
6 mortgage equal to or exceeding a minimum amount that the department establishes  
7 by rule.

8 **45.43 Veterans assistance program. (1)** The department shall administer  
9 a program to provide assistance to persons who served in the U.S. armed forces or  
10 in forces incorporated as part of the U.S. armed forces and who were discharged  
11 under conditions other than dishonorable. The department shall provide assistance  
12 to persons whose need for services is based upon homelessness, incarceration, or  
13 other circumstances designated by the department by rule. The department shall  
14 designate the assistance available under this section, which may include assistance  
15 in receiving medical care, dental care, education, employment, and transitional  
16 housing. The department may provide payments to facilitate the provision of  
17 services under this section.

18 **(2)** The department may charge fees for transitional housing and for other  
19 assistance provided under this section that the department designates. The  
20 department shall promulgate rules establishing the fee schedule and the manner of  
21 implementation of that schedule.

22 **SUBCHAPTER V**

23 **VETERANS HOMES**

24 **45.50 Veterans homes; management. (1)** (a) The department shall operate  
25 the Wisconsin Veterans Home at King and employ a commandant for the home. The

**BILL**

1 department shall employ a commandant for the Wisconsin Veterans Home at Union  
2 Grove and may employ a commandant for the Wisconsin Veterans Home at  
3 Chippewa Falls. The department may employ any personnel that are necessary for  
4 the proper management and operation of veterans homes. In compliance with the  
5 compensation plan established pursuant to s. 230.12 (3), a commandant may  
6 recommend to the director of personnel charges for meals, living quarters, laundry,  
7 and other services furnished to employees and members of the employees' family  
8 maintained at veterans homes. The department shall provide complete personal  
9 maintenance and medical care, including programs and facilities that promote  
10 comfort, recreation, well-being, or rehabilitation, to all members of veterans homes.

11 (b) All moneys received as reimbursement for services to veterans homes  
12 employees or as payment for meals served to guests at veterans homes shall be  
13 accumulated in an account named "employee maintenance credits" and shall be paid  
14 into the general fund within one week after receipt and credited to the appropriation  
15 under s. 20.485 (1) (gk).

16 (c) Veterans homes with a skilled nursing facility shall include a geriatric  
17 evaluation, research, and education program. The program staff shall be funded  
18 from the appropriations under s. 20.485 (1) (hm), (j), and (mj).

19 **(2)** (a) Subject to authorization under ss. 13.48 (10) and 20.924 (1), the  
20 department may construct or renovate and operate residential, treatment, and  
21 nursing care facilities, including a community-based residential facility, to be known  
22 as the Wisconsin Veterans Home at Union Grove.

23 (b) Subject to authorization under ss. 13.48 (10) and 20.924 (1), the department  
24 may develop, construct or renovate, and operate residential, treatment, and nursing  
25 care facilities and programs for veterans in northwestern Wisconsin, on the property

1 of the Northern Wisconsin Center for the Developmentally Disabled in Chippewa  
2 Falls to be known as the Wisconsin Veterans Home at Chippewa Falls. The programs  
3 and facilities may include an assisted living facility, a skilled nursing facility, a  
4 medical clinic, an adult day health care center, an activities center, and a veterans  
5 assistance program.

6       **(3)** The department may acquire, by gift, purchase, or condemnation, lands  
7 necessary for the purposes of the veterans homes. Title to the lands shall be taken  
8 in the name of this state and shall be held by and for the uses and purposes of the  
9 veterans homes. No payment may be made out of the state treasury or otherwise for  
10 the land until the title has been examined and approved by the attorney general.  
11 Every such deed of conveyance shall be immediately recorded in the office of the  
12 proper register of deeds and filed with the secretary of state.

13       **(4)** The department may use moneys appropriated under s. 20.485 (1) (h) to  
14 purchase, erect, construct, or remodel buildings, to provide additions and  
15 improvements, to provide equipment, materials, supplies, and services necessary for  
16 the purposes of veterans homes, and for expenses that are necessary and incidental  
17 to acquisition of property under s. 45.51 (10) and (11).

18       **(5)** The department may accept gifts, bequests, grants, or donations of money  
19 or of property from private sources to be administered by the department for the  
20 purposes of veterans homes. All moneys received shall be paid into the general fund  
21 and appropriated as provided in s. 20.485 (1) (h), except that gifts or grants received  
22 specifically for the purposes of the geriatric program at veterans homes are  
23 appropriated as provided in s. 20.485 (1) (hm). The department may not apply to the  
24 gifts and bequests fund interest on certificate of savings deposits for those members  
25 who do not receive maximum monthly retained income. The department shall

**BILL**

1 establish for those persons upon their request individual accounts with savings and  
2 interest applied as the member requests.

3 **(6)** (a) The department may enter into agreements for furnishing and charging  
4 for water and sewer service from facilities constructed at and for veterans homes to  
5 public and private properties lying in the immediate vicinity of veterans homes.

6 (b) Agreements under this section shall be drafted to hold harmless the  
7 department, to require all expense to be paid by the applicant, and to be terminable  
8 by the department when other water and sewer services become available to the  
9 applicant.

10 **(7)** A commandant and employees designated by the commandant may  
11 summarily arrest all persons within or upon the grounds of veterans homes who are  
12 guilty of any offense against the laws of this state or the rules governing veterans  
13 homes. For this purpose, a commandant and deputies have the power of constables.

14 **(8)** A fire department at a veterans home in response to emergency fire calls  
15 may make runs and render fire fighting service beyond the confines of a veterans  
16 home.

17 **(9)** The department may develop a program to provide stipends to individuals  
18 to attend school and receive the necessary credentials to become employed at  
19 veterans homes. If the department develops a stipend program under this  
20 subsection, the department shall promulgate rules related to the program, including  
21 the application process, eligibility criteria, stipend amount, repayment provisions,  
22 and other provisions that the department determines are necessary to administer  
23 the program.

24 **(10)** The department may establish a hospital at the veterans homes. All  
25 hospitals established under this subsection may not have a total approved bed

1 capacity, as defined in s. 150.01 (4m), greater than 16 beds. The approved bed  
2 capacity of a skilled nursing facility operated at a veterans home is reduced by one  
3 bed for each approved bed at the hospital established under this subsection at that  
4 home.

5 **45.51 Eligibility for membership. (1) GENERAL STATEMENT.** Within the  
6 limitations of veterans homes, the department may admit to membership in veterans  
7 homes persons who meet the qualifications set forth in this section.

8 **(2) ELIGIBILITY.** (a) The following persons are eligible for benefits under this  
9 subchapter if they meet the applicable requirements of this subchapter:

10 1. A veteran.

11 2. A person who has served on active duty under honorable conditions in the  
12 U.S. armed forces or in forces incorporated as part of the U.S. armed forces for 90  
13 days or more and at least one day during a war period or under section 1 of executive  
14 order 10957, dated August 10, 1961.

15 3. A spouse, surviving spouse, or parent of a person under subd. 1. or 2.

16 (b) A person under par. (a) 1. or 2. may be admitted to a veterans home if the  
17 person meets all of the following conditions:

18 1. Is a resident of this state on the date of admission to a veterans home.

19 2. Is permanently incapacitated due to physical disability or age from any  
20 substantially gainful occupation.

21 3. Has not been convicted of a felony or of a crime involving moral turpitude  
22 or, if so, has produced sufficient evidence of subsequent good conduct and  
23 reformation of character as to be satisfactory to the department.

24 4. Provides a complete financial statement containing information that the  
25 department determines is necessary to evaluate the financial circumstances of the

**BILL**

1 person. The department may require a member of a veterans home to provide the  
2 department with information necessary for the department to determine the  
3 financial circumstances of the person. If a person fails to provide the additional  
4 information, the department may discharge the person from the veterans home.

5 5. Has care needs that the veterans home is able to provide within the resources  
6 allocated for the care of members of the veterans home, including chronic alcoholism,  
7 drug addition, psychosis, or active tuberculosis.

8 **(3) ADMISSION PRIORITIES.** (a) Except in cases where there is an immediate need  
9 for physical care or economic assistance, the department shall act on applications  
10 based upon the date of receipt of the application by the veterans home. The  
11 department may defer establishment of the priority date of the application to the  
12 date that the veterans home is able to verify its ability to provide appropriate care  
13 to the applicant or to assure that the appropriate care setting is available within the  
14 home.

15 (b) Spouses, surviving spouses, and parents derive their eligibility from the  
16 eligibility of the person under sub. (2) (a) 1. or 2. Surviving spouses and parents of  
17 eligible persons under sub. (2) (a) 1. or 2. are eligible for admission only to a skilled  
18 nursing facility at a veterans home.

19 (c) 1. The order of priority for admission to a veterans home shall be as follows:

20 a. Eligible persons under sub. (2) (a) 1. or 2. have 1st priority.

21 b. Spouses of eligible persons under sub. (2) (a) 1. or 2. have 2nd priority.

22 c. Surviving spouses of eligible persons under sub. (2) (a) 1. or 2. have 3rd  
23 priority for admission.

24 d. Parents of eligible persons under sub. (2) (a) 1. or 2. have 4th priority for  
25 admission.

1           2. The department may deviate from this sequence upon order of the board to  
2 prevent the separation of a husband and wife.

3           **(4) ADDITIONAL ELIGIBILITY REQUIREMENTS OF A SPOUSE OF A VETERAN.** A spouse  
4 of an eligible person under sub. (2) (a) 1. or 2. is eligible only if the spouse meets the  
5 requirements of sub. (2) (b) 3. to 5. and if all of the following apply:

6           (a) The person under sub. (2) (a) 1. or 2. is a member, or if not a member is  
7 institutionalized elsewhere because of physical or mental disability, and the spouse  
8 had lived with the person for not less than 6 months immediately before making  
9 application for membership.

10          (b) Separation from the spouse necessitated by reason of employment,  
11 hospitalization, or because of a physical or mental disability of either spouse shall  
12 not be taken to constitute an interruption of the 6-month period.

13          (c) A spouse of an eligible person under sub. (2) (a) 1. or 2. by virtue of a marriage  
14 that was void when entered into but validated under s. 765.21 before applying for  
15 admission shall, for the purpose of this subsection and sub. (6), be considered  
16 married to the eligible person under sub. (2) (a) 1. or 2. from the date the marriage  
17 was entered into.

18           **(5) ADDITIONAL ELIGIBILITY REQUIREMENTS OF A SURVIVING SPOUSE.** The surviving  
19 spouse of a person under sub. (2) (a) 1. or 2. who was a resident of this state at the  
20 time of the veteran's death is eligible if the surviving spouse meets the requirements  
21 of sub. (2) (b) 3. to 5. and if the surviving spouse satisfies all of the following  
22 conditions:

23           (a) 1. The surviving spouse satisfies any of the following conditions:

24           a. Was married to and living with the deceased person under sub. (2) (a) 1. or  
25 2. not less than 6 months immediately prior to the death of the person.

1           b. Was married to the person under sub. (2) (a) 1. or 2. at the time the person  
2 entered the service and who became a widow or widower by the death of the person  
3 while in the service or as a result of physical disability of the person incurred during  
4 the service.

5           c. The period during which the surviving spouse was married to and lived with  
6 the deceased person under sub. (2) (a) 1. or 2. plus the period of widowhood or  
7 widowerhood is 6 months or more.

8           d. Was married to and living with the person under sub. (2) (a) 1. or 2. less than  
9 6 months and a child was born of the marriage.

10          (b) Has not remarried.

11          (c) Is 45 years of age or over on the date of application.

12          (d) Is physically disabled.

13          (e) Is unable adequately to care for himself or herself and lacks adequate means  
14 of support.

15          (f) Has been a resident of this state for the 12 months immediately preceding  
16 the date of application for membership.

17          **(6) ADDITIONAL ELIGIBILITY REQUIREMENTS OF PARENTS.** The parent of a person  
18 under sub. (2) (a) 1. or 2. who was a resident of this state at the time of the person's  
19 death or, the parent of a living person under sub. (2) (a) 1. or 2. who is eligible for  
20 membership, is eligible if the parent meets the requirements of sub. (2) (b) 3. to 5.  
21 and if the parent satisfies all of the following conditions:

22          (a) Has reached 60 years of age.

23          (b) Has been a resident of this state for the 12-months preceding the date of  
24 application for membership.

1 (c) Is physically disabled, unable adequately to care for himself or herself, and  
2 lacks adequate means of support.

3 **(7) MEMBER INCOME RETENTION AND PAYMENT.** (a) The board shall establish a pay  
4 plan for compensation of members for services rendered to a veterans home under  
5 its work therapy program.

6 (b) Members shall pay the amount due the state for care and maintenance of  
7 the member within 30 days after the receipt of the veterans home's billing statement  
8 by the member or by the member's personal representative. The department may  
9 subject any bill not paid within 30 days after receipt of the billing statement to an  
10 interest assessment of 1 percent per month or fraction of a month. If payment is not  
11 made within 60 days after the receipt of the billing statement, the department may  
12 discharge the member from the veterans home.

13 (c) Payment of amounts due the state for care and maintenance of a member  
14 shall be made to the fullest extent possible from sources of income other than pension  
15 or compensation paid by the U.S. department of veterans affairs.

16 (d) A member is not required to use income received from services rendered to  
17 the veterans home under its work therapy program or from the sale of products or  
18 services through the hobby shop as payment for the care or maintenance of the  
19 member at the veterans home.

20 (e) The department shall supervise the operation of a veterans home exchange,  
21 including the operation of the hobby shop for the sale of products made by all  
22 members.

23 **(8) PERSONAL FUNDS OF MEMBER.** A member may, in writing, authorize a  
24 veterans home to receive, hold, and account for his or her personal funds. Section  
25 49.498 (8) applies to the funds of a member held by the veterans home under this

**BILL**

1 subsection. The department may transfer the personal funds of a member received  
2 under this subsection to the Wisconsin veterans facilities members fund under s.  
3 25.37. Upon request of the member, the department shall pay the member the  
4 amount the member requests from his or her personal account.

5 **(9) MEDICAL ASSISTANCE PAYMENTS.** All moneys received under medical  
6 assistance, as defined in s. 49.43 (8), for the care of members shall be transferred to  
7 the appropriation under s. 20.485 (1) (gk).

8 **(10) CONVEYANCE OF PROPERTY; DESCENT.** (a) Except as otherwise provided in  
9 this subsection, the application and admission of any applicant admitted under this  
10 section shall constitute a valid and binding contract between a member and the  
11 department. If a member dies leaving a relative that is entitled to an interest in the  
12 property of the member under the rules of intestate succession or a will the existence  
13 of which is made known to the commandant of the veterans home within 60 days of  
14 the member's death, the member's property shall constitute a part of the member's  
15 estate, except the commandant may distribute personal effects of nominal monetary  
16 value of a deceased member who is not survived by a member spouse to surviving  
17 relatives of the member who request the personal effects within a reasonable time  
18 after the member's death.

19 (b) The department may manage, sell, lease, or transfer property passing to the  
20 state pursuant to this section or conveyed to it by members, defend and prosecute all  
21 actions concerning it, pay all just claims against it, and do all other things necessary  
22 for the protection, preservation, and management of the property. All expenditures  
23 necessary for the execution of functions under this paragraph or sub. (14) shall be  
24 made from the appropriation in s. 20.485 (1) (h).

**BILL****SECTION 92**

1           (c) A person who at the time of death is a member of a veterans home is a  
2       resident of the county in which the veterans home is located for the probate of the  
3       person's will, issuance of letters testamentary or other letters authorizing the  
4       administration of the decedent's estate, and the administration of the estate.

5           **(11) DISPOSITION OF PROPERTY PASSING TO STATE.** If a member dies without a  
6       relative who is entitled to an interest in the property of the member under the rules  
7       of intestate succession and without leaving a will the existence of which is made  
8       known to the commandant of the home within 60 days of the member's death, the  
9       member's property shall be converted to cash, without administration. The  
10      commandant of a veterans home shall submit that converted sum to the secretary  
11      of administration to be paid into the appropriation under s. 20.485 (1) (h). The  
12      amount paid to the secretary of administration is subject to refund within 6 years to  
13      the estate of a member if it is subsequently discovered that the member left a will  
14      or a relative that is entitled to an interest in the property of the member under the  
15      rules of intestate succession or to any creditor of the member who establishes right  
16      to the funds or property or any portion of the funds or property. The department of  
17      administration, upon being satisfied that a claim out of the funds or property is legal  
18      and valid, shall pay the claim out of the funds or property, except that payment of  
19      claims for a member's funeral and burial expenses may not exceed a total of \$1,500  
20      including any amount allowed by the United States for the member's funeral and  
21      burial and the right for burial and interment provided in s. 45.61 (2).

22           **(12) POWERS OF COMMANDANT OVER PERSONAL FUNDS OF MEMBERS.** A commandant  
23      may receive, disburse, and account for funds of members.

24           **(13) ADDITIONAL ELIGIBILITY REQUIREMENTS FOR SKILLED NURSING FACILITIES.** Any  
25      person admitted to a skilled nursing facility at a veterans home shall meet the

1 eligibility requirements under ss. 49.45 and 49.46 and rules promulgated under  
2 those sections during residence at the skilled nursing facility except if any of the  
3 following apply:

4 (a) Persons with sufficient income and resources to meet the expenses of care  
5 for one or more months may be admitted to the skilled nursing facility but shall apply  
6 income and resources to costs to the extent required under ss. 49.45 and 49.46 and  
7 rules promulgated under those sections.

8 (b) Persons who meet all the requirements of this section but whose degree of  
9 physical disability does not meet the minimum requirements under ss. 49.45 and  
10 49.46 and rules promulgated under those sections may be admitted to the skilled  
11 nursing facility but shall apply income and resources to costs to the extent required  
12 by ss. 49.45 and 49.46 and rules promulgated under those sections.

13 **(14)** ADDITIONAL ELIGIBILITY REQUIREMENT FOR OTHER CARE FACILITIES AT VETERANS  
14 HOMES. An otherwise eligible person may be admitted to or remain in residency at  
15 a community-based residential facility, as defined in s. 50.01 (1g) or a residential  
16 care apartment complex, as defined in s. 50.01 (1d) at a veterans home only if the  
17 person has sufficient income and resources, and applies the income and resources to  
18 fully reimburse the department for the cost of providing care to the person.

**SUBCHAPTER VI****FUNERALS, BURIALS, AND CEMETERIES**

21 **45.60 Military funeral honors. (1) PROGRAM.** (a) The department shall  
22 administer a program to coordinate the provision of military funeral honors in this  
23 state to deceased veterans and to deceased persons who have served under honorable  
24 conditions in any national guard or in a reserve component of the U.S. armed forces.

**BILL****SECTION 92**

1           (b) Military funeral honors may be provided by local units of member  
2 organizations of the council on veterans programs, by local units of veterans  
3 organizations certified by the department to provide military funeral honors, by  
4 members of the Wisconsin national guard activated under s. 21.11 (3), or by staff of  
5 the department.

6           **(2) STIPENDS.** From the appropriation under s. 20.485 (2) (q), the department  
7 shall reimburse a local unit of a member organization of the council on veterans  
8 programs or a local unit of a veterans organization certified by the department to  
9 provide military funeral honors for the costs of providing military funeral honors in  
10 this state to a person described in sub. (1). The reimbursement may not exceed \$50  
11 for each funeral for which military honors are provided.

12           **(3) TUITION VOUCHER.** (a) The department shall create a tuition voucher form  
13 to be used by funeral directors under par. (b). The department shall distribute copies  
14 of the tuition voucher form, plus an explanation of the form's use, to every operator  
15 of a funeral establishment. The department may not charge a fee for the tuition  
16 voucher form or for the distribution of the form.

17           (b) A funeral director may issue a tuition voucher in the amount of \$25 to an  
18 individual who sounds "Taps" on a bugle, trumpet, or cornet during each funeral for  
19 which military honors are held in this state for a person described in sub. (1) and who  
20 is a student in grades 6 to 12 or at an institution of higher education, as defined under  
21 s. 895.515 (1) (b). The tuition voucher may be used at any time for the payment of  
22 tuition and required program activity fees at a University of Wisconsin System  
23 institution as provided under s. 36.27 (3r) or a technical college as provided under  
24 s. 38.24 (6). The department shall encourage private institutions of higher education  
25 to accept the vouchers. The vouchers are not transferable.

1           **45.61 Wisconsin veterans cemeteries. (1)** CONSTRUCTION AND OPERATION OF  
2 CEMETERIES. Subject to authorization under ss. 13.48 (10) and 20.924 (1), the  
3 department may construct and operate veterans cemeteries in central,  
4 northwestern, and southeastern Wisconsin and may employ any personnel that are  
5 necessary for the proper management of the cemeteries. The cemetery in central  
6 Wisconsin is the Central Wisconsin Veterans Memorial Cemetery. The cemetery in  
7 southeastern Wisconsin is the Southern Wisconsin Veterans Memorial Cemetery.  
8 The cemetery in northwestern Wisconsin is the Northern Wisconsin Veterans  
9 Memorial Cemetery. The department may acquire, by gift, purchase, or  
10 condemnation, lands necessary for the purposes of the cemeteries. Title to the  
11 properties shall be taken in the name of this state. Every deed of conveyance shall  
12 be immediately recorded in the office of the proper register of deeds and thereafter  
13 filed with the secretary of state. The department may accept for the state all gifts,  
14 grants, and bequests for the purposes of maintenance, restoration, preservation, and  
15 rehabilitation of the veterans cemeteries constructed under this subsection. All  
16 cemeteries operated by the department are exempt from the requirements of ss.  
17 157.061 to 157.70 and 440.90 to 440.95.

18           **(2) ELIGIBILITY.** The following persons are eligible for burial at a cemetery  
19 constructed and operated under sub. (1):

20           (a) A person who died while on active duty or who was discharged or released  
21 from active duty in the U.S. armed forces under honorable conditions and who was  
22 a resident of this state at the time of his or her entry or reentry into active service  
23 and his or her dependent child and surviving spouse.

**BILL****SECTION 92**

1 (b) A person who was discharged or released from active duty in the U.S. armed  
2 forces under honorable conditions and who was a resident of this state at the time  
3 of his or her death and his or her dependent child and surviving spouse.

4 (c) The spouse or dependent child of a person who meets one of the following  
5 conditions:

6 1. Is serving on active duty at the time of the spouse's or dependent child's death  
7 if the person was a resident of this state at the time of his or her entry or reentry into  
8 active service.

9 2. Was a resident of this state at the time of his or her entry or reentry into  
10 active service and was discharged or released from active duty in the U.S. armed  
11 forces under honorable conditions.

12 3. Was discharged or released from active duty in the U.S. armed forces under  
13 honorable conditions if the person and spouse or dependent child were residents of  
14 this state at the time of the spouse's or dependent child's death.

15 (d) A person who was a resident of this state at the time of his or her entry or  
16 reentry into service in any national guard or a reserve component of the U.S. armed  
17 forces or who was a resident of this state for at least 12 consecutive months  
18 immediately preceding his or her death, and the person's spouse, surviving spouse,  
19 and dependent children, if the person is eligible for burial in a national cemetery  
20 under 38 USC 2402.

21 (e) A person who was discharged or released from active duty in the U.S. armed  
22 forces under honorable conditions and who was a resident of this state for at least  
23 12 consecutive months after entering or reentering service on active duty.

24 **(3) FEES AND COSTS.** The department may charge a fee for burials under this  
25 section and may promulgate rules for the assessment of any fee. The cost of

1 preparing the grave and the erection of a marker for a person described under sub.  
2 (2) (a), (b), (d), or (e) shall be paid from the appropriation under s. 20.485 (1) (gk).

3 **(4) APPLICATION.** Application for burial shall be made to the department. The  
4 surviving spouse of the person described under sub. (2) (a), (b), (d), or (e), if that  
5 person is interred at the Central Wisconsin Veterans Memorial Cemetery, shall have  
6 the privilege of selecting a plot next to that person if available. The department shall  
7 hold the plot for the surviving spouse for a period of one year from the date of granting  
8 the privilege, but may extend the hold, on request, for additional one-year periods.

9 **(5) EXPENSES.** Expenses incident to the burial under this section shall be paid  
10 from the estate of the decedent, except that if there is no estate or the estate is  
11 insufficient, the expense of burial, or necessary part of the burial, shall be paid from  
12 the appropriation under s. 20.485 (1) (gk) for members of veterans homes, and the  
13 amount expended for those expenses shall not exceed the amount established for  
14 funeral and burial expenses under s. 49.785 (1) (b).

15 **45.62 Burial places compiled. (1)** The department may compile a record  
16 of veteran's burial places located within the state that may, so far as practicable,  
17 indicate all of the following information:

- 18 (a) The deceased veteran's name.
- 19 (b) The service in which the deceased veteran was engaged.
- 20 (c) The appropriate designation of the deceased veteran's armed forces unit.
- 21 (d) The deceased veteran's rank and period of service.
- 22 (e) The name and location of the cemetery or other place in which the deceased  
23 veteran's body is interred.
- 24 (f) The location of the deceased veteran's grave in the cemetery or other place  
25 of interment.

**BILL****SECTION 92**

1 (g) The character of the headstone or other marker, if any, at the deceased  
2 veteran's grave.

3 (2) The department may prepare blank forms for the transmission to the  
4 department of the information required for the record under sub. (1). The  
5 department may distribute the forms to county veterans service officers. A county  
6 veterans service officer within whose county any cemetery or other burial place is  
7 located in which deceased veteran's bodies are interred shall submit the facts  
8 required for the record under sub. (1) to the department on the forms provided by the  
9 department, if so requested by the department.

10 SUBCHAPTER VII

11 MEMORIALS

12 **45.70 Veterans memorials. (1) PERSIAN GULF MEMORIAL.** From the  
13 appropriation under s. 20.485 (2) (d), the department shall provide funding to the  
14 Wisconsin Vietnam Veterans Memorial Project, Inc., for the construction of a  
15 memorial for the veterans of the Persian Gulf War. The memorial shall be  
16 constructed at the veterans memorial site located at the Highground in Clark  
17 County. The department may expend up to \$60,000 for the memorial for the veterans  
18 of the Persian Gulf War.

19 (2) CAMP RANDALL MEMORIAL. (a) The board may approve, recommend, and veto  
20 any proposed plans, modifications, and changes or policies with respect to  
21 established state memorials, including the Camp Randall Memorial Park, Madison,  
22 Wisconsin, as described in par. (c), and any future veterans state memorials, and  
23 recommend the creation and establishment of veterans state memorials.

24 (b) No structures, other than memorials approved by the board, and no walks,  
25 roads, or subterranean footings may be placed or erected upon Camp Randall

1 Memorial Park unless authorized by the legislature; nor shall the park be used for  
2 any purpose other than a memorial park.

3 (c) Camp Randall Memorial Park, Madison, Wisconsin, is established and  
4 described as follows: beginning on the west line of Randall Avenue 96.6 feet north  
5 of the center line of Dayton Street extended; thence west at right angles to Randall  
6 Avenue 370 feet; thence south parallel to Randall Avenue 722 feet; thence west at  
7 right angles to Randall Avenue 235 feet; thence south parallel to Randall Avenue 205  
8 feet to the north line of Monroe Street; thence north 50 degrees 14 minutes east along  
9 the north line of Monroe Street approximately 780 feet to the west line of Randall  
10 Avenue; thence north along the west line of Randall Avenue 429 feet to the place of  
11 beginning.

12 **45.71 Catalog of memorials.** The department shall prepare a catalog of  
13 memorials, describing each memorial and giving its location and condition. The  
14 department shall periodically update that catalog.

15 **45.72 County and municipal memorials. (1)** In this section and s. 45.73,  
16 “local unit of government” means a city, village, town, or county.

17 **(2)** Any local unit of government may by gift, purchase, contract, or  
18 condemnation acquire property, real or personal, for the purpose of providing,  
19 furnishing, constructing, erecting, repairing, maintaining, or conducting a suitable  
20 memorial to the memory of former residents thereof who lost their lives in the  
21 military or naval service of the state or of the United States, or to commemorate and  
22 honor the deeds of persons, residents thereof, or of the state or United States, who  
23 served the nation in any war, or other persons who rendered great state or national  
24 service, or to the memory of any president of the United States, or for a combination  
25 of any those purposes, which are declared to be public purposes.

**BILL****SECTION 92**

1           **(3)** The local unit of government shall determine the character of the memorial,  
2 and without limitation because of enumeration, the memorial may comprise a public  
3 building, hospital, sanatorium, home for the aged or indigent, park, recreation  
4 facility, community forest, or other suitable object having a public purpose.

5           **(4)** Any local unit of government may appropriate money and may levy a tax  
6 to acquire, pay for, construct, erect, furnish, equip, operate, repair, maintain, or  
7 reconstruct a suitable memorial for the purpose or purposes provided in this section.

8           **(5)** Any local unit of government may authorize the use of any public property  
9 respectively of such city, village, town, or county as a site for a memorial, and any  
10 county may authorize its public property to be so used by any city, village, or town  
11 in the county.

12           **(6)** Any local unit of government may by ordinance or contract provide for the  
13 management, control, or operation of any memorial. The local unit of government  
14 may enter into a written lease, for a term not exceeding 25 years, with any duly  
15 chartered and incorporated veterans organization established in the local unit of  
16 government. The lease shall include the provisions for the amount of rental and such  
17 conditions of public use as the local unit determines.

18           **(7)** Any local unit of government may contract with or make an appropriation,  
19 or both, to any other local unit of government or to any nonprofit corporation without  
20 capital stock organized expressly for any of the purposes of this section or to any duly  
21 chartered and incorporated veterans organization established in the local unit of  
22 government, and for the purpose of raising funds for memorial purposes or  
23 contributions. The local unit of government may levy taxes upon the taxable  
24 property located in the local unit of government, or borrow money and issue bonds  
25 in the manner and under the regulations provided by ch. 67. The facilities of the

**BILL**

1 memorial shall be available to the residents of the local unit of government making  
2 the appropriation to the extent that the governing body of the local unit of  
3 government may require.

4 **45.73 Sites for veterans memorial halls. (1)** Any local unit of government  
5 may donate to any organization specified in s. 70.11 (9) land upon which is to be  
6 erected a memorial hall to contain the memorial tablet specified in s. 70.11 (9).

7 **(2)** The action of any local unit of government in granting veterans  
8 organizations or any other civic, patriotic, educational, or historical society rooms  
9 and space within public buildings for the establishment of memorial halls and  
10 museums, and occupancy thereof by its members, is authorized and confirmed. The  
11 local unit of government may permit the use and occupancy of the rooms and space  
12 for such terms and subject to such conditions and provisions as the local unit of  
13 government may impose. Any contract, lien, or agreement between the local unit of  
14 government and any organization now in force shall continue in force according to  
15 the terms of the contract, lien, or agreement.

16 **45.74 Memorial corporations organized under 1919 act. (1)** Any  
17 commission or board of trustees that governs a corporation organized to construct a  
18 memorial under s. 45.057 (5), statutes of 1919 to 1943 (created by chapter 598, laws  
19 of 1919, and repealed by chapter 301, laws of 1945), shall have the following powers  
20 in addition to those it now has:

21 (a) All powers vested in the members of the corporation by the articles of  
22 incorporation or bylaws, including the power to amend the articles of incorporation.

23 (b) The powers set forth in s. 181.0302 and all other applicable provisions of ch.  
24 181.

**BILL****SECTION 92**

1           (c) The power to convey any property under its control to any municipality and  
2           lease it back under terms agreed upon by the commission or board of trustees and  
3           the municipality.

4           (d) The power to dissolve the corporation and dispose of the real and personal  
5           property of the corporation in a manner that it deems will best serve the purposes  
6           for which it was organized and the interests of the community.

7           **(2)** The commission or board of trustees shall have a membership composed of  
8           5 residents of the city, village, or town in which the memorial is located, one  
9           appointed by the common council, village board, or town board of the city, village, or  
10          town, and 4 by the circuit judge of the county in which the memorial is located. The  
11          commission or board may appoint 4 additional members who are residents of this  
12          state. The terms of all members shall be 5 years. In order that terms of members  
13          may expire at different times, not more than 2 members shall be appointed in any  
14          one year in addition to appointments made to fill vacancies occurring by resignation  
15          or death. Members shall hold office until their successors are appointed and qualify.

16          **(3)** Notwithstanding the repeal of s. 45.057, 1943 stats., by chapter 301, laws  
17          of 1945, the continuing existence of all commissions, boards, and corporations  
18          organized under s. 45.057 (5), statutes of 1919 to 1943, is affirmed, and the  
19          continuing operation of such commissions, boards, and corporations is ratified as to  
20          the past and authorized in the future.

21          **45.75 Memorials in populous counties. (1)** Any county having a population  
22          of 500,000 or more may establish and maintain a memorial or memorials in the  
23          county under s. 45.72 by agreement between the county board of the county and any  
24          nonprofit private corporation without capital stock organized under the laws of this  
25          state, except as provided in this section, expressly for any of the purposes of s. 45.72.

**BILL**

1           **(2)** The board of directors of the corporation shall be designated as the  
2           “memorial board,” and its members shall be called “trustees.” The membership of  
3           the memorial board may include special members, who need not be members of the  
4           corporation.

5           **(3)** The memorial board shall consist of 15 members, of whom 8 may be special  
6           members to be elected as provided in this section, and the remaining members shall  
7           be elected from the membership of the corporation.

8           **(4)** Special members of the memorial board shall be elected by the county board  
9           of such county and consist of the following:

10           (a) Four members from the county board.

11           (b) Four members elected from among the residents of the county.

12           **(5)** Terms of members of the memorial board shall be as follows:

13           (a) For special members:

14           1. Members elected from the county board shall be elected at the first meeting  
15           of the county board following each county board general election and their terms  
16           shall commence on that date. They shall hold office during their terms on the county  
17           board and until their successors are elected and qualified.

18           2. Members elected from among the residents shall hold office for 4 years and  
19           until their successors are elected, except that the first 4 such members shall be  
20           chosen for 1, 2, 3, and 4 years, respectively.

21           3. Any vacancy in the special membership shall be filled by the county board  
22           for the unexpired term, and until a successor is elected and qualified.

23           (b) For elected members from the corporate membership: the terms of the  
24           trustees shall be for such numbers of years that those of an equal number, as nearly

1 as may be, shall expire in 2, 3, and 4 years, and successive terms of 4 years each  
2 thereafter and until their successors are elected and qualified.

3 **(6)** The articles of incorporation of the corporation shall provide originally or  
4 by amendment, in addition to other necessary provisions, and as permitted by this  
5 section, for the classification of the members of the corporation, for the election of  
6 trustees proportionately from and by those classifications, for the terms of the  
7 members of the corporation and for the officers, their duties, and the terms thereof  
8 to be elected from the membership.

9 **(7)** The war memorial may be constructed upon any land ceded before July 15,  
10 1953, by this state to any municipality in this state notwithstanding any restrictions,  
11 limitations, or conditions as to the nature of the use of any of the land contained in  
12 the legislative act, granting the land to the municipality, and notwithstanding the  
13 restrictions, limitations, or conditions incorporated in any subsequent conveyance  
14 of the lands by the municipality.

15 **(8)** The war memorial may be constructed in any public park and the use of  
16 those park lands as a location for a war memorial shall not be considered inconsistent  
17 with the use of the same for park purposes. No war memorial shall be constructed  
18 in a public park until the park commission, general manager appointed under s.  
19 27.03 (2), or park board having jurisdiction of the park shall approve the  
20 construction. The county board of any county may authorize the construction of a  
21 war memorial at different intervals of time if the proposed memorial consists of more  
22 than one building or structure and any county board subsequently elected shall carry  
23 into effect any contract authorized by s. 45.72 entered into on behalf of the county  
24 for the construction or maintenance of the war memorial. The construction,  
25 maintenance, and operation of a war memorial in a county park shall be subject to

1 the jurisdiction of the county board and no part of those costs shall be charged against  
2 the funds of the park commission, park system, or park board of the county.

**SUBCHAPTER VIII****LOCAL RESPONSIBILITIES**

5 **45.80 County veterans service officer. (1)** ELECTION OR APPOINTMENT. (a)  
6 Except as provided under par. (b), the county board shall elect a county veterans  
7 service officer who shall be a Wisconsin resident who served on active duty under  
8 honorable conditions in the U.S. armed forces or in forces incorporated as part of the  
9 U.S. armed forces and who meets at least one of the conditions listed in s. 45.01 (12)  
10 (a) to (d) and at least one of the conditions listed in s. 45.02 (2).

11 (b) Except as provided under par. (c), the county board may appoint assistant  
12 county veterans service officers who shall be Wisconsin residents who served on  
13 active duty under honorable conditions in the U.S. armed forces or in forces  
14 incorporated as part of the U.S. armed forces and who meet at least one of the  
15 conditions listed in s. 45.01 (12) (a) to (d) and at least one of the conditions listed in  
16 s. 45.02 (2).

17 (c) In counties with a county executive or county administrator, the county  
18 executive or county administrator shall appoint and supervise a county veterans  
19 service officer who shall have the qualifications prescribed under par. (a). The  
20 appointment is subject to confirmation by the county board unless the county board,  
21 by ordinance, elects to waive confirmation or unless the appointment is made under  
22 a civil service system competitive examination procedure established under s. 59.52  
23 (8) or ch. 63.

**BILL****SECTION 92**

1           **(2) TERM.** A county veterans service officer elected under sub. (1) (a) shall serve  
2 until the first Monday in January of the 2nd year subsequent to the year of his or her  
3 election, and, if reelected, shall continue to serve unless removed under s. 17.10 (2).

4           **(3) SALARY.** The salary of the county veterans service officer shall be fixed by  
5 the county board prior to or at the time of the service officer's election and annually  
6 thereafter.

7           **(4) MILWAUKEE COUNTY.** In counties having a population of 500,000 or more the  
8 officer shall be appointed subject to ss. 63.01 to 63.17.

9           **(5) DUTIES.** The county veterans service officer shall do all of the following:

10           (a) Advise persons living in the service officer's county who served in the U.S.  
11 armed forces regarding any benefits to which they may be entitled or any complaint  
12 or problem arising out of such service and render to them and their dependents all  
13 possible assistance.

14           (b) Make such reports to the county board as the county board requires.

15           (c) Cooperate with federal and state agencies that serve or grant aids or  
16 benefits to former military personnel and their dependents.

17           (d) Furnish information about veterans burial places within the county as  
18 required by s. 45.62 (2).

19           (e) Perform the duties prescribed by law, including those duties under pars. (a)  
20 to (d), separately and distinctly from any other county department.

21           **(6) PERMITTED ACTIVITIES.** The county veterans service officer may do any of the  
22 following:

23           (a) Inform persons living in the service officer's county who are members of the  
24 national guard or of a reserve unit of the U.S. armed forces or dependents of those  
25 persons regarding potential benefits to which they may be or may become entitled

1 and regarding all necessary military points of contact and general deployment  
2 information for activated and deployed members of the national guard or reserve
