Whereas: in which four states – California, Washington, Michigan and Texas have banned the use of affirmative action by voter referendums, court decisions and/or state statute.

Therefore be it resolved: that the students of UWSP strongly oppose the drafting of any such legislation(s) that will ban affirmative action in WI,

Therefore, further be it resolved: the students request that the Multicultural Issues Director be aware of any developments on the issue & to keep students and administration abreast of such news,

Be it finally resolved: upon passage, the Multicultural Issues Director will send this resolution to the Chancellor, Faculty Senate and any other appropriate administrative body deemed necessary.
