What is a Charter School?

- Charter School: A charter school is a tuition-free public school created on the basis of a contract or “charter” between the school and a local school board or other authorizer. A charter school has more freedom than a traditional public school in return for a commitment to meet higher standards of accountability. (NACSA, 2006)
- The "charter" establishing each school is a performance contract detailing the school's mission, program, goals, students served, methods of assessment, and ways to measure success. (US Charter Schools - website)

Charter School Accountability

- Charter schools are accountable to their authorizer to produce positive academic results and to adhere to the charter contract.
- The basic concept of charter schools is increased autonomy in return for accountability.

Charter School Accountability

- They are accountable for both academic results and fiscal practices to several groups:
 - the authorizer that grants them,
 - the parents who choose them,
 - and the public that funds them.

Federal Definition of a Charter School

- In order to be eligible for Federal Charter School funds, charter schools must meet the definition in Sec. 5210(1) of ESEA, Part B – Charter Schools.

Lottery & Admissions

- A charter school is a school to which parents choose to send their children, and that admits students on the basis of a lottery, if more students apply for admission than can be accommodated.

Available Wisconsin Grants

Start up Funds:

A 3-year continuous relationship

- Planning Grant (12-18 months)
- Implementation Grant Year 1 (12 months)
- Implementation Grant Year 2 (6-12 months)

Continuous Relationship

- The length of time that an applicant can be in a financial relationship with the DPI is determined by federal law.
- For example, if the charter school cannot open by the second semester of the 2007-08 school year, applicants should not request planning funds in 2006, as the “*continuous 3-year relationship*” will be broken and therefore their right to future federal charter school funds would be forfeited.

Planning Grant– Allowable Expenses

- Professional development of teachers or other staff
- Orientation and training of planning team members
- Consultation fees
- Extended teacher contracts – for the purposes of planning

Planning expenses (continued)

- Acquiring necessary educational materials for staff development
- Related costs for charter school site visits including reasonable mileage, meals and lodging
- Salaries for substitutes to cover teachers while conducting planning activities

Planning – Expenses Not Allowed

Any operational costs such as:

- Rent or Facility Leases
- Construction
- Purchase of vehicles
- No salary for grant writer, coordinator, lawyer, accountant, or counselors
- No honorariums for community or planning team members or students

Implementation Grant

Allowable expenses

- Staff development and training
- Computers/equipment, desks, chairs, tables, lockers
- Curriculum materials, books
- Reasonable travel expenses for conferences

Implementation-Allowable expenses

- Refrigerator/stove for food service
- Minor renovations to bring facility up to health and safety codes
- Extended contracts for curriculum writing/program development

Implementation Grants

Expenses Not Allowed

Any operational costs such as:

- Salaries
- Rent or Leases
- Field Trips
- Construction
- Purchase of vehicles, boats, trailers
- Roof repairs, boilers
- Fees for accounting, administration or grant writing

Dissemination Grant Program



Eligibility

- The charter school must have been in operation for at least 3 consecutive years.
- The school must demonstrate overall success including substantial progress in improving student achievement.

Eligibility

- The school must document high levels of parental satisfaction.
- The school must describe the management and the leadership necessary to overcome initial start-up problems.

Dissemination Grant Guidelines

- Awarded on a single grant basis for twenty-four months duration.
- May be for a single charter school, or consortia of two or more charter schools.

Dissemination Grant Guidelines

- Funds are to be used exclusively to provide a service and/or for the development and dissemination of a product designed to improve student performance in other public schools, including charter schools.
- Sub-grants are not to be used towards the operation of the charter school.
