RE: Year Round ATV Access to State Trails

Dear Senator Breske:

You have probably been getting lots of mail regarding what kinds of uses should be allowed on bike trails. Thought we would put in our two cents worth too. We do a lot of bicycling on the trails and have found that it is very difficult to enjoy it when other uses are allowed on them for several common sense reasons.

First, while we love horses and have ridden them ourselves, it is not possible to safely ride on a trail that has divots and depressions from horse hoofs. It is also not very pleasant to ride through horse manure that has become greasy after wet weather.

Second, motorized vehicles should not be permitted on bicycle trails period. It is not possible to enjoy the peace and quiet of a bike ride while listening to noisy engines. It is not possible to breath fresh air while inhaling oily exhaust fumes especially if you are riding hard or up a hill and breathing deeply. And finally, it is just plain dangerous. Maybe some day someone will offer a quiet electric ATV that has a governor on it with a top speed equal to the top speed of a bicycle. That would be fine. Until then, pedestrians have the right of way

over bicycles. Bicycles have the right of way over ATVs. Unfortunately there are enough ATV riders who think they own the trail that they can roar past a bike rider two inches away or crawl up on a bike rider while impatiently waiting for him to get up a long incline.

We have nearly been killed on several occasions in the middle of nowhere by such people and wished they were required to wear nice big tags like hunters so we could report their license numbers. We would like to see such a requirement for ATVs (and snowmobiles too for that matter). We think this is one situation where you just cannot because the competing uses are simply incompatible. That is why we have lakes and zones on lakes in Wisconsin that are designated as no-motor, or electric motor only, or no-wake — because such uses are incompatible with fishing, canoeing and sailing. Bike trails are bike trails for the same reason.

Good luck with this one. We hope you will work to keep bike trails for bikes. Thanks for listening. Good luck trying to make everyone happy! :):)

Dear Senator Breske,

I sent the following letter to the Fond du Lac County Board members before they voted on whether or not to allow ATVs on the Eisenbahn Trail in the winter. On December 19, they voted against their use, 26 to 9.

Note: one committee member of 5 changed his mind after recommending ATVs on the trail at the December 6 meeting. He voted NO to ATVs December 19.

Dear County Board Member,

I was very unhappy with the December 6 meeting of the Parks and Development Committee. Not one member on the Committee voted against ATVs on the Eisenbahn Trail during the winter. Not one member did the right thing. Not one member stood up for the overwhelming majority of trail users. Not one member realizes or admitted the inherently destructive nature of ATVs. Not one member defended a brand new trail- a trail not designed or intended for motorized use. The Committee's recommendation was wrong.

The Committee Chairman was wrong. Just because "ATVs are a growing industry" (as he said) doesn't mean we should encourage this activity which by its very nature is unsafe and destructive to our resources. June 23, 2006, a presentation before the Natural Resources Board called "ATVs in Wisconsin" concluded that "the economic impact report on ATV riding did not take into account the true cost of law enforcement, environmental damage, nuisance and other undesirable aspects.

When balanced with these costs it is doubtful that the economic impact of ATV riding in Wisconsin is a net gain."

How can ATVs be allowed on a limestone trail and a brand new one at that?

Have you personally ever seen the destruction ATVs do to the ground? I have.

Did you read the December 8 article in the Reporter about the increasing problems over the past few years Dodge County (Goose Trail) is having from ATVs causing damage and creating hazards with more and more tire ruts from purposely spinning tires and digging into the trails? THIS DAMAGE IS OCCURRING DURING THE WINTER SEASON. AGAIN: TRAIL DAMAGE FROM ATVS IS INCREASING ON THE GOOSE TRAIL IN DODGE COUNTY AND IT IS DURING THE WINTER.

Why would the County Board want to recreate these problems here in Fond du Lac County by approving ATV use on the Eisenbahn in the winter? Isn't it wiser to preserve and protect the integrity of the trail rather than repair it from the inevitable damage?

It is your duty to keep our wonderful trails safe and free from abuse. Motorized vehicles will destroy them even in the winter- look at Dodge County.

Just go to Google, type in "ATV damage to trails" and you will see all the damage ATVs are doing across the country. They are becoming the greatest threat to our nation's natural areas.

In some places the problem has become a crisis. At the meeting I was disturbed by the ATV users. I sat behind a group of them, including the 2 men from the ATV club who spoke at the beginning of the meeting. The group snickered and laughed every time a citizen spoke about ATV damage he/she had witnessed. They just didn't care. I found their laughing very revealing.

Our natural world is quickly disappearing. Please do not contribute to this.

The vast majority of trail users (walkers, joggers, runners, pet walkers, wildlife viewers, horse riders, bikers, skiers, families...) does not support ATVs on our trails in any season of the year.

Dear Ms. Piliouras:

I have read the proposed agenda for the January 4, 2007 meeting regarding proposed changes in funding and legislation for ATV and trails. Like many who commented on earlier agendas for the Special Committee on State Trails, I too am concerned about the appropriation of funds from ATV users not earmarked for repair of the damage caused by ATVs on public trails and private property. I am also concerned that the proposals do not adequately address the needs of other trail users on multi-use trails. While the funding from other users, such as bicycles, walkers and hikers is much lower, the impacts are much, much lower. The focus on ATV funding used for expansion of trails for ATVs is not appropriate until greater attention is made to the existing damage the ATVs are causing to public and private lands.

The proposed text as described in the 12/20/06 bill draft regarding ATV damage reimbursement is insufficient with regard to the amount of current damage that has been caused and creates too many barriers to reimbursement. For example, under the draft text:

"The department may pay a claim under this subsection only if the damage to the property was caused by the operation of all-terrain vehicles in an area not designated as an all-terrain vehicle route or all-terrain vehicle trail, the applicant has made reasonable efforts to identify the responsible individual and obtain payment from the individual, and the applicant has made reasonable efforts to prevent reoccurrence."

I'm concerned that damage to all-terrain vehicle routes and trails, especially multi-use trails, will be inadequately funded because of the above-referenced exclusion. The high susceptibility of limestone-screened trails, in particular, to damage from ATVs and my observation that insufficient repair work is currently being done in Wisconsin to these trails makes me question if the funding mechanism should be strengthened in the draft bill. I respectfully request that all ATV funds are used to repair existing ATV damage prior to their use to expand trails.

Thank you for considering my comments.

I am writing to you regarding the continuing efforts of the ATV lobby to increase funding for ATV trails in Wisconsin. I ask that you forward my comments to other members of your committee.

The expansion of the trail system for motor vehicles is not good public policy. Motor vehicles drive non-motor vehicle users from trails not only because the vehicles pose a danger to hikers and others, but also because the noise, pollution and erosion that result from motor vehicle use make the experience for hikers and others unacceptable. At a time when health care costs are out of control, we should be encouraging healthful activities such as hiking and walking. More use by ATVs will discourage these healthful activities.

In addition to the negative effect on healthful outdoor activities, ATV use increases trail maintenance cost because of the serious erosion they cause. At a time when government is struggling to finance state parks and other public facilities for recreation, encouraging ATV use makes no sense.
