#### PART I

### KEY PROVISIONS OF COMMITTEE RECOMMENDATIONS

The Joint Legislative Council recommends the following bills for introduction in the 2009-10 Session of the Legislature.

[Note: These bills have been introduced in both houses as companion legislation. For clarity, this report refers to them in the singular form as "the bill."]

# 2009 Senate Bill 568 and 2009 Assembly Bill 822, Relating to Extended Juvenile Court Jurisdiction for Certain Foster Youth Under the Age of 21 Years

The bill, relating to extended juvenile court jurisdiction for certain foster youth under the age of 21 years, permits certain foster youth who are in foster care when they reach the age of 18 years to request an agency to petition the court assigned to exercise jurisdiction under the Children's Code and the Juvenile Justice Code (juvenile court) to extend juvenile court jurisdiction until the foster youth reaches 21 years of age.

### 2009 Senate Bill 569 and 2009 Assembly Bill 823, Relating to Training for Foster Parents

The bill, relating to training for foster parents:

- Requires foster parent training to be completed before the first child is placed with a foster parent and on an ongoing basis.
- Requires foster parent training to be available to kinship care relatives.
- Specifies topics that must be covered in the training.

# 2009 Senate Bill 570 and 2009 Assembly Bill 824, Relating to Creating Expectations for Foster Children and Foster Parents and Requiring the Exercise of Rule-Making Authority

The bill, relating to creating expectations for foster children and foster parents and requiring the exercise of rule-making authority, requires the Department of Children and Families (DCF) to create expectations for foster children and foster parents by rule. The bill provides that a written copy of the expectations must be given to each foster child and foster parent and must be explained orally.

## 2009 Senate Bill 571 and 2009 Assembly Bill 825, Relating to Creating a Family Policy Board and Requiring Counties to Provide Prevention Resources

The bill, relating to creating a family policy board and requiring counties to provide prevention resources, renames the Child Abuse and Neglect Prevention Board as the Family Policy Board and expands its membership. The bill sets forth the duties and responsibilities of the Family Policy Board.

### PART II COMMITTEE ACTIVITY

#### **Assignment**

The Special Committee on Strengthening Wisconsin Families is a statutory committee created by 2005 Wisconsin Act 467. The committee will be in existence until its sunset date of December 31, 2010. During its existence, the committee is charged with studying the following:

- Ways to increase awareness of the importance of families in society and resolving social issues.
- The establishment of a state council to improve coordination among state agencies of programs that affect families; to set priorities for state agencies based on community and family needs; to consolidate funding for programs and services that affect families; and to encourage local communities to form local collaborative entities to coordinate, decrease duplication of, and streamline the delivery of services provided by public and private entities to families, children, and youth.
- Ways to target public moneys for family services and not individuals.
- Existing laws relating to strengthening families.
- Ways in which the results from the scientific study of attachment and brain development can be incorporated into public schools, day care centers, and homes.
- Child support and custody issues involving fathers, for the purpose of ensuring that fathers are appropriately engaged in the lives of their children.
- Changes to state agency rules, policies, guidelines, and procedures to strengthen families, reduce reliance on social service professionals for family support, and maximize community support for families.
- Identification of qualities held by successful Wisconsin families and recommendation of legislation to support those qualities.
- Changes to the state tax code to strengthen families and provide incentives to engage in family-supporting activities and services.
- Proposed legislation to create a reconciliation council that would seek to bridge cultural and religious differences among different cultural and religious groups.
- Identification of support of private sector initiatives to strengthen families.
- Ways in which local government services can be performed by volunteer groups of individuals and ways in which saved moneys currently spent for these services by local governments can be allocated to the volunteer groups.
- Health care.

The Joint Legislative Council established the Special Committee on Strengthening Wisconsin Families for 2008-10 and appointed the Co-Chairpersons by an April 9, 2008 mail ballot. For 2008-10, the committee was directed to develop recommendations to advise the new DCF on the administration of programs administered by the new department, to promote the integration of family services formerly administered by multiple departments.

Membership of the 2008-10 Special Committee, appointed by June 9, 2008 and January 8, 2009 mail ballots, consisted of two Senators, two Representatives, and 11 public members. A list of committee members is included as *Appendix 3* to this report.

#### **Summary of Meetings**

As of the date of this report, the Special Committee has held 11 meetings in Madison. The first eight meetings are summarized in RL 2009-05, *Special Committee on Strengthening Wisconsin Families* (July 27, 2009). The last three meetings were held on the following dates:

April 2, 2009 July 15, 2009 August 13, 2009

At the <u>April 2, 2009 meeting</u>, the committee discussed WLC: 0416/1, relating to creating bills of rights for foster children and foster parents; WLC: 0417/1, relating to training for foster parents; and WLC: 0424/P1, relating to extended court jurisdiction for certain foster youth under the age of 21 years.

The committee also heard testimony from Paul Stuiber, Deputy State Auditor for Program Evaluation, and Dean Swenson, Program Evaluation Director, Legislative Audit Bureau (LAB), relating to legislative audits regarding the child welfare system.

John Tuohy, Deputy Administrator, DCF, discussed the drafts before the committee and DCF's response to the LAB audits.

The committee also held a public hearing on issues related to the child welfare system in Milwaukee County, foster care, and training for foster parents. The testimony from the public hearing included testimony on the following issues:

- Bills of rights for foster children and foster parents.
- Training for foster parents, including the training provided by the Milwaukee Child Welfare Partnership for Professional Development.
- Training for foster children.
- Extending foster care to age 21.
- Stabilizing education for foster children, including coordination and collaboration between the child welfare system and the school system.
- Other models of education for children, including boarding schools.
- Requiring experience as a foster parent before becoming a treatment foster parent.
- Recognition of siblings as relative caregivers.
- Employment of foster children, including summer employment.
- Personal experiences with the child welfare system in Milwaukee County.

At the <u>July 15, 2009 meeting</u>, the committee received an update from DCF. Dick Schlimm, Child Abuse and Neglect Prevention Board, discussed the board's concerns regarding a bill draft to create a family policy board.

The committee discussed WLC: 0434/1, relating to training for child welfare case workers, and WLC: 0346/3, relating to creating a family policy board and requiring counties to provide prevention resources.

At the August 13, 2009 meeting, the committee received an update from DCF.

The committee discussed WLC: 0346/3, relating to creating a family policy board and requiring counties to provide prevention resources; WLC: 0416/2, relating to creating bills of rights for foster children and foster parents; 0417/3, relating to training for foster parents; and WLC: 0424/1, relating to extended court jurisdiction for certain foster youth under the age of 21 years. There was consensus to make changes to the drafts and to include them in a mail ballot for committee members.

#### PART III

### RECOMMENDATIONS INTRODUCED BY THE JOINT LEGISLATIVE COUNCIL

This part of the report provides background information on, and a description of, the bills as recommended by the Special Committee on Strengthening Wisconsin Families and introduced by the Joint Legislative Council.

# 2009 Senate Bill 568 and 2009 Assembly Bill 822, Relating to Extended Juvenile Court Jurisdiction for Certain Foster Youth Under the Age of 21 Years

#### **Background**

Under current law, a juvenile court order placing a child in foster care terminates when the child reaches 18 years of age.

The committee received testimony from former foster youth and from professionals who work with foster youth that extending foster care for young adults leaving the foster care system would be very beneficial to youth who chose to exercise that option.

#### **Description**

The bill permits certain foster youth who are in foster care when they reach the age of 18 years to request an agency to petition the juvenile court to extend juvenile court jurisdiction until the foster youth reaches 21 years of age.

The bill defines a foster youth as a person who is a resident of this state, is under 21 years of age, and reached the age of 18 while placed in a foster home or other out-of-home placement under a juvenile court order.

Under the bill, a foster youth may submit a request for extended juvenile court jurisdiction to the agency primarily responsible for providing services under the foster youth's dispositional order. If the agency determines that the foster youth may be eligible for extended court jurisdiction, the agency must petition the juvenile court to extend jurisdiction. The juvenile court may extend jurisdiction if the juvenile court finds that one of several conditions are met, such as that the youth is completing secondary education, is enrolled in a postsecondary institution, or is employed for at least 80 hours per month. The order for extended juvenile court jurisdiction terminates when the foster youth reaches 21 years of age or when the juvenile court finds that specified conditions are met.

The bill has an effective date of October 1, 2010.

### 2009 Senate Bill 569 and 2009 Assembly Bill 823, Relating to Training for Foster Parents

#### **Background**

2009 Wisconsin Act 28, the Biennial Budget Act, requires that all foster parents complete training in the care and support needs of foster children. DCF is required to monitor compliance with the training requirements and promulgate rules prescribing the training.

The committee received testimony from former foster youth regarding the need for training of foster parents. Committee members discussed the specific topics that the training should include and the need for training to be ongoing.

#### Description

The bill requires foster parent training to be completed before the first child is placed with a foster parent and on an ongoing basis. The training must be available to kinship care relatives. In addition, the training must include training in parenting skills; teaching and encouraging independent living skills; issues that may confront foster parents; child abuse and neglect prevention; the proper use of foster care payments; the availability of resources for foster parents in the local community; and other topics, as determined by DCF.

# 2009 Senate Bill 570 and 2009 Assembly Bill 824, Relating to Creating Expectations for Foster Children and Foster Parents and Requiring the Exercise of Rule-Making Authority

#### **Background**

The committee received testimony from former foster youth that they would like child welfare professionals and foster parents to recognize certain rights of foster children. Committee members concluded that foster parents should also have their expectations of the child welfare system set forth in the statute.

#### **Description**

The bill requires DCF to create expectations for foster children and foster parents by rule. Under the bill, a foster child or foster parent must receive a written copy of the applicable expectations in his or her primary language, if possible. The expectations must also be explained orally using language or means that ensure that the child or foster parent understands the meaning of the expectations. For a foster child, the oral explanation must also use language or means that are appropriate to the child's age and developmental level. The copy of the expectations given to a foster child or foster parent or materials accompanying the copy of the expectations must include relevant community-specific contact information and other information.

# 2009 Senate Bill 571 and 2009 Assembly Bill 825, Relating to Creating a Family Policy Board and Requiring Counties to Provide Prevention Resources

#### Background

Under current law, the Child Abuse and Neglect Prevention Board is responsible for administering grants and other efforts for preventing child abuse and neglect.

Committee members discussed the merits of having a board with broader representation and with the broader mission of encouraging state and local coordination and collaboration to promote thriving families.

#### Description

This bill renames the Child Abuse and Neglect Prevention Board as the Family Policy Board and expands its membership and duties. Under the bill, the board is chaired by the governor or lieutenant governor.

The board is required to promote the coordination of resources for families in order to achieve several goals, including children who are healthy and ready for school and families that are economically self-sufficient and in which children are safe. The board must also establish a policy for the state agencies with membership on the board that highest priority should be given to promoting thriving families and healthy children through the provision of comprehensive, integrated resources based on community and family needs. The board is also required to make recommendations to the governor and the legislature relating to changes needed in state programs, policies, and funding levels to improve the coordination of programs that affect families; to set priorities for state agencies based on community and family needs; to consolidate funding; and to encourage communities to form local collaborative entities consisting of public and private providers to coordinate the provision of resources. The board is required to submit a report of its recommendations to the appropriate legislative standing committees and the governor by September 1 of each even-numbered year. Finally, the board must establish a system of communication between the board and local collaborative entities in order to more effectively provide resources for families, and identify requirements for counties to report to state agencies with membership on the board and instances in which those reporting requirements could be consolidated or eliminated.

The bill also requires DCF to assist counties in developing programs, policies, and resources that prevent delinquency, child abuse and neglect, mental illness, alcohol or other drug dependency, developmental disability, mental infirmity, and other forms of mental or social maladjustment (prevention resources). In addition, the bill requires counties to provide, either directly or through community agencies and within limits of available funding, prevention resources.

#### Appendix 1

#### **Committee and Joint Legislative Council Votes**

Grigsby; and Public Members Erdmann and Montgomery); and Not Voting, 2 (Public Members Fields and Ray).
- WLC: 0416/3 [LRB-3560/1], relating to creating expectations for foster children and foster
  parents and rule-making, passed by a vote of Ayes, 13 (Sens. Taylor and Schultz; Rep.
  Kestell and Grigsby; and Public Members Albers, Angeli, Burgess, Erdmann, Howard,
  Montgomery, Rosenberg, Tittl, and Westman); Noes, 0; and Not Voting, 2 (Public Members
  Fields and Ray).
- WLC: 0417/4 [LRB-3559/1], relating to training for foster parents, passed by a vote of Ayes, 13 (Sens. Taylor and Schultz; Reps. Kestell and Grigsby; and Public Members Albers, Angeli, Burgess, Erdmann, Howard, Montgomery, Rosenberg, Tittl, and Westman); Noes, 0; and Not Voting, 2 (Public Members Fields and Ray).
- WLC: 0424/2 [LRB-3558/1], relating to extended court jurisdiction for certain foster youth under the age of 21 years, passed by a vote of Ayes, 13 (Sens. Taylor and Schultz; Reps. Kestell and Grigsby; and Public Members Albers, Angeli, Burgess, Erdmann, Howard, Montgomery, Rosenberg, Tittl, and Westman); Noes, 0; and Not Voting, 2 (Public Members Fields and Ray).

#### **Joint Legislative Council Vote**

At its February 24, 2010 meeting, the Joint Legislative Council voted as follows on the recommendations of the Special Committee:

Co-Chair Schneider moved, seconded by Sen. Schultz, that the following three drafts recommended by the Special Committee on Strengthening Wisconsin Families, be introduced en masse:

- 1. LRB-3558/1, relating to extended juvenile court jurisdiction for certain foster youth under the age of 21 years.
- 2. LRB-3559/1, relating to training for foster parents.

3. LRB-3560/1, relating to creating expectations for foster children and foster parents and requiring the exercise of rule-making authority.

The motion passed on a roll call vote as follows: Ayes, 21 (Sens. Risser, Darling, Decker, Fitzgerald, Harsdorf, Kreitlow, Miller, Robson, Schultz, and Wirch; and Reps. Schneider, Ballweg, Berceau, Black, Fitzgerald, Kaufert, Nelson, Pocan, Sheridan, Staskunas, and Vos); Noes, 0; and Absent, 1 (Sen. Coggs).

Co-Chair Schneider moved, seconded by Rep. Berceau, that LRB-3561/1, relating to creating a family policy board and requiring counties to provide prevention resources, be introduced by the Joint Legislative Council. The motion passed on a roll call vote of Ayes, 14 (Sens. Risser, Decker, Fitzgerald, Kreitlow, Miller, Robson, Schultz, and Wirch; and Reps. Schneider, Berceau, Nelson, Pocan, Sheridan, and Staskunas); Noes, 6 (Sens. Darling and Harsdorf; and Reps. Ballweg, Fitzgerald, Kaufert, and Vos); and Absent, 2 (Sen. Coggs and Rep. Black).
