AMENDMENT 3

JOINT LEGISLATIVE COUNCIL PREFATORY NOTE: This amendment to WLC: 0038/3, relating to the establishment of the Wisconsin Health Exchange Authority, was prepared for the Joint Legislative Council's Special Committee on Health Care Reform Implementation.

The amendment creates a board for the Wisconsin Health Exchange Authority to be composed of 9 members without vested interest in health care or insurance, including 1 member representing labor organizations, 1 member representing business interests, 1 member representing self-employed individuals' interests, 2 members representing consumer group interests, 3 exchange participants, and 1 member at-large. The board members shall be appointed based on expertise in their fields.

The board shall be assisted in the design, establishment, and operation of the exchange by a 9-member standing advisory committee. The named associations shall submit 3 nominations to the governor for one advisory committee position. Nominations are to be made collectively if more than one statewide association represents a particular interest group. When choosing a nominee, the governor shall make the selection based upon the nominee's skills and expertise.

10	or a staff member of the exchange, may not be employed by, a consultant to, a member of the
11	board of directors of, affiliated with, or otherwise a representative of, a carrier or other insurer,
12	an agent or broker, a health care provider, or a health care facility or health clinic while serving
13	on the board or on the staff of the health care exchange. A voting member of the board, or a
14	staff member of the health care exchange, may not be a member, a board member, or an
15	employee of a trade association of carriers, health facilities, health clinics, or health care
16	provider while serving on the board or on the staff of the health care exchange. A member
17	of the board, or a staff member of the exchange, may not be a health care provider unless he
18	or she receives no compensation for rendering services as a health care provider and does not
19	have an ownership interest in a professional health care practice.".

2	nominations for their representative on the advisory committee to the governor. The advisory
3	committee members shall then be nominated by the governor from the named organizations'
4	lists of submitted nominees, based on the person's skills and expertise in his or her field, and
5	with the advice and consent of the senate appointed, for staggered 4-year terms:
6	1. One member representing the American Federation of Labor and Congress of
7	Industrial Organizations.
8	2. One member representing the Wisconsin Manufacturers and Commerce.
9	3. One member representing the Wisconsin Federation of Independent Business.
10	4. One member representing the Wisconsin Farm Bureau and Farmer's Union,
11	collectively.
12	5. One member representing at least 2 but no more than 5 consumer organizations
13	including AARP, Disability Rights Wisconsin, and a health care cooperative, collectively.
14	6. One member representing the Wisconsin Association of Health Plans and any other
15	statewide insurance organizations, collectively.
16	7. One member representing the Wisconsin Hospital Association.
17	8. One member representing the Wisconsin Medical Society.
18	9. One member representing the Wisconsin Federation of Nurses and Health
19	Professionals, Wisconsin Nursing Association, and the SEIU Nurse Alliance of Wisconsin,
20	collectively.".
