#### Call to Order and Roll Call

Chair Ballweg called the committee to order. The roll was called and a quorum was present.

### **Opening Remarks**

Chair Ballweg welcomed the committee members. Terry Anderson, Director of the Legislative Council staff, thanked the committee members for their participation, gave opening remarks, and described the Joint Legislative Council and the committee process.

#### **Introduction of Committee Members**

Chair Ballweg described the organization of and the procedures for the committee and invited remarks from Senator Jauch, Vice Chair, Senator Moulton, who appeared via telephone, and Representative Vruwink. Chair Ballweg then asked the committee members to introduce themselves.

### **Presentations by Invited Speakers**

# Trey Forgety, Director of Governmental Affairs, National Emergency Number Association, Alexandria, VA

Mr. Forgety provided information relating to the history of 911 communication and described the progression of the technology to date. He shared insight into and discussed potential costs of technological changes for the future, including Voice Over Internet Protocol, Next Generation 911, 911 by text message, and Internet Protocol systems. Mr. Forgety concluded his prepared remarks by recommending that the committee consider issues relating to training standards, potential analytical uses of 911 call data that will become available with advancing technologies, requirements for nonproprietary standards for new systems, and existing regulations that may need to be updated moving forward.

### Dennis Klaila, Rate Analyst, Wisconsin Public Service Commission, Madison

Mr. Klaila noted the separate state funding mechanisms for land line and wireless 911 in Wisconsin, and described their histories. He spoke to the current state of the land line surcharge, the implementation and administration of the wireless funding mechanism established through the wireless 911 surcharge, and the conversion of this mechanism in 2003 Wisconsin Act 48 from a wireless 911 fee to the current police and fire fee. Mr. Klaila pointed out potential issues with existing contracts in the event of legislative changes, and indicated that the Public Service Commission could provide legislative language to assist with any transition.

# Deborah Wilichowski, Fire Technical Services Manager, Milwaukee Fire Department, Milwaukee

Ms. Wilichowski described the Milwaukee Fire Department's next generation capable, internet protocol-based 911 system. She outlined the nature of the calls the department received, and discussed the problems arising from nuisance and abandoned calls. Specifically, she discussed the significance of problems associated with nonprovisioned cell phones, which she defined as phones no longer associated with a phone number or service plan.

### **Discussion of Committee Assignment**

Chair Ballweg engaged the committee in discussion of issues raised during the presentations that the committee could address with speakers or discussion at the next meeting. These issues included nonprovisioned phones, training, and next generation capability. Larry Konopacki briefly described the memorandum that had been circulated to members prior to the meeting. Chair Ballweg solicited ideas for the next meeting, including recommendations for speakers or other presentations of information. Suggestions by the committee included input from statewide emergency services organizations and technical colleges, information relating to educating the public on 911, standardization of 911

telecommunicator training and certification, and examination of the trend from landlines to cellular calls.
