1 **AN ACT** *to repeal* 348.25 (8) (bm) 2.; *to renumber and amend* 348.25 (8) (bm)
2 1.; and *to amend* 348.25 (8) (a) 1., 348.25 (8) (a) 2., 348.25 (8) (a) 2m., 348.25
3 (8) (b) 1., 348.25 (8) (b) 2., 348.25 (8) (b) 3. a., 348.25 (8) (b) 3. b. and 348.25 (8)
4 (b) 3. c. of the statutes; **relating to:** elimination of extraneous permits fees
5 (suggested as remedial legislation by the Department of Transportation).

Analysis by the Legislative Reference Bureau

Under current law, with limited exceptions, no person may operate upon a highway any vehicle or combination of vehicles that exceeds certain statutory weight or size limits unless the person obtains a permit issued by the Department of Transportation or a local authority. Current law contains numerous fee provisions for these permits that applied only during a specific timeframe. This bill repeals these fee provisions.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

13 ~~vehiele described in this subdivision is submitted to the department after~~
14 ~~December 31, 1999, and before July 1, 2005, the fee is \$28.~~

15 **SECTION 4.** 348.25 (8) (b) 1. of the statutes is amended to read:

16 348.25 (8) (b) 1. For a vehicle or combination of vehicles which exceeds length
17 limitations, \$60, ~~except that if the application for a permit for a vehicle described in~~
18 ~~this subdivision is submitted to the department after December 31, 1999, and before~~

20 **SECTION 5.** 348.25 (8) (b) 2. of the statutes is amended to read:

4 ~~to the department after December 31, 1999, and before July 1, 2005, the fee is \$220.~~

5 **SECTION 7.** 348.25 (8) (b) 3. b. of the statutes is amended to read:

6 348.25 (8) (b) 3. b. If the gross weight is more than 90,000 pounds but not more
7 than 100,000 pounds, \$350, ~~except that if the application for a permit for a vehicle~~
8 ~~described in this subd. 3. b. is submitted to the department after December 31, 1999,~~
9 ~~and before July 1, 2005, the fee is \$385.~~

10 **SECTION 8.** 348.25 (8) (b) 3. c. of the statutes is amended to read:

11 348.25 (8) (b) 3. c. If the gross weight is greater than 100,000 pounds, \$350 plus
12 \$100 for each 10,000-pound increment or fraction thereof by which the gross weight
13 exceeds 100,000 pounds, ~~except that if the application for a permit for a vehicle~~
14 ~~described in this subd. 3. c. is submitted to the department after December 31, 1999,~~
15 ~~and before July 1, 2005, the fee is \$385 plus \$110 for each 10,000-pound increment~~
16 ~~or fraction thereof by which the gross weight exceeds 100,000 pounds.~~

17 **SECTION 9.** 348.25 (8) (bm) 1. of the statutes is renumbered 348.25 (8) (bm) and
18 amended to read:

19 348.25 (8) (bm) Unless a different fee is specifically provided, the fee for a
20 consecutive month permit is one-twelfth of the fee under par. (b) for an annual
21 permit times the number of months for which the permit is desired, plus \$15 for each
22 permit issued. ~~This subdivision does not apply to applications for permits submitted~~
23 ~~after December 31, 1999, and before July 1, 2005.~~

24 **SECTION 10.** 348.25 (8) (bm) 2. of the statutes is repealed.
