

Reciprocity/Endorsement Not Available

Application by Reciprocity/Endorsement may be an option for a professional who holds a license in another state or jurisdiction. Reciprocity/Endorsement applications require a detailed comparison of the originating state's licensure requirements (or permissible services for cosmetology related licenses) to Wisconsin's requirements.
