RE: Data on Median and Average Salaries for Certain School Staff Positions

DATE: November 29, 2022

At the committee's meeting on October 26, 2022, members requested data on statewide median and average salaries for certain school staff positions. This memo includes a chart compiled from data provided in the Department of Public Instruction (DPI) [Public All Staff Report](#). Please note that these medians and averages are rough estimations using the data from the 2021-22 school year and do not account for some salaries being for part-time employees.

The Public All Staff Report provides the following descriptions of the positions included in the chart¹:

- **Business Manager:** Has primary budget and fiscal responsibility in the school district.
- **Subject Coordinator:** Coordinates curriculum for a designated subject area, but does not supervise licensed staff. Department Head is normally an individual at school level; whereas, Subject and Program Coordinators are usually at a district level.
- **Director of Instruction/Program Supervisor:** This may include supervision of licensed staff.
- **Reading Specialist:** Under s. DPI 34.32 (8), Wis. Adm. Code, a reading specialist license is required for any person who directs early childhood through adolescence reading programs or works with reading teachers, classroom teachers, administrators, and others as a resource teacher in reading.
- **Department Head:** Department Head is normally an individual at school level; whereas, Subject and Program Coordinators are usually at a district level.
- **Teacher in Charge:** A non-supervisory school-level designated contact, in lieu of an on-site principal or other administrator.
- **School Psychologist:** Professional staff member who provides direct and indirect support, including prevention and intervention, to evaluate and address students' intellectual development, academic success, social-emotional learning, and mental and behavioral health.

¹ The Public All Staff Report does not currently include descriptions for the following positions included in the chart: District Administrator, Assistant District Administrator, School Social Worker, Principal, Assistant Principal, Teacher, School Counselor, School Physical Therapy, Educational Interpreter, School Occupational Therapy, Director of Special Education and/or Pupil Services, Assistant Director of Special Education, Speech/Language Pathologist, School Audiologist, Central Office Administrator, Other Support Staff, Other Professional Staff in a Non-Instructional Role.

- **Social-Emotional Behavioral Interventions/Support:** Provides social, emotional, or behavioral intervention to students at the school level. Specific licensure not required. Does not supervise staff.
- **Program Coordinator:** Provides coordination and support to staff in the specific area. Does not supervise licensed staff or provide direct service to students. Usually at a district level; not a school level. For special education, includes special education program support teachers.
- **School Nurse:** A registered nurse who meets the requirements under s. 115.001 (11), Stats.
- **Director of Human Relations/Multicultural Education/Equity:** Supervises professional staff.
- **Library Media Specialist:** Person responsible for all library collection development and facility management at the building level, information literacy instruction, and access to information in multiple formats.
- **Instructional Technology Integrator:** Teacher who integrates technology into curriculum. Person responsible will work and collaborate with teachers to facilitate the integration of educational technology into the curriculum through teaching and learning activities.
- **Library Media Supervisor:** A Library Media Specialist with an additional Library Media Supervisor license whose responsibilities include supervising and evaluating professional library staff.
- **District Instructional Technology Coordinator:** Responsible for educational leadership in the direction and coordination of instructional technology program; including supervision and evaluation of professional technology staff.
- **Career and Technical Education Coordinator:** Oversees a district's Education for Employment program as well as the Carl Perkins grant.
- **Paraprofessional:** Provides instructional support to teachers and students (i.e., assistance with classroom management, implementing instructional activities under the supervision of a teacher, etc.).
- **Program Aide:** Provides non-instructional support to teachers and students (i.e., assisting students in non-instructional activities, bus aides, recess/cafeteria supervision, attendant care, etc.).
