Agricultural Chemical Segregated Funds Overview (Agriculture, Trade and Consumer Protection)

CURRENT LAW

The Department of Agriculture, Trade and Consumer Protection administers two segregated funds for the regulation and cleanup of agricultural chemicals. The agrichemical management (ACM) fund supports: (a) DATCP administration of the agricultural chemical cleanup program (ACCP); (b) inspection and regulation of the individuals and businesses that manufacture, store or distribute feed, fertilizer and pesticide products in Wisconsin; (c) DATCP administration of environmental quality programs related to groundwater; (d) administration of the collection program for agricultural chemical containers and wastes, known as clean sweep; and (e) grants for the Agriculture in the Classroom and Grazing Lands Conservation Initiative programs. DATCP is authorized 42.25 positions in 2012-13 from the ACM. Total expenditures from the fund are budgeted at \$7.2 million in 2012-13.

The agricultural chemical cleanup program (ACCP) fund primarily supports reimbursement grants to eligible farms and businesses that remediate sites contaminated with fertilizers or pesticides. The fund also currently supports: (a) 4.0 positions for animal health inspection, testing and enforcement, budgeted at \$351,700; and (b) the Discovery Farms program in the University of Wisconsin–Extension, which is authorized 1.2 positions and expenditures of \$248,400 in 2012-13.

ACM fund revenues include fees on licenses and permits required of certain manufacturers or handlers of agricultural chemicals, as well as fees on each ton of certain agricultural products sold in Wisconsin. ACCP fund revenues also include a tonnage fee assessed on fertilizer sold in Wisconsin, as well as several surcharges on licenses required for pesticide and fertilizer manufacturers or distributors. The attachment lists each fee deposited to the funds, as well as the revenues from the fee category in 2011-12.

ACM fees have not changed since 1999 Act 9, although most fees received by the fund

have been maintained since 1997 Act 27 or earlier, aside from temporary fee holidays in certain fee categories from 1999 through 2002. ACCP fees were reduced by approximately 30% across the board under 2007 Act 20, and have been at current levels since that time. The statutes allow DATCP to increase or decrease, by administrative rule, the surcharges deposited to the ACCP fund, but not to exceed the maximum amount established in the statutes. Each maximum surcharge and the corresponding amount under current law is shown in Table 1. DATCP also is required to adjust surcharges as necessary to maintain an ACCP fund balance of no more than \$2,500,000 at the end of each fiscal year.

The bill would make several changes to appropriations of the ACM and ACCP funds, which are discussed in separate papers. Tables 2 and 3 show the estimated condition of the ACM and ACCP funds, respectively, under AB 40.
