### Request:

The Department of Justice requests expenditure authority of \$355,200 PR in fiscal year 2021-22 and \$671,100 PR in fiscal year 2022-23 in its gifts, grants and proceeds appropriation under s. 20.455(3)(g). The requested expenditure authority would be on a one-time basis in the 2021-23 biennium, and not ongoing.

### Revenue Sources for Appropriation(s):

The program revenue appropriation for gifts, grants and proceeds under s. 20.455(3)(g) is funded from revenue received by the department for gifts, grants and proceeds related to administrative services. Revenue for this request would be supported by fees from department-hosted training and conferences, sale of materials, donations, and other proceeds.

### Background:

The department provides training and technical assistance to stakeholders in the state's criminal justice system. These activities are funded by state funds appropriated to the department, grants awarded to it and revenue from tuition or attendance fees. The department also collects revenue from the sale of materials and other services (e.g., sale of evidence collection kits and publications). According to its request, the department would only use revenue derived from these sources, and not case-related revenue. The department requests an increase in expenditure authority to allow it to use collected revenues to support training programs and training grants, utilize donations, restock items purchased from the department, and support investigations.

The gifts, grants and proceeds appropriation under s. 20.455(3)(g) was changed from an all moneys received, continuing appropriation to an annual appropriation in 2017 Wisconsin Act 369. The current expenditure authority in the appropriation is \$0 in fiscal year 2021-22 and \$0 in fiscal year 2022-23.

### **Analysis:**

The department's request for expenditure authority would be supported by non-case-related revenue it has received plus projections of such revenues in the 2021-23 biennium.

The appropriation's closing balance at the end of fiscal year 2020-21 was \$807,999.40. According to the department, \$496,701.77 of that balance represents revenue from legal cases collected prior to the enactment of Act 369. The department has designated case-related revenue in the appropriation using an operating unit chartfield value in PeopleSoft. Table 1 below outlines the department's proposed allocation of the remaining \$311,297.63 in non-case-related revenue (at the close of fiscal year 2020-21).

As illustrated above, most of this expenditure authority would be used for specialized training grants to law enforcement agencies and organizations. Awardees would use grants for certified officers to receive training in specialized and advanced subjects. The department hosts these trainings and would further develop more specific specialized trainings if its request is approved. Examples of specialized trainings include death investigation school, fire investigation school, drug investigation school and human trafficking school. The department administers specialized training grants with its registration system and training staff. In addition to department-hosted trainings, specialized training grants would be awarded to agencies and organizations to host training events for law enforcement.

The department's request notes that without the requested expenditure authority, the amount of specialized training grants provided to law enforcement agencies during the 2021-23 biennium would decrease from over \$500,000 to approximately \$200,000. According to the department, this represents the \$308,358.71 of its request for specialized law enforcement training grants and the \$200,000 of what it has currently allocated from the law enforcement training fund for specialized training for the Division of Criminal Investigations and select law enforcement. The law enforcement training fund is supported by transfers from the penalty surcharge, receipts appropriation under s. 20.455(2)(i), which at the end of fiscal year 2020-21 had an unsupported overdraft of \$23,015,514.

The department also requests expenditure authority of \$714,930 for trainings and other activities, which would be funded by projections of non-case-related revenues in the 2021-23 biennium, including \$674,430 from training events and \$40,500 from other proceeds. The department notes that revenue from training events would be used for "training schools, courses and events that are self-funded" and provided to sworn members of law enforcement. Revenue receipts for training events would be contingent upon the number of attendees. Table 2 below summarizes the requested expenditure purpose by fiscal year for law enforcement training events and includes the supporting projected revenue.

The requested expenditure authority related to the sale of evidence collection kits under both parts of the request would be used to restock evidence collection kits sold to law enforcement agencies for investigations, which the department makes available at cost. The expenditure authority related to state forfeiture reimbursement and other donations would be used by the department's Division of Criminal Investigation to offset the costs of law enforcement investigations.

According to data in PeopleSoft, as of April 12, 2022, the department has received \$210,865.87 in non-case-related revenue in fiscal year 2021-22. This includes: \$206,526.24 from training events or conferences, \$2,930.02 from state forfeitures or other reimbursements, \$909.61 from the sale of evidence collection kits, and the \$500 donation to the Missing and Murdered Indigenous Women Task Force. But these figures are preliminary estimates and there may be some variation due to timing and other adjustments.

It is possible that approving the request, and a recent funding announcement, could provide some funding for the projected training events. For instance, it is possible that grants for law enforcement specialized training provided under the first part of this request would be used by awardees to pay for attendance at applicable training events outlined in the second part of the request. Also, on March 15, 2022, the Governor announced an investment of approximately \$19 million for local and tribal law enforcement agencies from the state's allocation of federal State Fiscal Relief Funds under the American Rescue Plan Act of 2021. According to the Governor's announcement, these funds will enable law enforcement agencies to address needs like training, recruitment bonuses, community policing needs and technology investments. It is possible that some law enforcement agencies may use a portion of their allocations for training events outlined in this request.

The department's request would facilitate more grants for law enforcement specialized training and allow the department to conduct more training events for law enforcement officers. The request would also enable the department to utilize donations, restock evidence collection kits and support investigations by the Division of Criminal Investigation. The department indicates that it has collected non-case-related revenue to support part of its request and that if projected revenues in the biennium for the other part are "lower than projected, the department will not incur the costs related to training and will not use any excess authority for other purposes."

### Recommendation:

Approve the request.

Dear Administrator Pahnke:

Pursuant to Wis. Stat. § 16.515, the Department of Justice respectfully requests to supplement its expenditure authority of the Management Services Gifts, Grants and Proceeds appropriation under Wis. Stat. § 20.455 (3)(g) by \$355,158.71 in fiscal year 2022 and \$671,068.92 in fiscal year 2023. As explained further below, the department seeks this authority to support specialized training programs and grants for law enforcement, and to fund expenses related to the activities for which the revenues are collected.

### BACKGROUND

One of the department's key responsibilities is to provide training and technical assistance to support organizations and agencies involved in the state's criminal justice system. This includes law enforcement agencies, schools, courts, victim and witness support organizations, prosecutors and defense attorneys. The department provides training through a combination of hosted training events, training provided by vendors under contracts issued by the department, and training grants issued to agencies and organizations. These training activities are supported by a combination of funding from grants awarded to the department; state funds appropriated to the department, including the Law Enforcement Training Fund and School Safety grant appropriation; and revenues from tuition and fees charged to attendees.

Revenue from training and conference events hosted by the department is deposited into the department's Gifts, Grants and Proceeds appropriation under Wis. Stat. § 20.455 (3)(g), along with proceeds received for non-training activities like sales of evidence collection kits and publications. The department uses this revenue to support directly the costs of the training or items provided, and the department sets fees and tuition amounts to reflect the actual cost to the department of providing the training or items.

The COVID-19 pandemic has disrupted the department's training programs over the past two years. To the extent possible, the department has transitioned to providing virtual training in compliance with state and local pandemic measures. As those restrictions have lifted, the department is shifting back to a combination of virtual and in-person events, with an emphasis on reinstating training that could not be provided in a virtual environment, such as criminal investigation and forensic evidence collection schools.

Prior to December 2018, the Gifts, Grants and Proceeds appropriation was a continuing, all moneys received appropriation allowing expenditure authority levels to be adjusted to reflect actual collections. 2017 Wisconsin Act 369 changed the appropriation from continuing to an annual appropriation with expenditure authority limited to the amounts in the Chapter 20 schedule. By this letter, the department requests an increase in the amount of expenditure authority under the appropriation to allow the department to use collected revenues to support training programs and training grants, and the restock of items purchased from the department.

For clarity, the department does not request authority to expend the case-related revenue that was at issue in Polk County Circuit Court case no. 21-CV-152 wherein the Court issued a final order on March 14, 2022. Rather, this request pertains only to revenue derived from other sources. An itemized list of the revenue that is at issue in this request, and the proposed expenditures from the Gifts, Grants and Proceeds appropriation, follows below.

### PROPOSED USE OF FUNDS

During the fiscal year (FY) 2019-21 biennium, the department did not expend any of the revenue carried over from the prior biennium or collected during the biennium. Due to the pandemic-related disruption of law enforcement training programs, the department incurred significantly lower costs for training due to fewer

events and the virtual nature of the training that was provided. The department supported the remaining training activities and grants using federal grants and other state appropriations.

The opening balance of the Gifts, Grants and Proceeds appropriation at the beginning of the FY22 was \$807,999.40. Of this amount, \$496,701.77 represents revenue from legal cases collected prior to the passage of 2017 Wisconsin Act 369. The department does not request authority to expend these case-related revenues. Rather, the department seeks authority to use the remaining balance from other proceeds, an amount totaling \$311,297.63.

As noted in the chart below, most of the funds in the remaining balance (i.e., of the \$311,297.63) will be used for specialized training grants to law enforcement agencies and organizations. If the department does not receive this expenditure authority, the amount of specialized training grants provided to law enforcement agencies during the FY 2021-23 biennium will decrease significantly, from over \$500,000 to approximately \$200,000, based on the availability of training grant funds from other sources.

In addition, the department requests authority to spend up to \$714,930 in revenue collected in FY22 and FY23 to support the purpose for which the fees are charged. As noted in the chart below, the majority of this revenue (\$674,430) will be for training schools, courses and events that are self-funded, meaning the department will not be able to provide this training without the ability to spend the collected fees. The department also requests expenditure authority to spend a \$500 donation to the

Missing and Murdered Indigenous Women Taskforce, up to \$30,000 to restock evidence collection kits, and \$10,000 of projected receipts for state asset forfeiture reimbursements of costs and other donations.

In sum, based on the timing of training activities, the department requests an increase in expenditure authority in FY22 of \$355,158.71 and \$671,068.92 in FY23.

### REVENUE

As explained above, the department requests \$1,026,227.63 of additional expenditure authority to support training programs and the purchase of items sold by the department during FY22 and FY23. Of this amount, \$311,297.63 was carried forward into FY22 from prior fiscal years and, based on the department's training and event schedule, \$306,050 is projected to be collected in FY22 and \$408,880 is projected to be collected in FY23. If the revenue is lower than projected, the

department will not incur the costs related to training and will not use any excess authority for other purposes. If the department does not receive expenditure authority for these amounts prior to the next biennial budget, the department will not realize the majority of the revenue in this biennium as there is not sufficient funding from other sources to support these training events and courses.
