RE: Report on Positions Created or Abolished by the University of Wisconsin System in 2018-19

This letter is provided in compliance with Wisconsin Statutes Section 16.505(2p)(a). The University of Wisconsin System did not create or abolish any GPR funded full time equivalent (FTE) positions in 2018-19.

Section. 16.505(2p)(a) allows the Board of Regents of the University of Wisconsin System or the chancellor of the University of Wisconsin-Madison to create or abolish a full-time equivalent academic staff or faculty position or portion thereof from revenues appropriated under Section 20.285(1)(a), the major GPR appropriation for the System. It also requires that annually, no later than September 30 following completion of the fiscal year, the Board of Regents or chancellor shall report to the Department of Administration and the co-chairpersons of the Joint Committee on Finance the number of positions created or abolished by the Board under this subsection during the preceding fiscal year.

Section 16.505 (2p)(b) required a memorandum of understanding between the UW and DOA for identifying and accounting for the cost of funding any positions created. The Secretary of DOA and the President of the UW System signed a memorandum of understanding on November 29 and 30, 2001.
