Dear Senator Darling and Representative Nygren:

Per s. 20.940(3)(c)2., created by 2017 Act 370, the Department of Health Services (DHS) is required to submit to the Joint Finance Committee a monthly implementation progress report for the BadgerCare Reform Demonstration Project, which was approved by the federal Centers for Medicare and Medicaid Services on October 31, 2018. This letter serves as the progress report for the month of June 2020.

2019 Wisconsin Act 185 suspends premiums and health risk assessment requirements and delays the implementation deadline for the community engagement component of the BadgerCare Reform Demonstration Project. These provisions enable the state to qualify for enhanced federal Medicaid matching funds made available through federal COVID-19 legislation.

Because of the Act 185 provisions and our ongoing efforts to respond to the COVID-19 pandemic, DHS has not made further progress toward implementing the BadgerCare Reform Demonstration Project in June. Please contact me with any questions.
