This report is required by subsection (7) of section 18.16 of the Wisconsin Statutes and specifies the reason for not complying with subsections (2) to (5) of the same section for a specific issue of debt.

The State of Wisconsin Building Commission previously approved an authorizing resolution on December 14, 2022 that provided for the sale of \$138,920,000 State of Wisconsin Extendible Municipal Commercial Paper (Notes).

The Notes are not underwritten; rather, they are placed and remarketed on a best-efforts basis through dealers that are engaged by the State. Goldman Sachs & Co. LLC and BofA Securities, Inc. have been engaged as dealers for the placement and remarketing of the Notes. The initial placement of the Notes will occur on June 1, 2023.

Neither dealer is certified by the State of Wisconsin Department of Administration as a minority-owned investment firm. In addition, neither dealer is certified by the Department of Administration as a disabled veteran-owned investment firm, in as much as no investment firm is currently certified as such by the Department of Administration.
