Dear Senator Marklein and Representative Born:

Under s. 20.940(3)(b)(2), Wis. Stats., created by 2017 Act 370, the Department of Health Services (DHS) is required to submit to the Joint Committee on Finance a monthly implementation progress report on the status of negotiations toward approval of any waiver request submitted to the Centers for Medicare & Medicaid Services (CMS). This letter serves as the October 2023 progress report on the status of Medicaid waiver amendment initiatives pending with CMS.

CMS is currently reviewing one Medicaid waiver amendment, an 1115 demonstration waiver, and an 1115 demonstration waiver renewal.

On December 21, 2020, the Department submitted to CMS an amendment to the BadgerCare Reform 1115 Demonstration Project requesting to implement a Medicaid Health Savings Account Program for childless adults as required under s. 49.45(60), created by 2017 Act 271. The Department received the Committee's approval to submit this amendment on March 12, 2020. During the month of October 2023, the Department continued bi-weekly contacts with CMS regarding the status of the amendment approval process. CMS staff indicated they would be in communication with the Department as they analyze the application.

On June 3, 2022, DHS submitted an 1115 demonstration waiver to CMS to extend Medicaid coverage for pregnant women to 90 days postpartum. CMS posted Wisconsin's application on the federal Medicaid.gov website for a 30-day federal comment period, which was open through July 21, 2022. The Department continued bi-weekly contacts with CMS regarding the status of the request in October 2023.

On November 18, 2022, the Department submitted to CMS an application to renew the BadgerCare Reform 1115 Demonstration Project. The Department received the Committee's approval to submit the

renewal application on November 7, 2022. On December 2, 2022, CMS notified the Department that the application was complete, and CMS would proceed with its review. On the same day, CMS opened the federal public comment period on the waiver, which lasted through January 1, 2023. In the subsequent months, the Department met with and responded to questions from CMS regarding the waiver. The Department continued bi-weekly contacts with CMS in October 2023, including an in-person meeting, and is awaiting next steps from CMS on the waiver application.
