2021-2023 BIENNIAL OPERATIONS REPORT ENVIRONMENTAL IMPROVEMENT FUND

I. INTRODUCTION

Section 281.59(3)(j), Wis. Stats., requires the Department of Natural Resources (WI DNR) and the Department of Administration (WI DOA) to submit an Environmental Improvement Fund (EIF) Biennial Report to the Legislature and to the State Building Commission. The report provides information on the operations and activities of the EIF for the previous biennium.

The EIF consists of three loan programs: the Clean Water Fund Program (CWFP), the Safe Drinking Water Loan Program (SDWLP), and the Land Recycling Loan Program (LRLP). Revenue bonds of the EIF are issued to fund activities for both the CWFP and the SDWLP.

WI DOA assesses EIF market interest rates every three months. During the 2021-2023 biennium, the market interest rate varied from 2.700% to 3.900% for loans with terms of 20 years or less. The EIF's base subsidized interest rate (not including further subsidies for disadvantaged municipalities) for eligible projects ranged from 1.485% to 2.145% for loans of 20 years or less. During the same time period, for loans with terms exceeding 20 years up to the current maximum repayment term of 30 years, the market interest rate varied from 2.900% to 4.100%. The base subsidized interest rate varied for loans exceeding 20 years varied from 1.595% to 2.255%.

II. CWFP ACTIVITIES/OPERATIONS DURING THE 2021-2023 BIENNIUM

- 1. The CWFP awarded 95 financial assistance agreements and amendments during the 2021–2023 biennium. These awards provided \$511.4 million to local governmental units, consisting of \$45.6 million of principal forgiveness and \$465.9 million of loans. Appendix A lists recipients.
- 2. The CWFP interest rate subsidy is intended to incentivize local governmental units to initiate compliance maintenance programs and to protect and preserve the quality of Wisconsin's water resources. The CWFP had and continues a major goal of minimizing discharge permit violations and water quality degradation by Wisconsin municipalities.
- 3. The Clean Water Fund Small Loan Program, in partnership with the Board of Commissioners of Public Lands, streamlines the loan process for projects with a cost of \$2 million or less. The Small Loan Program entered into two subsidy agreements during the biennium. These agreements subsidize loan principal with project amounts totaling \$835,973. Appendix A lists recipients.
- 4. Since the program's inception in 1991 through June 30, 2023, the CWFP has completed 1,300 financial assistance awards (including small loans) totaling nearly \$5.9 billion.

III. SDWLP ACTIVITIES/OPERATIONS DURING THE 2021-2023 BIENNIUM

1. The SDWLP awarded 44 financial assistance agreements and amendments during the 2021-2023 biennium for projects other than private lead service line replacements (see below). These awards provided \$127.0 million of financial assistance to local governmental units, consisting of \$12.9 million of principal forgiveness and \$114.2 million of loans. Appendix B lists recipients.

- 2. Pursuant to guidelines provided by the U.S. Environmental Protection Agency (EPA), the EIF made a new source of funding available by transferring funds from the CWFP to the SDWLP for funding the replacement of private lead service lines. Using this new funding source, the SDWLP awarded 121 financial assistance agreements during the 2021-2023 biennium to replace private lead service lines. These awards provided \$62.9 million of financial assistance to local governmental units, which consisted entirely of principal forgiveness. Appendix B lists recipients.
- 3. Since the program's inception in 1998 through June 30, 2023, the SDWLP has completed 659 financial assistance awards for more than \$1.1 billion.

IV. LRLP ACTIVITIES/OPERATIONS DURING THE 2021-2023 BIENNIUM

- 1. The LRLP loans did not award financial assistance during the 2021-2023 biennium. The LRLP has not awarded financial assistance since state fiscal year 2008. The remaining unallocated LRLP funds were returned to the CWFP via 2023 Wisconsin Act 6. In addition, 2023 Wisconsin Act 6 removed any future reporting requirements related to LRLP activities.
- 2. Since the program's inception in 2000 through June 30, 2023, the LRLP made ten financial assistance awards for \$15.2 million.
