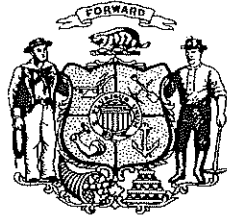

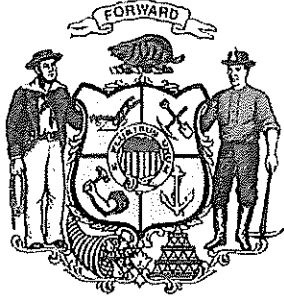


Attached is the report on Prison Industries for the quarter ending December 31, 2023 as required by §303.019 of the Wisconsin Statutes. This report includes the cash balances of the Bureau of Correctional Enterprises (BCE) through the end of the second quarter of FY24.

Traditional Prison Industries


For the period July 1, 2023 through December 31, 2023, BCE had gross revenues of \$11,701,600 and cash expenditures of \$9,713,800. The second quarter ended with revenues above expenditures by \$1,987,700. The Department currently projects a net profit of \$338,500 on a cash basis for FY24, and a projected profit of \$60,600 on an accrual basis.

With a beginning cash balance of \$5,608,000 and year-to-date gain of \$1,987,700 the cash balance at the end of the second quarter reflects a surplus of \$7,595,600.
