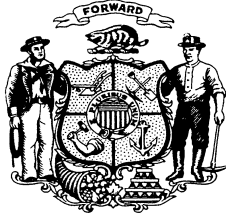

Dear Senator Marklein and Representative Born:

Enclosed, please find the 2024 Entitlements and Recommended CY 2025 Payments Schedule under the Municipal Services Payments (MSP) Program, as required under s. 70.119(2).

The Department submits this payment schedule summary report for municipal services provided during calendar year 2023 as required under s. 70.119(6). The report shows the individual entitlements as derived by applying the MSP Program formula, standard program adjustments, and the prorated payments calculated by the Department of Administration, as required by s. 70.119(6), Wisconsin Statutes.

The number of towns, villages, and cities eligible for payment is 361. The recommended payments are at 37.62 percent (37.62%) of the total adjusted gross entitlements (\$49,402,860.06). The reduction is necessary to contain the program within its \$18,584,200 appropriation. The reduction of payments on a pro-rata basis is a standard action required by s. 70.119(7)(a) whenever the appropriation is insufficient.
