Omnibus Motion [LFB Papers #460, 465, 470, and 471]

Motion:

Move to adopt the following items related to the Department of Justice:

- 1. Cybersecurity and Compliance Enhancements (Paper #460). Modify Alternative 1 to provide \$7,500,000 GPR in 2025-26 for supplies and services costs to meet federal requirements for criminal justice data and information systems security published by the U.S. Department of Justice.
- 2. *Position Maintenance (Page 398, #3).* Provide 0.01 PR position annually to correct a mismatch in the state operations appropriation for the law enforcement training fund.
- 3. Victims of Crime Act Funding Modifications (Paper #465). Modify Alternatives B3 and C3 to provide \$20,000,000 GPR and -\$20,000,000 FED in 2025-26 for awards to victim service providers for crime victim services and child advocacy centers and \$163,500 GPR, -\$163,500 FED, and 2.0 GPR and -2.0 FED positions annually to provide positions to administer grants for crime victim services. Specify that the positions be two-year project positions expiring in July, 2027. Further: (a) create a biennial GPR appropriation titled, "Community-based crime victim services" to supplement VOCA grants; and (b) amend the general program operations appropriations for victim and witness services to include administration of OCVS programs under Chapter 165 of the statutes (DOJ).
- 4. Office of School Safety (Paper #470). Modify Alternative 1 to provide \$688,300 PR in 2025-26 and \$882,600 PR in 2026-27 and 13.0 PR permanent positions annually related to the OSS. Further, provide \$850,000 GPR to the general program operations appropriation for law enforcement services in 2025-26 for a replacement printer for the CCW program.
- 5. State Fire Marshal Safety Equipment (Paper #471). Adopt Alternative 1 to provide \$43,300 GPR annually in one-time funding for arson safety equipment.
- 6. Law Enforcement Reimbursement Cross-Reference (Page 405, #8). Modify statute to include a reference to the SEG law enforcement training fund local government fund appropriation in addition to the GPR officer training reimbursement appropriation referenced under current law when reimbursing political subdivisions for officer training.
- 7. Child Advocacy Centers. Create a biennial GPR appropriation titled, "Child advocacy centers," and provide \$2,000,000 GPR annually for grants to child advocacy centers under s. 165.96 of the statutes.

- 8. Law Enforcement Data Sharing. Provide \$2,000,000 GPR annually on a one-time basis to the Joint Committee on Finance's supplemental GPR appropriation for potential release to law enforcement agencies in the Milwaukee area to implement tools that allow for the sharing of law enforcement database information between agencies. Create a new annual GPR appropriation titled, "Law enforcement data sharing."
- 9. Vacant Positions. Remove 0.3 GPR and 1.7 FED positions that have been vacant for 12 months or more as follows: (a) 0.3 GPR position and \$23,100 GPR annually from the law enforcement services general program operations appropriation; (b) 1.55 FED positions and \$119,000 FED annually from the law enforcement services federal aid, state operations appropriation; and (c) 0.15 position and \$11,600 FED annually from the victims and witnesses federal aid; state operations relating to crime victim services appropriation.
