- SUBJECT: Corrections: Section 13.10 for Probation and Parole Hold Reimbursements to Counties -- Agenda Item IV

REQUEST

The Department of Corrections requests a transfer of 587,800 GPR in 2007-08 from the Department's contract beds appropriation [s.20.410(1)(ab)] to increase monies for probation and parole hold payments to counties [s. 20.410(1)(bn)].

BACKGROUND

Under s. 302.33 of the statutes, the Department is required to pay for the maintenance of any individual in its custody who is placed in a county jail pending the disposition of parole, extended supervision, or probation revocation proceedings. The statutes specify that the Department's reimbursement is subject to the following conditions:

a. The Department is not required to pay for persons who have pending criminal charges, whether or not a departmental hold has been placed on the person. Payment for maintenance by the Department is limited to confinements where an offender is held solely because of conduct that violates the offender's supervision and which would not otherwise constitute a criminal offense.

b. Pursuant only to such a departmental hold, the Department is required to make payments beginning when an offender is detained in a county jail or other county facility, or in a tribal jail, and ending when the revocation process is completed and a final order of the Department or the Division of Hearings and Appeals in the Department of Administration has been entered. c. After verification by the Department, counties or tribal governing bodies are reimbursed at a rate of \$40 per person per day, unless the amount provided in the reimbursement appropriation for any fiscal year is insufficient to provide complete reimbursement at that rate. If funds are insufficient, the Department must prorate the payments for that fiscal year. The statutes specify that Corrections is not required to reimburse a county or tribal governing body unless it is informed of the amount of reimbursement no later than September 1st of the fiscal year following the fiscal year for which reimbursement is requested.

d. Reimbursement is only provided for felony probationers or parolees or felons on extended supervision.

The appropriation for probation and parole hold payments to counties is \$4,935,100 GPR. As indicated above, the reimbursement rate is targeted at \$40 per day, but if funding is insufficient, the reimbursement amount is prorated. The below table identifies, for the past five fiscal years, the number of holds the Department reimbursed counties for and the daily rate paid for those holds.

ANALYSIS

Under the request, \$587,800 GPR in 2007-08 would be transferred from the Department's contract beds appropriation to the appropriation for probation and parole hold payments to counties. Current funding for contract beds is \$24,829,500 GPR. As a result of the transfer, funding for contract beds would be \$24,241,700 GPR while funding for the probation and parole hold payment would be \$5,522,900 GPR. This transfer would be a one-time in nature.

As indicated in the above table, the reimbursement rate to counties for 2006-07 holds is currently \$28.59. Under the request, the additional funding would allow the Department to reimburse counties at \$32 per day, approximately the same rate for 2005-06 holds. According to the Department,

"Given the critical partnership the Department has with counties for housing felony offenders pending disposition of their cases, the Department feels that P&P

hold reimbursement at the \$28.59 level is low by historical standards and places an unfair financial burden on counties."

In its December 7, 2007, memorandum related to this request, the Department of Administration (DOA) indicated that the reimbursement amounts were not addressed in the 2007-09 biennial budget because, "given the scarcity of resources, the priority was given to fully funding the contract beds appropriation in order to control overcrowding of the institutions."

Corrections indicates that additional funding is available from the contract beds appropriation as a result in the delay of the enactment of the biennial budget: "the Department was not able to move additional inmates into county jail beds until the budget was signed. As a result, the Department projects a surplus" in the contract bed appropriation of \$7,284,000 GPR for 2007-08. The Department indicates that the balance remaining after removing \$587,800 GPR for county hold reimbursements (\$6,696,200 GPR) "will be considered by the Department of Administration as part of the Department of Corrections' portion of the \$100 million lapse requirement contained in 2007 Wisconsin Act 20." Act 20 requires DOA to lapse \$200 million biennially to the general fund from unencumbered balances of executive branch agencies. The required amounts from each agency, however, have not yet been determined.

Since additional funding from the contract bed appropriation is available, and since DOA has not yet specified the amount Corrections will be required to lapse to the general fund, the Committee could transfer additional monies to the probation and parole hold appropriation to reimburse counties at the full \$40 per day rate, rather than at the 2005-06 rate of \$32. Under this alternative, funding of \$1,968,500 GPR could be transferred to the probation and parole hold appropriation. As a result, \$5,315,500 GPR would remain of the estimated \$7,284,000 GPR surplus from the contract bed appropriation to apply to Corrections' lapse requirement. To the extent that DOA determines a higher lapse requirement from Corrections, Corrections would need to review other appropriations for available balances.

Under s. 13.101(4), the Joint Finance Committee may transfer funding between appropriations, if the Committee finds: (a) unnecessary duplication of functions can be eliminated; (b) transfer would result in more efficient and effective methods for performing programs or legislative intent will be more effectively carried out; (c) legislative intent will not change as a result of the transfer; and (d) the purposes for which the transfer is requested have been authorized by the Legislature. Transfer between appropriations is expressly permitted between two fiscal years of the same biennium, between two appropriations in the same agency, and between appropriations in different agencies. Funding may not, however, be transferred to offset deficiencies arising from the lack of adequate expenditure controls by an agency.

Statutory language contains an explicit provision as to how to address situations where the probation and parole hold appropriation is not sufficient to fully fund reimbursements at \$40 per day. As such, it could be argued, the Legislature's intent related to the appropriation is clear. While funding hold days at \$40 per day may be a goal of the statute, the appropriation anticipates the issue

of limited funding for reimbursing counties for holds. As a result, while increased funding would be necessary to reimburse counties at more than \$28.59 per day, some might suggest that separate legislation would be a more appropriate mechanism for increased funding. On the other hand, as Corrections has indicated, providing increased funding would address the low reimbursement rate for 2006-07 which may pose an unfair financial burden on counties.

The attachment to this paper identifies reimbursement amounts by county at \$28.59, \$32, and \$40 per day.

ALTERNATIVES

1. Approve the Department's request for a one-time transfer of \$587,800 GPR in 2007-08 from the Department's contract bed appropriation [s.20.410(1)(ab)] to the probation and parole hold reimbursement appropriation [s. 20.410(1)(bn)] to increase the reimbursement rate for 2006-07 holds from \$28.59 to \$32 per day.

2. Modify the Department's request and provide a one-time transfer of 1,968,500 GPR in 2007-08 from the Department's contract bed appropriation [s.20.410(1)(ab)] to the probation and parole hold reimbursement appropriation [s. 20.410(1)(bn)] to increase the reimbursement rate for 2006-07 holds from \$28.59 to \$40 per day.

3. Deny the request.
