NOTES

Prior to 1965, executive orders were issued less frequently and were not numbered. Some current executive order functions, such as calling for a special election, ordering flags to be flown at half-staff, or creating a commission, may have been accomplished by a proclamation or announced in a press release. These pre-1965 orders are available in the Legislative Reference Bureau Library's Wisconsin Documents collection filed, by governor, under "Press releases" or "Proclamations."

The numbering of Governor Knowles executive orders start over each calendar year until 1969.

The numbering of Governor Lucey executive orders starts over in 1975 – 1971 Executive Order 1 to 1974 Executive Order 87 and 1975 Executive Order 1 to 1977 Executive Order 43.

Prior to October 1983, special sessions were called via proclamation (see Appendix II).

An underscore (_) is used when a date is missing or illegible.

A date in brackets ([]) is a "best guess" based on the paper copy or from nearby executive orders.
