Statutes that affect printing, publishing, and mailing

This report identifies each Wisconsin statute that requires a state or local governmental entity to publish, print, or mail a document. These statutes would potentially need to be amended or repealed by legislation to reduce publishing, printing, and mailing costs in the state of Wisconsin. The governor's proposed 2017–19 biennial budget, 2017 Assembly Bill 64/2017 Senate Bill 30, included provisions allowing state and local governmental entities to electronically publish, print, or mail certain documents, but those provisions were removed by the Joint Committee on Finance during deliberations over the 2017–19 biennial budget.
