Section III: Academic Performance of Charter Schools

Wildlands Charter School Academic Performance Summary 2019-20

Wildlands is a project-based learning school with students from grades 7-12 attending. The enrollment for 2019-20 was 75 students. 24 were in the 7th-8th grade cohort, the 51 in the 9th-12th grade cohort. Wildlands utilizes project-based learning, formative assessments, project and performance assessments, as well as administering the district and state required standardized tests.

During the 2019-20 year:

- Wildlands had a 100% graduation rate. This continues the 15-year trend of 100% graduation.
- All seniors graduated, with all of them being admitted to the post-secondary school of their choice.
 - The senior class of 14 students received in excess of \$65,000 in scholarships for attending various colleges and universities.
- All students in the high school at Wildlands participated in the formative assessment ePortfolio assessment and demonstrated evidence of learning program, as well as earning credits to progress to the next year.
 - All high school students participated and passed two (1st and 2nd) semester final seminar presentations to staff, parents, and community members.
- Seniors all completed capstone senior projects with connections to real community issues and authentic project learning.
- The middle school students participated in the Wildlands program of formative and project-based assessment, with successful results.

- Aggregate results from the Assessment
 - As a group the students scored at or above the state averages for each area of the ACT test.
 - School composite average score for spring 2020 was 21. Range of individual ACT composite student scores was from 15 to 34.

In terms of school evaluation, student and parent surveys are conducted every year. Results from the 2019-20 school year were very favorable in terms of student and parent satisfaction, as well as academic preparation and matriculation to post-secondary institutions. All achievement metrics outlined in the charter contract for Wildlands School were met or exceeded during the 2019-20 school year.
