Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On January 25, 2021, the agency received a report regarding a 17-year-old child pronounced deceased on January 23, 2021. Law enforcement was contacted and initiated a criminal investigation. The Coroner determined the death was accidental. No criminal charges relating to the child's death were filed, and the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect of the child by the mother's boyfriend. The agency determined the child's 22-month-old half-brother safe and he remained with his mother. A Petition for Protection or Services was filed, and the case remained open to provide ongoing case management services.
