



Per the Discover Charter School contract with the Columbus School District, the District allocated 80% of the elementary school's per pupil cost per each DCS member for non personnel expenditures including personal service, employee travel, general supplies, workbooks, resale items, and equipment. The allocated budget was \$18,450 and actual audited expenditures totaled \$11,352.81.
