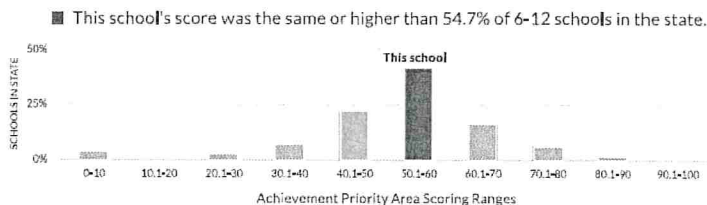

#### Priority Area Score



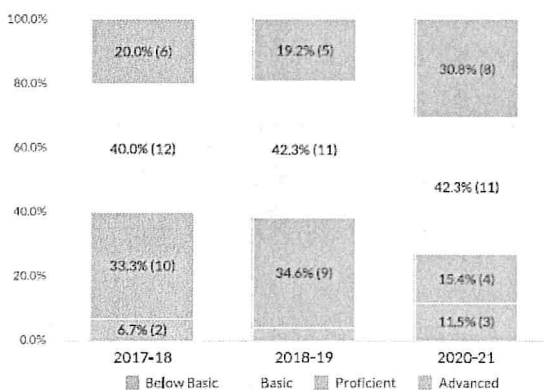
English Language Arts Score: 59.1

Mathematics Score: 51.8

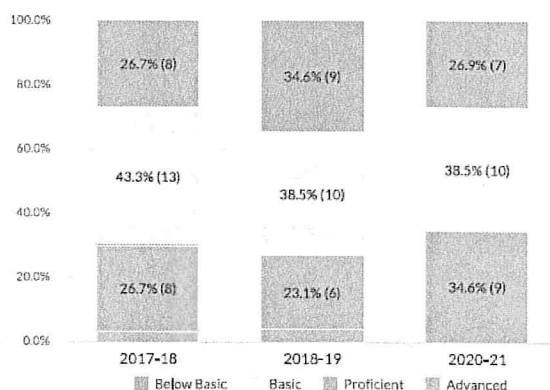
### Performance Levels by Year
