### SECTION III: ACADEMIC PERFORMANCE OF CHARTER SCHOOLS

The Northwood School District had an overall score of 69.0 on the state-issued report card. As for the growth, we saw a 1.3 point gain in ELA. We saw improvement in the overall student achievement score and are above the state average in the area of closing the gaps in ELA and Mathematics.

For each charter school, please see state issued – and the school issued report cards for each school. A few of the academic performance successes will be summarized below:

# NorthStar Community Charter School:

\*93% of student raised their overall STAR Reading Score from fall to spring.

\*72% of students raised their overall math score.

\*85% of students increased writing scores in ideas and 75% in word choice.

### Northwood HS/MS:

\*Significantly closing the gap in math and reading achievement with an average of 7.7 points higher than the state average.

\*8th grade math achievement is 1.4 points higher than the state average.

\*100% of students participated in Career Cruising.

\*Grades 6-10, 100% of students completed SEL lessons.

\*88.5% of seniors graduated on schedule.

## Northwood ES:

\*92% of Pre-K students met literacy benchmarks.

\*86% of grades 2 – 3 students increased their scores on STAR math assessment.

\*86% of 1st and 5th graders showed growth in one or more areas writing.

\*86% of 4th graders showed growth in two or more areas in writing.

\*100% of students completed SEL lessons.

### Northwood Virtual Charter:

Due to no enrollment during the 2<sup>nd</sup> Friday count in January of 2021, an Alternate Report was not necessary.

\*100% of students completed SEL lessons.

\*85% of students improved attendance and work completion.

\*88.5% of seniors graduated on schedule.

# **Coffee Connections**

Parents, staff, and community members are invited into school throughout the year to see and experience what the kids are creating and learning. Presentations are often held along with delicious treats made by the students, coffee, and tea.



### Aleks Math

ALEKS uses adaptive questioning to quickly and accurately determine exactly what a student knows and doesn't know in a course. ALEKS then instructs the student on the topics he/she is most ready to learn. As a student works through a course, ALEKS periodically reassesses the student to ensure that topics learned are also retained.



# **Community Projects**

Students often work on projects that will benefit the community. Some of the projects included the school forest ski trail, the green house, a deer enclosure, the prairie and walking trails.



# Real World/Project Based

Learning

Students at NorthStar experience most of their learning by creating projects that includes research of topics through the use of experts and/or by the internet. Students need to answer a specific question, take notes, write a paper, and design a project around the topic.



# One-to-One Student School

Each student at NorthStar has their own computer to complete research, which allows them to access more up-to-date information. Integrating technology in the classroom also helps keep the students engaged.

### ATTENDANCE:

There is a significant correlation between student attendance and student achievement. Students who attend school regularly have been shown to achieve at higher levels than students who do not have regular attendance. Research shows that missing 10% of school days, or about 18 days of school negatively affects a student's academic performance.

### COLLEGE CREDITS:

Students in the top 25% of their class, at the end of their 7<sup>th</sup> semester of high school, have the opportunity to participate in the dual credit program at Northwood.

College credits are earned through Wisconsin Technical Colleges and the University of Wisconsin System. Dual credit courses give our students a great opportunity to begin their post-secondary credits. This results in saving families thousands of dollars and increasing the likelihood of graduating on schedule.

### SCHOLARSHIPS:

Our financials are aimed at the district rather than individual schools; however, next year the financials will reflect each school. This reporting year, because we are a full conversion, all of the expenses are charter school expenses.

The District is a charter district, one of three in the state of Wisconsin. The District's budget is expended in four charter contracts: NorthStar, Northwood HS/MS, Northwood ES, and Northwood Virtual.
