SECTION III: ACADEMIC PERFORMANCE OF CHARTER SCHOOLS

(In this section, provide a summary of the academic performance of each charter school that operated during the school year.)

The data included, sourced per the WISEdash Public Portal and the raw MAP Data File from each school, provides insight into the academic performance of the three OEO-authorized schools operational during the 2020-2021 school year. All three of these schools were located in Madison. These schools provide an additional avenue for a high-quality public education beyond the offerings of the Madison Metropolitan School District, rising to meet the unexpected and ongoing challenges of the COVID-19 pandemic. School administrators maximized resources to best-assure the safety of staff and students while also addressing technology demands driven by remote/hybrid learning needs, coupled with the tireless efforts of the educational staff to adapt and deliver on the promise of high-quality and innovative educational content. The measure of academic performance does not capture such effort, nor does it express the deserved appreciation.

Across the board, for OEO-chartered schools with students eligible to take the statewide Forward Exam, the schools outperformed the local school district. The data affirms the mission of the OEO to provide innovative, high-quality educational options for students, and demonstrates that the schools are fulfilling a need in their community to do just that. This need became even greater when the COVID-19 pandemic hit. School leaders from all across the state and nation had to navigate a plethora of new challenges, address learning in new ways, and put into place new systems and structures in order to continue to provide students with the best possible educational experience.

It is important to note that all three of the OEO-charters navigated these unexpected challenges during the early stages of their existence, with two of the schools having opened in Fall of 2018 and the third opening in Fall of 2020. Creative solutions were both employed and shared among the three charters, helping achieve the promise of delivering a high-quality educational option. Further, the OEO is proud to serve as the authorizer for the only public school that stayed open the entire school year in all of Dane County during the 2020-2021 school year; One City Schools Elementary School. In cooperation with the Wisconsin Department of Health & Human Services and the University of Wisconsin-Madison, One City Schools implemented an on-site rigorous testing program utilized by both staff and students, with impressive results.

ISTHMUS MONTESSORI ACADEMY PUBLIC - MADISON, WI

<u>Mission Statement:</u> The mission of Isthmus Montessori Academy Public is to provide a holistic Montessori Education; helping children achieve their greatest success, develop independence, and live with genuine kindness to others and the world.

<u>Summary</u>: Isthmus Montessori Academy Public (IMAP) outperformed the local public school district on the Forward Exam in both ELA and Math; scoring 5% higher in ELA than the Madison Metropolitan School District. While IMAP lagged behind state scores during the 2020-2021 school year, prior to the pandemic, Isthmus Montessori Academy Public outperformed both the local district (+8%) and state (+3%) in achieving proficient or advanced scores in ELA. Other data presented includes the percentage of students who met or exceeded their Fall to Spring Growth on the MAP Assessment as well as student attendance data. IMAP did have students eligible to take the ACT; however, all data was redacted in order to protect student anonymity.

ONE CITY SCHOOLS ELEMENTARY SCHOOL - MADISON, WI

<u>Mission Statement</u>: The mission of One City Schools Elementary School is to seed a new model of public education that ensures young children are on track to succeed in a college or career preparatory program from birth through high school graduation.

<u>Summary</u>: One City Schools Elementary School did not have students eligible to take the Forward Exam last school year as they only served up to 2nd grade; however, next year's report will include this data as they added grades 3 and 4 beginning this school year. Other key data includes the percentage of students who met or exceeded their Fall to Spring Growth on the MAP Assessment; however, you will also see additional data included reflective of their longer academic school year which demonstrates that these additional days in session yield increased student gains.

Worth noting, One City Schools Elementary School was the only public school in Dane County that stayed open the entire 2020-2021 school year. The school collaborated with the Wisconsin Department of Health Services and the University of Wisconsin-Madison's Department of Pathology and Laboratory Medicine to open an on-site COVID-19 testing center utilized by staff and students alike, resulting in making in-person instruction possible, for which they gained national recognition. The attendance data is also included in the tables below.

MILESTONE DEMOCRATIC SCHOOL - MADISON, WI

<u>Mission Statement</u>: The mission of Milestone Democratic school is to be a place where learning is engaging, where everyone has a voice and that all voices are heard, and where the most important step is the next one.

<u>Summary</u>: The 2020-2021 school year marked the inaugural year of Milestone Democratic School. Opening during a pandemic year provided a whole host of challenges and yet Milestone Democratic School still outperformed the local public school district on the Forward Exam in both ELA and Math. Other data presented includes the percentage of students who met or exceeded their Fall to Spring Growth on the MAP Assessment as well as student attendance data. While Milestone did have students eligible to take the ACT, all data was redacted in order to protect student anonymity.

ADELINE MONTESSORI SCHOOL – WAUKESHA, WI

The AMS community/team will guide students to problem-solve with empathy as they grow to become adults with integrity.

NEW LEAF PREP ACADEMY - HOWARD, WI

The mission of New Leaf Prep Academy is to focus on the whole child through highly researched, hands on teaching philosophies and techniques, mainly the Montessori method. Hands-on learning is a proven way to keep students more engaged and increase retention by curating critical thinkers, problem-solvers, and self-motivated learners.

THE LINCOLN ACADEMY - BELOIT, WI

The mission of The Lincoln Academy is to be the premier K-12 school in the state of Wisconsin providing college and career pathways for scholars to lead happy, choice-filled lives. We are committed to an equitable environment with rigorous instruction, joyous interactions, and strong community partnerships.

UPGRADE MEDIA ARTS SCHOOL - BROOKFIELD, WI

The mission of UpGrade Media Arts School is to prepare students to excel academically, develop critical thinking, literacy and leadership skills, and present original film, television radio, recording arts and podcast projects through a social justice lens. While our school has a strong emphasis on the media arts, our design prepares students to thrive in any industry.

A new reporting system for collecting the data outlined in each school's contract was put into place starting in the 2021-2022 school year using a secure file sharing system. Any and all documentation submitted by school teams is reviewed by the OEO Director in order to ensure that they meet the requirements of the contract. During the bi-weekly check in meetings between school leadership and the OEO Director, uploaded submissions are also reviewed and discussed as needed. This has created a strong system of accountability.

The OEO's role as authorizer extends far beyond the application and authorization stage. During the term of the contract, constant oversight through the lens of the contract is both needed and necessary in order to hold schools to the highest level of accountability; accountability demanded by the office, the UW system, and the public.

New and pre-existing contracts are currently being amended so that the Appendices are truly reflective of the various components that are contractually required, be it evidence of student academic attainment, reports submitted to the Department of Public Instruction (DPI), Governance Board minutes and agendas, and more. As part of that work, reporting requirements and due dates are being clarified in order to create a system of accountability that is rigorous, relevant, and ready to use. More so, the pre-opening requirements from the OEO are also being revised so that they are inclusive of the DPI requirements in order to create synergy between the two offices.
