The following language is taken from the contract that **WSTEM** has with the Wauwatosa School District.

As a public instrumentality charter school, WSTEM operates under a model of shared governance. All administrative services, and all instructional services, necessary for WSTEM's operation under this Contract shall be provided to WSTEM by the District in substantially the same manner as provided to District students enrolled in the District's non-charter schools in areas including but not limited to curriculum, instructional services, technology, and facilities. Shared decision making shall be guided by the school Governance Council comprised of elected parent representatives, the teachers of the school, and the school administrator.

The following language is taken from the contract that **Wauwatosa Virtual Academy** has with the Wauwatosa School District.

The annual audits of the financial operations will be done in the same manner as Wauwatosa School District, through the business department at the district office. The programmatic operations will be done through several different processes. The WVA will be held accountable for all programmatic issues that any other school in the District is held accountable for. Annual reports on student achievement and overall program successes will be communicated to both WVA Governance Board and the Wauwatosa School Board.
