



## 2021 ASSEMBLY BILL 191

March 23, 2021 - Introduced by Representatives KNODL, ARMSTRONG, ALLEN, BRANDTJEN, BROOKS, CABRAL-GUEVARA, CALLAHAN, DALLMAN, DITTRICH, DUCHOW, EDMING, GUNDRUM, HORLACHER, JAMES, KRUG, KUGLITSCH, MAGNAFICI, MOSES, MURPHY, NEYLON, NOVAK, OLDENBURG, PRONSCHINSKE, RAMTHUN, ROZAR, SANFELIPPO, SCHRAA, SKOWRONSKI, SORTWELL, SUMMERFIELD, TAUCHEN, THIESFELDT, TITTL, VANDERMEER, WICHGERS and ZIMMERMAN, cosponsored by Senators STROEBEL, TESTIN, FELZKOWSKI, JACQUE, MARKLEIN, NASS, WANGGAARD and FEYEN. Referred to Committee on Ways and Means.

1     **AN ACT** *to repeal* 70.13 (3), 70.13 (7), 70.35, 70.36 and 70.47 (15); *to renumber*  
2             79.096 (1); *to renumber and amend* 79.096 (2) (a); *to amend* 26.03 (1m) (b)  
3             (intro.), 70.17 (1), 79.096 (3) and 978.05 (6) (a); and *to create* 70.111 (28), 70.17  
4             (3), 79.096 (1) (b) and 79.096 (2) (a) 2. of the statutes; **relating to:** eliminating  
5             the personal property tax and making an appropriation.

### ***Analysis by the Legislative Reference Bureau***

Under current law, beginning with the property tax assessments as of January 1, 2018, machinery, tools, and patterns, not including those items used in manufacturing, are exempt from the personal property tax. However, beginning in 2019, the state pays each taxing jurisdiction an amount equal to the property taxes levied on those items of personal property for the property tax assessments as of January 1, 2017.

Under the bill, beginning with the property tax assessments as of January 1, 2021, no items of personal property will be subject to the property tax. Beginning in 2022, the state will pay each taxing jurisdiction an additional amount equal to the property taxes levied on the items made exempt under the bill for the property tax assessments as of January 1, 2020. Beginning in 2023, each taxing jurisdiction will receive a payment to compensate it for its loss in personal property revenue equal to the payment it received in the previous year.

Because this bill relates to an exemption from state or local taxes, it may be referred to the Joint Survey Committee on Tax Exemptions for a report to be printed as an appendix to the bill.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

1           **SECTION 1.** 26.03 (1m) (b) (intro.) of the statutes is amended to read:

2           26.03 **(1m)** (b) (intro.) Paragraph (a) 1. does not apply to a person harvesting  
3 raw forest products on public lands, as defined in s. 70.13 (7), 2019 stats., to a person  
4 harvesting raw forest products for fuel wood for his or her home consumption, to a  
5 person harvesting for the purpose of clearing the land for agricultural use or to a  
6 person harvesting from the person's own land, any of the following:

8           70.111 **(28)** ALL PERSONAL PROPERTY. (a) Beginning with the property tax  
9 assessments as of January 1, 2021, all personal property.

10           (b) A taxing jurisdiction may include the most recent valuation of personal  
11 property described under par. (a) that is located in the taxing jurisdiction for  
12 purposes of complying with debt limitations applicable to the jurisdiction.

13           **SECTION 3.** 70.13 (3) of the statutes is repealed.

14           **SECTION 4.** 70.13 (7) of the statutes is repealed.

15           **SECTION 5.** 70.17 (1) of the statutes is amended to read:

16           70.17 **(1)** Real property shall be entered in the name of the owner, if known to  
17 the assessor, otherwise to the occupant thereof if ascertainable, and otherwise  
18 without any name. The person holding the contract or certificate of sale of any real  
19 property contracted to be sold by the state, but not conveyed, shall be deemed the  
20 owner for such purpose. The undivided real estate of any deceased person may be  
21 entered to the heirs of such person without designating them by name. The real

1 estate of an incorporated company shall be entered in the same manner as that of an  
2 individual. Improvements Except as provided in sub. (3), buildings on leased lands  
3 may be assessed either as real property or personal property.

4 **SECTION 6.** 70.17 (3) of the statutes is created to read:

5 70.17 (3) Beginning with the property tax assessments as of January 1, 2021,  
6 manufactured and mobile homes, not otherwise exempt from taxation under s.  
7 66.0435 (3), buildings on leased lands, buildings on exempt lands, buildings on forest  
8 croplands, and buildings on managed forest lands shall be assessed as real property.  
9 If buildings, but not the underlying land, are leased to a person other than the  
10 landowner or if the buildings are owned by a person other than the landowner, the  
11 assessor may create a separate tax parcel for the buildings and assess the buildings  
12 as real property to the lessee or owner of the buildings. The assessor may also create  
13 tax parcel for buildings on exempt lands, buildings on forest croplands, and buildings  
14 on managed forest lands and assess the buildings as real property to the lessee or  
15 owner of the buildings.

16 **SECTION 7.** 70.35 of the statutes is repealed.

17 **SECTION 8.** 70.36 of the statutes is repealed.

18 **SECTION 9.** 70.47 (15) of the statutes is repealed.

19 **SECTION 10.** 79.096 (1) of the statutes is renumbered 79.096 (1) (a).

20 **SECTION 11.** 79.096 (1) (b) of the statutes is created to read:

21 79.096 (1) (b) Beginning in 2022, and in each year thereafter, the department  
22 of administration shall pay to each taxing jurisdiction, as defined in s. 79.095 (1) (c),  
23 an amount equal to the property taxes levied on the items of personal property  
24 described under s. 70.111 (28) (a) for the property tax assessments as of January 1,  
25 2020.

1 with court proceedings in a court assigned to exercise jurisdiction under chs. 48 and  
2 938 as the judge may request and perform all appropriate duties and appear if the  
3 district attorney is designated in specific statutes, including matters within chs. 782,  
4 976 and 979 and ss. 51.81 to 51.85. Nothing in this paragraph limits the authority  
5 of the county board to designate, under s. 48.09 (5), that the corporation counsel  
6 provide representation as specified in s. 48.09 (5) or to designate, under s. 48.09 (6)  
7 or 938.09 (6), the district attorney as an appropriate person to represent the interests  
8 of the public under s. 48.14 or 938.14.
