6. Are convicted of a misdemeanor crime of domestic violence	ce, <del>or who fail</del> <u>as</u>
defined in 18 USC 921 (a) (33), or are convicted of domestic abuse	, as defined in s.
968.075 (1) (a), or the conviction is subject to the imposition of the	e domestic abuse
surcharge under s. 973.055 (1), regardless of whether any part of	the surcharge is
waived by the court under s. 973.055 (4). A law enforcement officer s	so convicted shall
notify the board within 30 days of his or her conviction.	
8. Fail to pay court-ordered payments of child or family suppo	ort, maintenance,
birth expenses, medical expenses, or other expenses related to the	support of a child
or former spouse, or who fail to comply, after appropriate notice, wi	th a subpoena or
warrant issued by the department of children and families or a cour	nty child support
agency under s. 59.53 (5) and related to paternity or child support	proceedings.".

<b>3.</b> Page 5, line 15: after "(a)." insert "The procedures shall i	nclude a process
for reviewing a resignation in lieu of termination or a termination	for just cause.".

<b>5.</b> Page 5, line 17: delete "6." and substitute "7.".	
<b>6.</b> Page 5, line 17: delete "4. or 5." and substitute "5. or 6.".
