

ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD
AMENDING, REPEALING AND RECREATING AND CREATING RULES

The Wisconsin Natural Resources Board proposes an order to amend NR 20.20(7)(b)1, (13)(d)1, (44)(g)3, (55)(bm)1, (57)(c)1, (e)2, (f)2, (61)(c)2, (73)(m)1; repeal and recreate 20.20(59)(e), (60), (73)(e), 22.04(2), 23.05(5)(c); and create 19.11(2)(e), 20.05(14), 20.10(1i), (1r), 20.20(2)(bm), (6)(bm), (9)(am), (17)(bm), (18)(bm), (26)(am), (47)(bm), (dm), (51)(bg), (bm), (55)(bg), (61)(ag), (am), (64)(h)10, (70)(b)3, (dm), 26.32 relating to fishing on the inland and outlying waters of Wisconsin.

Statutory authority: ss. 23.09(2)(c), 29.014(1), 29.041, 29.614, and 227.11(2), Stats.

Statutes interpreted: ss. 29.014(1) and 29.041, Stats.

Sections 1 and 2 eliminate the capture and tagging of wild fish unless an individual obtains a scientific collectors permit.

Sections 3 and 4 create a separate sturgeon carcass tag for the Winnebago system upriver lakes (Lakes Poygan, Winneconne and Butte des Morts) and Lake Winnebago during the special sturgeon spearing seasons held on the Upriver Lakes every five years. The Upriver Lakes tag would be usable only on the Upriver Lakes. An individual electing to purchase said tag would only be able to take, capture, kill or attempt to take, capture or kill a sturgeon on the upriver lakes that season (thus NOT allowing that individual to take, capture, kill or attempt to take, capture or kill a sturgeon on Lake Winnebago) in that same season. A Lake Winnebago tag purchased for that season would operate in a similar fashion (only being usable for Lake Winnebago).

Sections 5, 6, 7, 8, 10, 11, 12, 14, 16, 18, 20, 24, 31 and 34 identify waters open to hook and line lake sturgeon fishing and closes all other waters.

Section 9 increases the minimum length limit from 34" to 45" for muskellunge on Lakes Waubesa and Monona, and from 40" to 45" for muskellunge on Lake Wingra, Dane county.

Section 13 changes the size restriction from no minimum length limit with only one fish longer than 14" allowed to the statewide minimum size limit of 15" for walleye on East Horsehead lake and Manson lake, Oneida county.

Section 15 reduces the daily bag limit from 25 in total to 10 in total for panfish on Thompson lake, Pepin county.

Sections 17, 19, 21 and 26 extend the 40" minimum length limit for muskellunge on Holcombe flowage (located in Chippewa and Rusk counties) to coincide with the walleye regulations for

the Holcombe flowage and tributaries (upstream to a barrier to movement) by increasing the minimum length limit from 34" to 40" for muskellunge on the Chippewa river and all tributaries upstream to the first dam or lake and the Flambeau river upstream to the Thornapple flowage dam including all tributaries upstream to the first dam or lake, Rusk county; and the Chippewa river and all its tributaries upstream to the first dam or lake, Sawyer county.

Section 22 decreases the daily bag limit from 25 in total to 10 in total for panfish on Sand lake, Sawyer county.

Section 23 increases the minimum length limit from 9" to 15", reduces the daily bag limit from 3 in total to 1 in total, and establishes an artificial lure only restriction for trout on Ben Nutt creek, Mill creek, and the Onion river upstream from CTH E, Sheboygan county.

Section 24 increases the minimum length limit from 14" to 18" and decreases the daily bag limit from 5 in total to 1 in total for largemouth and smallmouth bass; increases the minimum length limit from none to 32" and reduces the daily bag limit from 5 to 1 for northern pike; and decreases the daily bag limit from 25 in total to 10 in total for panfish on Dry Dam lake, St. Croix county. Section 24 also decreases the daily bag limit from 25 in total to 10 in total for panfish on Squaw lake, St. Croix county.

Section 27 increases the minimum length limit from 7" to 9" and reduces the daily bag limit from 5 in total to 3 in total for trout on Wood creek, Taylor county.

Section 28 increases the minimum length limit from 15" to 18" and decreases the daily bag limit from 5 to 3 for walleye in Found lake, Vilas county.

Section 29 increases the minimum length limit from 14" to 18" and decreases the daily bag limit from 5 in total to 1 in total for largemouth and smallmouth bass on Hartford lake, Waushara county.

Section 30 decreases the daily bag limit from 25 in total to 10 in total for panfish on Hartford lake, Waushara county.

Section 31 reduces the season length from 2 days to 1 day for sturgeon spearing on the Winnebago system upriver lakes (Lakes Poygan, Winneconne and Butte des Morts) held every 5 years and deletes the cross reference to sturgeon tags being required for Lake Superior and the Lower Wisconsin River below the Wisconsin Dells Dam.

Section 32 closes the hook and line fishing season for shovelnose sturgeon on the Chippewa river downstream from interstate highway 94 bridge at Eau Claire including its tributaries upstream to the first dam or lake.

Section 33 creates a 20" to 27" protected slot limit with only one fish larger than 27" allowed for walleye on the Mississippi river Pool 12 and reduces the daily bag limit for walleye and sauger from 10 in aggregate of which no more than 6 may be walleye to 6 in aggregate on the Wisconsin-Iowa boundary waters (Mississippi river). A five year sunset is established.

Section 35 establishes a fish refuge beginning December 1 of each year and lasting through March 15 of the following year in, on or along the Mississippi river from lock and dam number 11 downstream to the STH 61 and 151 bridge on the Wisconsin-Iowa boundary waters. A five year sunset is established.

Section 36 changes the closing date for the general inland hook and line fishing season, rough fish spearing, and hook and line seasons on the Great Lakes and tributaries that close March 1 to the first Sunday in March.

NR 19.11(2)(e) *Tagging of fish.* Scientific collectors permits are required to capture a wild fish, attach a tag to any part of it, and then to release it back into waters of the state.

(1) WISCONSIN – IOWA BOUNDARY WATERS. Mississippi river from lock and dam number 11 downstream to the STH 61 and 151 bridge excluding that area located East of the main channel and directly south of the earthen dike known as O'Leary's Lake until April 1, 2009.
