CONSTITUTIONAL AUTHORITY: First Amendment, U.S. Constitution; Article 1, § 3, Wisconsin Constitution.

STATUTORY AUTHORITY: s. 84.30(14), Stats. **STATUTE INTERPRETED**: s. 84.30, Stats.

<u>General Summary of Rule</u>. This rule making is necessitated by a recent U.S. Supreme Court decision. The Supreme Court has invalidated a Wisconsin restriction on otherwise qualifying political signs on private property. As a result, political signs on private property adjacent to interstates and freeways are exempt from our permit requirements in the same manner as other political signs adjacent to conventional highways if they meet the same size and election time limitations. Currently, Trans 201 exempts political signs from our normal billboard permit requirements if the sign meets certain size and election time frame criteria and if the sign is located on private property. However, Trans 201.16.(2)(e) states that the exemption does not apply if the political sign is "erected adjacent to an interstate highway or a freeway."

This rule making will amend Trans 201.16(2)(e) to eliminate the phrase "adjacent to an interstate highway or freeway or." It will also bring the rule into compliance with the Supreme Court decision. *{Ladue v. Gilleo, 62 USLW 4477 [June 13, 1994]*}.

Fiscal Effect. The Department estimates that there will be no fiscal impact on the liabilities or revenues of any county, city, village, town, school district, technical college district or sewerage district. The Department estimates that there will be no fiscal impact on state revenues or liabilities.

<u>Final Regulatory Flexibility Analysis</u>. This rule will not have an adverse impact on small businesses.

TEXT OF RULE

Under the authority vested in the state of Wisconsin, department of transportation, by s. 84.30(14), Stats., the department of transportation hereby adopts an order to amend a rule interpreting s. 84.30, Stats., relating to on-private property political signs next to interstates and freeways.

SECTION 1. Trans 201.16(2)(e) is amended to read:

Trans 201.16(2)(e) The sign is not erected adjacent to an interstate highway or

a freeway or in a location where it constitutes a traffic hazard.
