





ORDER OF THE STATE OF WISCONSIN
NATURAL RESOURCES BOARD
AMENDING RULES

The Wisconsin Natural Resources Board proposes an order to amend NR 20.08(10) relating to fishing tournament permitting.

FM-31-96

Analysis prepared by the Department of Natural Resources

Statutory authority: ss. 29.174(3) and 227.11(2)(a), Stats.

Statutes interpreted: s. 29.174(1) and (2), Stats.

This order extends the December 31, 1996 sunset on existing tournament permitting rules for two years, to December 31, 1998.

SECTION 1. NR 20.08(10) is amended to read:

NR 20.08(10) SUNSET. This section shall remain in effect until December 31, ~~1996~~ 1998.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on September 25, 1996.

The rules contained herein shall take effect on the first day of the month following publication as provided in s. 227.22(2)(intro.), Stats.




