ORDER OF THE STATE OF WISCONSIN

STATE FAIR PARK BOARD

ADOPTING RULES

4 The Wisconsin State Fair Park Board adopts the following order to amend SFP 2.07(2)

5 and (3), 2.16(4)(b) and (5)(b), and 2.18; and to repeal and recreate SFP 7 relating to

6 regulation of State Fair Park and establishing a bail bond schedule.

The current rule contains 6 instances in which specific actions are prohibited if a person is under 18 years of age.

1. It prohibits persons under 18 years of age from carrying, possessing, receiving possession or transferring possession of paint in a spray can.

2. It prohibits selling spray cans of paint to any person under 18 years of age; and requires display of a sign stating "It is unlawful to sell spray paint to persons under 18 years of age, unless the seller records sales, date, purchaser's name and paint purchased on a form and forwards a copy of the form to the police department.

3. It prohibits selling or transferring spray paint containing a harmful substance to any person under 18 years of age.

4. It prohibits selling or transferring toxic glue to any person under 18 years of age, except it does not prohibit transferring one tube or container of toxic glue to a person under 18 years of age when the glue is provided along with a model kit as long as the model kit needs approximately that amount of glue to assemble the kit.

5. It prohibits a lessee who has a contract permitting the sale of alcoholic beverages from employing a person under 18 years of age for serving, selling or vending alcoholic beverages.

6. It prohibits employing a person under 18 years of age unless the employer has on file a child labor permit authorizing the employment.

The rule changes each reference from 18 years of age to 17 years of age except it does not change the age requirement for persons selling, serving or vending alcoholic beverages. The current requirement that persons serving, selling or vending alcoholic beverages be 18 years of age or older is not changed.

The rule also repeals and recreates the bond deposit schedule. The current rule establishing a bond deposit schedule does not address several violations which were established in SFP rules promulgated in 1996. This rule establishes bond deposits for additional types of violations and changes the amount of bond required for some violations and continues the policy of expelling anyone camping at the State Fair Park after revocation of a RV permit.

2SECTION 1. SFP 2.07(2) and (3), 2.16(4)(b) and (5)(b) and 2.18 are amended to 3 read: 4 SPF 2.07(2) POSSESSION OF SPRAY PAINT BY MINOR. No person under 5 18 17 years of age shall carry, possess, receive possession or transfer possession of paint 6 in a spray can, at a time or manner not usual for law abiding individuals under 7 circumstances that warrant alarm for the safety of property. A police office shall afford 8 the person an opportunity to dispel any alarm by requesting the person to explain any 9 reason for possessing paint in a spray can. 10 SFP 2.07(3) SALE OF SPRAY PAINT TO MINORS. No person may sell paint 11 in spray cans to any person under 18 17 years of age. Lessee selling paint in spray cans 12 shall have a sign conspicuously displayed stating, "It is unlawful to sell spray paint to 13 persons under 18 17 years of age." The requirements of this subsection with respect to 14 sales to minors shall not apply when the seller records sales, date, purchaser's name and 15 paint purchased on a form and forwards a copy of the form to the police department.

1 SFP 2.16(4)(b) No person may for the purpose of violating or aiding another to 2 violate any provision of this subsection, possess, buy, sell, transfer possession, or receive 3 possession of any harmful substance. No person may sell or transfer possession of any 4 aerosol spray paint containing a harmful substance having the property of releasing toxic 5 vapors to any person under <u>18 17</u> years of age.

6 SFP 2.16(5)(b) No person may, for the purpose of violating or aiding another to 7 violate any provision of this subsection, possess, buy, sell, transfer possession of any 8 toxic glue. No person may sell or transfer possession of any toxic glue to any person 9 under 18 17 years of age, provided however, that one tube or container of toxic glue may 10 be sold or transferred to a child under 18 17 years of age immediately in conjunction with 11 the sale or transfer of a model kit, if the kit requires approximately such quantity of the 12 glue for assembly of the model, and provided, further, that this paragraph does not 13 prohibit the transfer of a tube or other container of such glue from a parent to his or her 14 child or from a legal guardian to his or her ward.

15 <u>SFP 2.18 CHILD LABOR LAWS</u>. No minor under <u>18 17</u> years of age may be 16 employed or permitted to work in gainful employment unless the employer has on file a 17 child labor permit authorizing the employment, as specified in s. ILHR 270.002. Each 18 day and each instance of violation shall constitute a separate and distinct offense.

1 SECTION 2. SFP 7 is repealed and recreated to read:

3 <u>SFP 7.01 VIOLATION</u>. A violation of any rule within chs. SFP 1 to 6 is subject
4 to forfeiture of an amount up to \$200 as established in s. 42.01, Stats., expulsion from the
5 park, or both.
