AN ACT to repeal an act entitled "an act to incorporate the Mississippi Marine and Fire Insurance Company," approved March 11, 1839.

Be it enacted by the Council and House of Representatives of the Territory of Wisconsin:

SECTION 1. That the act entitled "An act to incorporate the Act repealed. Mississippi Marine and Fire Insurance Company," approved March 11, 1839, be, and the same is hereby repealed: Provided, Proviso that the said repeal shall not release the said company from any liability which has accrued or may accrue on any policy of insurance executed by said company, nor from any obligation the said company would be under, to pay to any person any sum of money, had said act not have been repealed.

Approved, February 22, 1845.

AN ACT to authorize School district No. one in the town of Milwaukee to levy a tax for purchasing or leasing a site for, and building a School House.

Be it enacted by the Council and House of Representatives of the Territory of Wisconsin.

- SEC. 1. That the inhabitants of school district No. one, in the Inhabitants may vote a town of Milwaukee, who are qualified voters at any school meettax. ing in said district may vote a tax to be levied on all the texable property in said district not to exceed one per cent on the last assement roll, for the purpose of purchasing or leasing a site for and building a school house in said district: Provided, That two Proviso. thirds of the legal voters of the same who may be present at any school meeting duly called by the trustees of said district for that purpose, shall vote in favor of the tax authorized by this act.
- SEC. 2. The trustees of said district shall give notice of any Trustees to meetings to be called by them for the purpose of levying said tax give notice. by advertising the same in one of the public newspapers in the village of Milwaukee at least three weeks previous to the time of bolding said meeting.
  - .SEC. 3. The said tax shall be collected and returned in the Tax how sol-

lected and re- same manner as is now provided by law for the collection of taxes surned. for building school houses: This act shall take effect from and after its passage.

AN ACT to authorize the Supervisors of Brown County to raise money for certain improvements, and for other purposes.

Be it enacted by the Council and House of Representatives of the Territory of Wisconsin:

Sapervisors to levy one per cent.

SECTION 1. That the supervisors of Brown county, shall have power and they are hereby required to levy a tax not exceeding one per cent, per annum annually, for the purpose of constructing a McAdam, plank, rail or turnpike road, from the foot of the Grand Kakalin to Winnebago Lake as may be deemed most expedient.

The said tax shall be levied and collected at the same

and collected time, and in the same manner that taxes are by law required to be levied for the support of county government, in said county; and said tax shall be a lien on real estate on which the same is or may be assessed until paid: Provided, however, that the tax authorized to be collected by this act, shall be paid in money to the several collectors, and paid by them in like funds to the county tressurer.
