SEC. 2. That this act shall take effect and be in force from and after its passage.

**AN ACT to divide the election district composed of the counties of Walworth and Rock. and to constitute them separate election districts.**

*Be it enacted by the Council and House of Representatives of the Territory of Wisconsin:*

SECTION. 1. That the election district composed of the counties of Walworth and Rock shall be hereafter divided, and the county of Rock shall constitute one election district, and the county of Walworth shall constitute another election district, and the said district composed of the county of Rock shall hereafter be entitled to elect one member of the council, and one member of the house of representatives, and the said district composed of the county of Walworth shall be entitled to elect one member of the council and three members of the house of representatives.

SEC. 2. In case a vacancy shall occur in the representation in the council from either of the said districts as formed by this act, then the district in which such vacancy shall occur, may supply the same by an election as now provided by law in like cases.

SEC. 3. So much of any act as is repugnant to or contravenes the provisions of this act is hereby repealed.

**AN ACT to provide for the selection of certain lands reserved by act of Congress, for the use and support of a University in the Territory of Wisconsin.**

*Be it enacted by the Council and House of Representatives of the Territory of Wisconsin:*

SECTION 1. John T. Haight is hereby appointed the agent of the Territory to select all the lands authorized to be set

apart and reserved from sale by virtue of an act of Congress approved 12th June, 1838, entitled "An act concerning a seminary of learning in the Territory of Wisconsin," which have not been set apart and reserved from sale by the Secretary of the Treasury of the United States, for the purposes aforesaid: *Provided*, That no improved land or lands claimed by actual occupants, shall be selected for the purposes aforesaid.

SEC. 2. That upon the selection being completed, it shall be the duty of the person so appointed, to report to the Governor, a description of the lands by him selected, to be by him transmitted to the Secretary of the Treasury of the United States, with a request that the several lands so selected, may be set apart and reserved from sale, for the purposes mentioned in said act of Congress. To report to Governor.

SEC. 3. That the person so appointed shall receive for the services herein required to be performed, such compensation to be paid out of the territorial treasury, as the Legislative Assembly may deem proper. Compensation

## AN ACT to incorporate the first Congregational Society in the town of Milwaukie.

*Be it enacted by the Council and House of Representatives of the Territory of Wisconsin:*

SECTION 1. That James Bonnel, Eliphalet Cramer, Samuel Brown, Frederick B. Otis, and Abram D. Smith and their associates together with such persons as may hereafter be associated with them, be, and they are hereby created a body politic and corporate, with perpetual succession by the name of the First Congregational Society in the town of Milwaukie, and by that name shall be competent to contract and be contracted with, to sue and be sued, to answer and be answered unto in all courts of law and equity, acquire, hold, possess and enjoy, and to sell and convey and dispose of property, both real and personal: *Provided*, The annual income of such property shall not exceed two thousand dollars. *Provided*, that nothing herein contained, shall authorize the corporation hereby created, to purchase, sell, or deal in Name and power of incorporation.

*Proviso.*
