## **Assumptions Used in Arriving at Fiscal Estimate**

SB-439 requires the Technical College System Board (WTCS Board) to award a grant of \$9,600,000 in the 2021-22 fiscal year to Mid-State Technical College for a manufacturing engineering apprenticeship center. The schedule under s. 20.005 (3) for the appropriation to the technical college system board under s. 20.292 (1) (f), is increased by \$9,600,000 for fiscal year 2021-22 for the purpose of awarding this grant.

SB-439, through a newly created appropriation, 20.292(1)(fm),conveys \$500,000 from the general fund for the creation and funding of a tuition assistance grant program. The WTCS Board shall award grants to current or prospective farmers in the state for the purpose of paying no more than 50 percent of tuition costs for enrolling in Wisconsin technical college courses on farm management or farm finance. A current or prospective farmer may receive no more than \$1,000 in these grants per year for no more than three years.

It is unknown how many individuals will be eligible, apply for and receive tuition grants. There will be some increased costs to WTCS Board staff and WTCS district board staff for soliciting applicants, reviewing applications and ensuring tuition grant recipients do not exceed the statutory dollar amounts or time limits available to eligible individuals.

Long-Range Fiscal Implications
