Assumptions Used in Arriving at Fiscal Estimate

This bill requires the Department of Justice to establish a Wisconsin Sexual Assault Kit Tracking System to provide access to information on the location of sexual assault kits to victims and to allow health care professionals, forensic laboratories, and law enforcement agencies to update and track the location of sexual assault kits. The bill provides \$400,000 GPR in fiscal year 2021-22.

In October 2020, the State Crime Laboratories purchased and is in the process of implementing a laboratory information management system that has the capacity to track sexual assault kits through all phases of processing, including collection, submission to law enforcement and the State Crime Laboratories, processing and storage. The system also incorporates online portals for victims, law enforcement agencies, prosecutors and the forensic laboratories to update and view status information on sexual assault kits. The initial purchase and implementation was funded by a combination of federal grants and existing state funding. Ongoing maintenance costs for the kit tracking functionality are \$39,600 per year. DOJ also anticipates ongoing costs in an indeterminate amount related to tools to assist with implementation for hospitals and law enforcement agencies including scanning equipment and outreach materials.

Long-Range Fiscal Implications

Kit tracking maintenance costs are \$39,600 annually for the five years of the contract period. Costs in an indeterminate amount are also anticipated for implementation tools and outreach.
