Wisconsin Department of Transportation (WisDOT) hereby submits to the Wisconsin Legislative Council Clearinghouse for review, pursuant to s. 227.15 (1), Stats., the proposed permanent rule ch. Trans 129, relating to motorcycle licensing and courses, and the fiscal estimate/economic impact analysis. The scope statement for this rule, SS 087-21, was approved by the Governor on October 7, 2021, published in the Wisconsin Administrative Register No. 790A3, on October 18, 2021, and approved by the Secretary of the State of Wisconsin Department of Transportation Craig Thompson as required by s. 227.135 (2), Stats., on September 3, 2021.
