An act to appropriate the several sums therein named.

THE People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. That the sum of forty dollars be, and the same is hereby appropriated to Darwin Clark, for secretary furnished supreme court room, and screen furnished the senate.

Stc. 2. That the sum of forty dollars be, and the same in J D Reymert. hereby appropriated to James D. Reymert, for newspapers containing the governor's message in the Norwegian lauguager

SEC. 3. That the sum of twenty dollars be, and the same is T Me'Hugh. hereby appropriated to Thomas Me Hugh, for traveling expense es, in going to Southport and Milwankee on business of the states

P Kavenaugh SEC. 4. That the sum of thirty-six tiollars and twenty-five cents be, and the same is hereby appropriated to Peter Kavenaugh for twenty-nine days' work done about the capitol.

Sec. 5. That the sum of one hundred dollars be, and the same G M Oakley. is hereby appropriated to G. M. Oakley, in full for work done on the capitol up to this time.

That the sum of twenty-eight dollars twenty-five cents J R Brigham be, and the same is hereby appropriated to J. R. Brigham, for fees in state suits in supreme court.

Sec. 7. That the sum of five dollars be, and the same is hereby appropriated to each of the following named persons, to wit: John Catlin, J. A. Bingham, in full pay as messengers to notify the electors of president and vice-president of their election.

SEC. 8. That the sum of five dollars fifty cents be, and the P W Matts. same is hereby appropriated to P. W. Matts, for expenses incurred in fitting up supreme court room.

> SEC. 9. That the sum of fifty dollars be, and the same is: hereby appropriated to H. C. Parker, in full for materials furnished and work done in fitting up supreme court room.

> That the sum of eight dollars be and the same is hereby appropriated to H. H. Farnsworth, for painting and varnishing desk in supreme court room.

> That the sum of twenty dollars be and the same is hereby appropriated to Seymour and Varney, for articles furnished in repairing supreme court room as by account rendered, dated January 3d, 1849.

> SEC. 12. To Romanzo B. Rice jailor of Milwankee, two hundred and fifteen dollars, in full for support of state prisoners from December 31, 1848, to April 1, 1849.
