

Chap. 150. An Act to amend Chapter nineteen, of Title seven, part first of the Revised Statutes.

*The People of the State of Wisconsin represented in Senate and Assembly do enact as follows :*

When Town Superintendent of Schools to apportion monies.

SECTION 1. That so much of Section forty-two, of Chapter nineteen, Title seven, part first of the Revised Statutes, as make it the duty of the Town Superintendent of Common Schools to apportion the school monies received from the Town and County Treasurers, on the first Monday of April in each year, is hereby repealed, and hereafter it shall be the duty of the said Superintendent to apportion the School monies received from the Town and County Treasurer, on the first Monday of March in each year, or as soon thereafter as they shall receive the same: Provided, That nothing in this act shall be so construed as to interfere with the provisions of an act for the apportionment of School moneys for the year one thousand eight hundred and fifty-one.

Proviso.

Of Notice.

SEC. 2. The notice hereafter required by subdivision twelve, of section eleven of said chapter nineteen, shall be the same as that provided in section twenty-nine, of said chapter nineteen.

An Act to appropriate to Timothy Burns the sum therein named

*The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows :*

SECTION 1. There is hereby appropriated to Timothy Burns the sum of six hundred and twenty-one dollars, in full for ser-

ices as commissioner in locating state lands, to be paid out of any money in the treasury not otherwise appropriated.

An Act to appropriate to Thomas Bullen the sum of money therein named.

*The People of the State of Wisconsin represented in Senate and Assembly, do enact as follows:* Chap. 153

SECTION 1. There is hereby appropriated to Thomas Bullen, to be paid out of any money in the treasury not otherwise appropriated, the sum of ten dollars in full payment of principal and interest due on Territorial Scrip numbered eight hundred and eighty-nine, dated February nineteenth, eighteen hundred and forty-two.

An Act to appropriate to John W. Hunt the sum of money therein named.

*The People of the State of Wisconsin represented in Senate and Assembly, do enact as follows:* Chap. 154

SECTION 1. There is hereby appropriated to John W. Hunt to be paid out of any money in the treasury not otherwise appropriated, the sum of twenty-five dollars in full pay and satisfaction for twelve and a half days work in writing up the journal of the Senate for the session of eighteen hundred and fifty.

SEC. 2. There is hereby further appropriated to John W. Hunt the sum of five dollars to be paid out of any money in the treasury not otherwise appropriated in full pay and satisfaction for writing up the journal of the Assembly for the session of eighteen hundred and fifty, to be paid to the said Hunt on presentation to the Treasurer of the certificate of the Secretary of State that the said Hunt has completed the writing up of said journal.
